Telecom Secretary Dr. Neeraj Mittal today said that as India moves from 5G to 6G, there is tremendous role for AI to improve the intelligence in networks, make them self-healing and move from generative AI to agentic AI to make customer service better. He was speaking at the inauguration of the International Telecommunication

Union's (ITU) "AI for Good -Impact India" Conference 2025 at IMC 2025 here. "While the title of the summit is AI for Good, there is equally AI for Bad and risks come along naturally, because AI is truly horizontal and sits atop all verticals.and we are able to see how artificial intelligence (AI) tools are leading to deep fakes, voice cloning, financial frauds, bypassing voice signatures and even videos to establish false identities.

Therefore, we have to be very vigilant about what the telecom



artificial intelligence" said Mittal. India is advancing a trusted, inclusive and human-centric AI ecosystem through the USD 1.25 billion IndiaAI Mission, in close collaboration with global partners such as ITU, to ensure that technology remains a force for trust, inclusion and progress, Mittal added. 

■ ED arrests 4 in Rs 100 crore cyber scam

New Delhi, Oct 10 (Reporter) The Enforcement Directorate's (ED) Surat Sub-Zonal Office announced today the arrest of four individuals in connection with a multi-faceted cybercrime investigation involving Proceeds of Crime (POC) exceeding Rs 100 crore. The arrested accused have been identified as Makbul Abdul Rehman Doctor, Kaashif Makbul Doctor, Mahesh Mafatlal Desai. and Om Rajendra Pandya. They were produced before a special PMLA court in Ahmedabad, which has granted the ED five days of custody for further investigation. The ED initiated its investigation under the Prevention of Money Laundering Act (PMLA) based on a case filed by the Special Operation Group of Surat police under various sections of the Bhartiya Nyay Sanhita. Indian life insurance industry witnessed double-digit growth in Sep'25

Kolkata / New Delhi, Oct 10 (Mayank Nigam)

Indian life insurance industry in September, witnessed double-digit growth, with new business premiums rising by 14.8 percent year-on-year to Rs 40,206.7 crore, reversing the 5.2 pc decline seen in August 2025. This uptick was slightly higher than the 14.0 pc growth seen in September 2024. The group was driven by strong momentum in the group business, particularly in the single premium segment, which more than offset the decline in individual premiums. A favourable base effect and the impact

of GST reductions aided this. According to Sanjay Agarwal, senior director. CareEdge Ratings, "The life insurance Indian industry's APE growth moderated to 5.2 pc in September 2025, lower than

the 6.6 pc rise seen in August and well below the base of September 2024." However, the implementation of the GST waiver on individual life and health insurance premiums has had some impact, driving improved sales momentum towards the month-end. "The industry is now showing signs of



recovery, with underlying business growth returning to double digits. Over the medium term, CareEdge expects the sector to sustain a better growth trajectory, supported by favourable regulatory

reforms, evolving product innovation, deepening digital reach, and expanding distribution efficiency," he said. "New business premiums in the Indian life insurance industry touched Rs 40,206.7 in September 2025, growing by 14.8 pc, slightly above the growth of 14.0% reported in ▶ Cont. to Page-2

More than half of the world's winged friends face decline: IUCN

New Delhi, Oct 10 (Bureau)

ore than half of the world's bird species -Lour cherished winged are witnessing a worrying decline, according to the latest global assessment released by the International union for Conservation of Nature (IUCN). The report attributes the 61% decline in the bird population chiefly to habitat loss and degradation, driven by agricultural expansion, and logging. intensification, The update, which is the eighth comprehensive evaluation of all bird species worldwide conducted BirdLife International, reassessed 1,360 species as part of a nine-year collaborative effort

involving thousands of experts globally. The IUCN is a global union of governments, civil society organisations, and scientific

The warning about the health of bird population has come amid ongoing IUCN World Conservation Congress in Abu Dhabi. Out of 11,185 bird species assessed, 1,256 — or 11.5 per cent — are now classified as globally threatened. The study further reveals that 61 per cent of bird populations are in decline, a sharp rise from 44 per cent in 2016, underscoring a deepening biodiversity crisis. "The most prevalent cause of the bird population decline is habitat loss

and degradation, driven especially

agricultural expansion and

intensification and logging — the foremost threats to birds at risk of extinction," stated the IUCN in a statement here. The report draws



attention to tropical forest loss in regions such as Madagascar, West Africa, and Central America, where the fate of many iconic bird species hangs in the balance. In Madagascar, for instance, 14 endemic forest bird species have been uplisted to near threatened, and three to vulnerable.

Among them is the striking Schlegel's asity (Philepitta schlegeli), whose males are adorned with vibrant blue and green face wattles, a vivid reminder of nature's fragile beauty. In West Africa, the black-casqued hornbill (Ceratogymna atrata), known not only for its distinctive casque but also its ecological role, is now near threatened, due to hunting and illegal trade. In Central America, the tail-bobbing northern nightingalewren (Microcerculus philomela) has been pushed to near threatened status due to continued forest loss. Dr. Ian Burfield, BirdLife's Global Science Coordinator, emphasised the urgency of the situation, saying, "That three in five of the world's bird species have declining populations shows ▶ Cont. to Page-2

inaugurating the threeday 15th NAREDCO Telangana Property Show at Hitex Exhibition Centre, Madhapur.

appreciated NAREDCO's contribution to Hyderabad's real estate growth and urged developers to prioritise affordable housing for middle-class and lowerincome families, while channeling CSR funds toward education and

Hyderabad as "a city where directions are given not by landmass, but by projects," the Deputy Chief Minister said this reflected the city's dynamic growth and continuous renewal. He highlighted that under the leadership of Chief Minister A Revanth Reddy, the government is investing heavily in urban infrastructure and sustainable development.

"For the second consecutive year, we are spending not less than Rs 10,000 crore annually for Hyderabad's development. This investment is visible in roads, drainage, green cover, and overall quality of life," he noted. Bhatti said the government is determined to make Hyderabad a future-ready, resilient, and sustainable city, citing major initiatives such as the revitalisation of the Musi River, the Regional Ring Road (RRR) project, and the new master plan integrating housing, mobility, and environment. "When a city restores its river, it restores its self-respect,"

He added that the government is working to ensure 24x7 water and power supply, expand sewage treatment capacity with 39 new STPs, promote battery-operated

buses for a pollution-free city, and protect lakes, parks, and rock formations. Reaffirming Hyderabad's economic strength, Bhatti said recent land auctions fetching up to Rs 177 crore per acre reflect strong investor confidence in the city's growth story. "Nowhere in the country has land value appreciated like in Hyderabad. This is the result of committed governance and sustained investment," he stated. Tourism, Culture and Archaeology

Minister Jupally Krishna Rao said Telangana is the fastest-growing state in the country, with the real estate sector playing a key role in Hyderabad's expansion. He said progressive policies and world-class infrastructure under Chief Minister Revanth Reddy's leadership have put Hyderabad at the top, adding that Rs 15,000 crore worth of investments in tourism have boosted investor confidence. Earlier, NAREDCO Telangana President Vijaya Sai Meka urged the Deputy Chief Minister to remove the 10 per cent mortgage system and reduce power tariffs for the construction industry. Private Equity in Indian RE down 15 pc over H1 FY25, deal sizes holding: ANAROCK

Kolkata, Oct 10 (FN Bureau)

mid a declining trend of private equity investments in Indian real estate, overall, PE activity in the sector continued to remain soft on an aggregate basis in H1 FY16, finds ANAROCK Capital's latest edition of FLUX. Company CEO Shobhit Agarwal said, "A stronger deal showing in Q1 FY26 appeared to present a glimmer of hope, though it was short-lived as activity subsided again going into the second quarter. When viewed on a full year basis, PE activity has been on a steady decline from the high of USD 6.4 Bn seen in FY21 to USD 3.7 Bn in FY25." "While it is tempting to look at the H1 FY26 tally of USD 2.2 Bn with positivity, it bears keeping in mind that overall activity for H1 FY26 is down 15% on a Y-o-Y basis, compared to H1 FY25," adds Agarwal. While average deal values have remained range bound at lower levels of USD 60 Mn - USD 100 Mn, lower numbers of transactions have been the key drag on the overall deal values. "The share of top 10 deals in H1 FY26 has declined to 77 pc compared to 93 pc witnessed in H1 FY25," says Aashiesh Agarwaal, senior vice president – Research & Investment Advisory – ANAROCK Capital.

"While we do witness an outsized transaction each year, FY25 had a particularly large transaction involving Reliance Group & ADIA-KKR." FY24 & FY25 witnessed an outsized deal each accounting for 37 pc & 42 pc of the total deal value, compared to 15 pc-17 pc witnessed in FY23 & FY22. Unless we see another outsized transaction in FY26, this fiscal year might see a more evenly distributed deal table compared to witnessed in the recent few years. MMR and Kolkata, followed by Chennai, witnessed a sharp rise in activity, while pan-India / multi-city transactions took a back seat in H1 FY26. MMR deal tables were boosted by the Kanakia-Hines-Mitsubishi-



Sumitomo deal, while Kolkata saw a prominent deal in the sale of the South City Mall to Blackstone, where ANAROCK was the transaction advisor. Favored segments in H1 FY26 looked dramatically different from those seen in the previous year. Industrial & Logistics was conspicuous by its absence,

while the Retail, Mixed-use & Commercial asset classes registered a strong presence. Hotels and Data Centres also made an impact in the current half-year. Equity deals comprised 78% of all deals in H1 FY26. This is in line with the usual mix witnessed in the past, barring FY25 which witnessed an outsized hybrid transaction.

The share of foreign capital in total investments bounced back to 73 pc for H1 FY26, after declining to 65 pc in FY25. Residential real estate continued its phase of consolidation into the period, with launches and new sales declining. Investor interest and activity remained buoyant in the sector, with appetite for equity deals - which was

missing until recently - also seen. India's position as the world's fastest growing large economy, shifting lifestyle preferences, and the increasing formalization of its residential real estate sector will keep investor interest in this space high. Leasing momentum remained robust, led by GCCs and coworking places. Expectedly, deal activity also picked up, with USD 869 Mn of offices being transacted in H1 FY26, compared to an average of USD 417 Mn transacted in the three preceding half-year periods. H1 FY26 saw no institutional transactions in the segment, but interest amongst institutional buyers remains high for quality assets, driven by India's consumption story, 3PL, and e-commerce boom. Several transactions are currently under discussion, and some are likely to be closed in the coming months. Retail real estate continued its strong run. Robust operating financial performance drove 2 large retail transactions in this half year period – one by Nexus Select, and the other by Blackstone. India's consumption boom will keep investors excited about its retail real estate prospects.

Rajasthan ATS busts racket employing fake ex-servicemen as guards

Jaipur, Oct 10 (FN Representative)

The Rajasthan Police Anti Terrorism Squad (ATS) has busted a major racket involving the recruitment of "fake exservicemen" as security guards in various government and public sector enterprises using forged documents and identity cards. ATS Inspector General Vikas Kumar today announced the breakthrough, detailing the two-month-long operation code-named 'Square Pyramid'. The investigation focused on 31 offices and installations of the Food Corporation of India (FCI). The operation led to the arrest of 28 individuals who were found to be operating under the guise of ex-servicemen. Kumar stated that these impostors were recruited through private agencies based on fabricated identity cards and certificates

Kumar described the racket as a nexus between undeserving

candidates, private recruitment agencies, brokers, and certain FCI personnel, all conspiring to secure appointments meant for genuine ex-servicemen. According to the ATS, 90 percent of the 490 guard and related posts at various FCI locations are reserved for ex-servicemen. The impostors reportedly received salaries of around Rs 21,000 per month, of which Rs 2,000-Rs 3,000 was allegedly paid as commission to recruitment agents or middlemen. Kumar cautioned that the findings so far could be "just the tip of the iceberg," adding that similar fraudulent appointments may exist in other government, state, or defence-linked establishments. Kumar further noted that "there may be a larger conspiracy involving the corrupt recruitment of impostors and other ineligible candidates through such unscrupulous practices." Operation Square Pyramid is still ongoing, he added.

Fake Mineral Water Bust Sends Powerful Warning



under a direct order from Delhi's Karakarduma Court, Barabanki authorities raided S.M. Hightech City Private Limited at Agro Park, UPSIDC. The company had been pumping out bottles of "CLEAR FRESH", a sham version of the legitimate CLEAR brand, deceiving customers with fake mineral water. Officials recovered massive quantities of bottled water and stickers, collectively estimated in crores of rupees. All production material and bottles were seized in the presence of the Umra Chowki police from Kursi Thana. Court-appointed commissioner and company lawyers present: Authorised company lawyer Rajan Dwivedi and court-appointed local commissioner advocate Nimish Goyal oversaw the seizure, ensuring every step stayed within legal bounds. The Karakarduma Court's order was crystal clear: investigate the allegations thoroughly. The local commissioner documented every seized item, prepared inventories, and ensured all paperwork was court-ready. No corners were cut. Authorities say S.M. Hightech City Private Limited sold fake CLEAR bottles in the market, a case that touches both consumer safety and brand protection. In India, fake product scandals aren't rare, but courts cracking down like this? That sends a serious message. Authorities are urging citizens: always stick to certified mineral water brands. Drinking fake water is not just shady; it's dangerous. Experts warn that coun-

Slipway Cradle to boost vessel maintenance, Blue Economy initiatives

Kochi, Oct 10 (Agency)



The newly inaugurated Slipway Cradle at the Fishery Survey of India - Marine Engineering Division (FSI-MED), a Rs 1.78-crore facility capable of hauling vessels up to 250 tonnes, is set to significantly enhance the country's capacity for vessel maintenance, repair, and marine research, advancing India's Blue Economy goals. In a major boost to India's marine infrastructure, the state-of-the-art Slipway Cradle at FSI-MED was inaugurated here, marking a key milestone in the nation's efforts to strengthen marine research and operational efficiency. The new facility will enhance the performance and upkeep of vessels operated by the Fishery Survey of India (FSI) and other allied agencies, including the Central Marine Fisheries Research Institute (CMFRI), the Central Institute of Fisheries Technology (CIFT), and the Lakshadweep Fisheries Department. Officials described the new cradle as "a milestone in India's journey towards realizing the vision of a sustainable Blue Economy." The facility is expected to benefit fishers, government departments, and private operators alike by ensuring uninterrupted research, surveys, and ecosystem monitoring. The initiative is part of the government's continuing efforts under the Pradhan Mantri Matsya Sampada Yojana (PMMSY) to modernize the fisheries sector, improve livelihoods, and boost seafood exports. Noting the sector's rapid growth, officials said India would explore new international markets for seafood exports amid emerging global trade challenges. They also highlighted that transponders are being installed on fishing vessels in collaboration with ISRO to improve real-time communication and safety at sea. These systems will integrate FSI's Potential Fishing Zone (PFZ) forecasts, enabling fishermen to access accurate information on fish-rich zones directly through their onboard devices. According to FSI Director General Dr. Sreenath K. R., the cradle marks a key step toward achieving the fleet modernization goals under PMMSY. "As fishers invest in modern vessels, world-class maintenance infrastructure is essential to keep them operational and safe. This slipway cradle will ensure long-term sustainability and enhance the lifespan of these assets," he said. Equipped with an electric winch system and designed for balanced hull support, the cradle can dock up to six vessels simultaneously for repair and maintenance. It will cater to a diverse range of crafts, including those operated by the Coast Guard, Customs, Water Metro, tourism operators, and private deep-sea fishing enterprises.

ECoR posts significant growth in freight loading in H1 of FY 2025–26

The East Coast R a i l w a y (ECoR) has registered impressive performance in both

Akash Anand steps into leadership role as Maya indicates return to prominence

Lucknow, Oct 10 (Representative)

ignalling a renewed bid to be a serious contender for power in Uttar Pradesh, the Mayawatiled BSP today officially elevated Akash Anand, nephew of the party chief, to the position of the party's National Vice President, marking a generational shift in the party's leadership and strategy. The announcement came during a massive rally in Lucknow, held on the death anniversary of BSP founder Kanshi Ram. Mayawati declared from the stage, "Just as Kanshi Ram ji mentored me, I have now decided to mentor Akash Anand. He is fully committed to the mission and will work under my guidance to strengthen the party across the country." Akash Anand, in his address to the lakhs-strong crowd, said, "Looking at the enthusiasm and unity among you all, it's clear that BSP is set to form its fifth government in Uttar Pradesh in 2027. The state needs Behenji's leadership now more than ever." His speech energized the gathering and signaled a fresh push toward

youth leadership in the BSP's traditionally disciplined structure. Meanwhile, in a massive show of strength after nearly nine years, Mayawati addressed a huge rally in Lucknow, signaling the party's renewed political momentum ahead of the 2027 Uttar Pradesh Assembly elections. Addressing lakhs of supporters from Uttar Pradesh and five other

states, including Bihar, Punjab, and Haryana, Mayawati declared that the time has come for the BSP to once again form a government on its own, as it did in 2007. In a surprising move, Mayawati praised Chief Minister Yogi Adityanath for not misusing funds and lauded his efforts in maintaining Ambedkar Park. However, she launched a scathing



attack on the Samajwadi Party (SP), calling it "double-faced and opportunistic". She alleged that SP only remembers the backward and Dalit communities when out of power and accused it of changing the names of institutions started under Kanshi Ram's legacy. She also accused opposition parties including SP, BJP. and Congress of conspiring to di-

vide the Dalit vote by creating or backing smaller, "sellout" outfits that aim to weaken BSP electorally. Without naming

Nagina MP Chandrashekhar Azad, Mayawati accused certain individuals of working as tools of rival parties to split BSP's vote bank. "Many selfish and sell-out

types have been propped up to mislead our voters. These parties not only field candidates tactically but also secretly transfer votes to help one or two of their own win.

This is nothing but an organized conspiracy," she charged. The BSP chief also criticized Congress for historical neglect of Babasaheb Ambedkar and Dalit rights. "Congress didn't even declare national mourning when Kanshi Ram ji passed away," she noted. Similarly, she accused BJP and SP of doing little to advance Dalit rights despite being in power. She also blamed both the parties for failing to support reservation in promotions for SC/ST employees and called out SP MPs for allegedly tearing the bill in Parliament. Mayawati has also responded for the first time to rumors of Azam Khan joining the BSP. She said, "Since last month, rumours are afloat that leaders from other parties are joining the party. They've even met in Delhi. I'm not aware of anything like that yet. I don't meet anyone secretly; whenever I do, I meet openly." She said her rivals spread such rumors in

2007 as well. "People weren't misled then, so we won. If we're not misled this time, we'll win again. I hope you'll bring us back to power and make Behenji the CM for the fifth time," she said. Calling for Dalit unity and vigilance against conspiracies, Mayawati reiterated Kanshi Ram's vision of political empowerment. "Power is the key to development," she said. "Until we control power, our people cannot live with dignity." Mayawati made it clear that future elections will be fought solo, asserting that alliances have only hurt BSP's prospects in the past. "Our votes transfer fully, but we don't get anything in return," she said. She said even when such alliances win, the governments often collapse due to differences. She emphasized that only a full majority government led by BSP can truly safeguard the Constitution and ensure justice for Dalits, backwards, and minorities.

Israeli military to begin phased withdrawal from Gaza post parliament ratification



Jerusalem, Oct 10 (Agency) The Israeli military is set to begin a phased withdrawal from the Gaza Strip after the Knesset officially ratifies the ceasefire agreement reached with Hamas later this evening, as per Israeli officials. Within 24 hours of the ratification, the IDF is expected to pull back to pre-agreed deployment lines - retaining control over approximately 53% of Gaza's territory — primarily in less densely populated zones, reports Jerusalem Post. This partial withdrawal will lead to the creation of a security buffer zone for Jerusalem, leaving the IDF troops along the entire Gaza border in possession of the Philadelphi Corridor on the Egypt-Gaza frontier, Beit Hanoun, and Beit Lahiya in the north, an eastern ridge overlooking Gaza City, along with substantial parts of Rafah and Khan Younis in the south. Following the repositioning, Hamas will have 72 hours to fulfil its commitments under the ceasefire by releasing the 48 hostages it is currently holding. The IDF said that it is prepared for the simultaneous release of all 20 living hostages, though mediators have cautioned that the prisoner exchange could face several delays amid the uncertainty of their precise locations due to the heavy destruction of the Strip.

Under the terms of the arrangement, Hamas will transfer the living hostages directly to the International Committee of the Red Cross (ICRC), without any formal ceremony. The ICRC will then escort them to IDF troops stationed inside Gaza, who will oversee their safe passage to Israel's Re'im military base, near the border where they will undergo physical and psychological evaluations, with family members expected to be present for reunions. Those airlifted directly to Soroka Medical Center in Beersheba, bypassing the base. From there, others will be transported to hospitals in central Israel for further treatment and family reunification. For the bodies of slain hostages, the IDF will conduct a brief military ceremony inside Gaza, led by a military rabbi. Before repatriation, all caskets will be examined by sappers "for security purposes," confirmed IDF officials. The caskets with civilian hostages will then be taken to the Abu Kabir forensic institute for identification, which may take up to two days. The bodies of slain soldiers will be taken to the IDF's Shura Camp for identification.

US clarifies no new missiles for Pakistan under recent defence deal

New Delhi, Oct 10 (Representative)

The United States clarified to-

day that reports suggesting Pakistan would receive new Advanced Medium-Range Air-to-Air Missiles (AMRAAMs) under a recently amended contract were incorrect. The US Embassy explained that the contract modification pertains only to sustainment and spare parts support, and does not involve any new weapons deliveries. In a statement, the Department confirmed that the Department of War's announcement on September 30 referred to "an amendment to an existing Foreign Military Sales contract for sustainment and spares for several countries, including Pakistan." It emphasized

no part of this referenced contract

modification is for deliveries of new AMRAAMs to Pakistan" and clarified that the sustainment work "does not include an upgrade to any of Pakistan's current capabilities." The clarification came after media reports claimed that the US was providing new missile systems to Pakistan. The Department emphasized that these reports were false and stressed that the changes were

part of routine support work, not a new weapons sale. This clarification comes in response to media reports, including one from Pakistan's Dawn

newspaper, which misinterpreted the US Department of Defense's Sep-



tember 30 update as indicating a new missile sale to Pakistan.

The official announcement disclosed that Raytheon Co., based in Tucmillion modification to an existing

AMRAAM production contract, raising its total value to over USD 2.5 billion. According to the initial statement from the Department of Defense, the contract involves foreign military sales to various countries, including the United Kingdom, Germany, Israel, Australia, Qatar, Oman, Singapore, Japan, Canada, Bahrain, Saudi Arabia,

Italy, Kuwait, Turkey, and Pakistan, and is expected to be completed by May 2030. sraeli Defence Minister Israel Katz said that he Lhas instructed the IDF to "respond with great force" against any attempt by Hamas to harm Israeli troops in the Gaza Strip, as the government is set to vote on the Trump deal for reaching a ceasefire in the war-ravaged territory. Katz had held an assessment with IDF Chief of Staff Lt Gen Eyal Zamir and other top officers, ahead of the security cabinet vote and full cabinet meetings in the evening, with both expected to approve the ceasefire deal due to wide support among Knesset officials, reports Times of Israel. "The defence minister instructed the IDF to respond with great force to any threat and any attack by the Hamas terror organisation against our forces during the interim stage before the government's decision and until the implementation of the agreement," Katz's office stated Katz was quoted by his office as saying: "Safeguarding the security of IDF soldiers is our foremost obligation in the current situation."

Lt Gen Eyal Zamir had praised the deal during his visit to Gaza, calling it a "ray of light" while meeting with the IDF troops on ground and praised their conduct, stating that the ceasefire deal which will release the hostages was made possible through their actions. "The signing of the agreement to return the hostages this morning is a ray of light for all of us and further evidence of the achievements of the ground manoeuvre. "Thanks to significant military pressure and a powerful, highquality ground manoeuvre, you, the troops, created the conditions for the hostages to be returned home," he remarked, according to the official statement released by the IDF." "The military action brought about a political achievement; the achievement is first and foremost yours," Zamir added. Amid the ongoing vote, IDF officials said that Lt Gen Zamir was briefed on the military's preparations for the deal, which includes a phased withdrawal of troops along the pre-deployment lines, and handling the release of the hostages. The IDF commander also echoed the military's operational readiness in any scenario, stressing that as per the arrangements of the deal "the IDF is committed

to maintaining a high level of

readiness in all arenas, both

in defence and in offense."

30 terrorists killed in military operation in NW Pakistan

Islamabad, Oct. 10 (Bureau)

akistani security forces killed 30 militants during a

large-scale operation in the Orakzai district of the country's northwest Khyber Pakhtunkhwa province, days after an attack that left several soldiers dead, the military said on Friday. The Inter-Services Public Relations (ISPR), the media wing of the Pakistan Army, said in a statement that the operation was launched in the Jamal Maya area of Orakzai following credible intelligence about the presence of militants involved in the Oct. 7 terrorist attack. After an intense exchange of fire, all 30 militants were killed, the statement said, adding that the group was involved in orchestrating the "heinous incident" earlier in the week.

According to military sources, terrorists attacked a group of soldiers in the district during a search operation

on Tuesday in which 11 soldiers, including a lieutenant colonel and a major-ranked officer, were killed. "These successful operations have avenged the attack and brought the main perpetrators to justice," said the ISPR. The ISPR added that clearance operations are continuing in the surrounding areas to eliminate any remaining militants. Pakistani President Asif Zardari paid tribute to the security forces for their brave action against militants, stating that Pakistan's continued success in the fight against terrorism reflects its unwavering resolve.

York New Attorney General Letitia James indicted U.S. state of Virginia

Washington, Oct.10 (Agency)

Tew York Attorney General Letitia James was indicted by a grand jury in the U.S. state of Virginia on Thursday. U.S. media noted that the charges against James are not yet clear. The Justice Department previously launched a criminal probe into James around alleged mortgage fraud and later expanded its investigation. In a statement, James called the indictment "a continuation of the president's desperate weaponization of our justice system.""These charges are

baseless, and the president's own public statements make clear that his only goal is political retribution at any cost," said the prominent Democrat. The indictment came two weeks after a grand jury in the same court -- the U.S. District Court for the Eastern District of Virginia -- indicted former FBI Director James Comey for allegedly making a false statement and obstruction of a congressional proceeding.

On Wednesday, Comey pleaded not guilty to the two charges. The indictments of Comey and James came after U.S. President Donald Trump publicly urged Attorney General Pam Bondi to investigate them, along with Senator Adam Schiff, a

California Democrat and longtime Trump critic. During the Biden administration, James' office sued Trump -- who was then a former president -- and the Trump Organization for fraud in 2022. In her statement on Thursday, James defended her lawsuit. "I stand strongly behind my office's litigation against the Trump Organization. We conducted a two-year investigation based on the facts and evidence -- not politics. Judges have upheld the trial court's finding that Donald Trump, his company, and his two sons are liable for fraud," she said. In a recent Truth Social post, Trump referred to James as "scum" and "corrupt," demanding her removal from office. Enditem

"It is a huge obligation to ensure that we do not return to the Oslo path, God forbid, and that we do not abandon our security to the hands of foreigners," he insisted, boasting that his opposition to previous deals "led to progress in the occupation of Gaza and the application of military pressure that brought Hamas to its knees." After a briefing to the security cabinet, the deal is set to be formally ratified at the Knesset, where a substantial majority is reportedly noted to be in favour of the initiative. An

anonymous Hamas commander said that Jerusalem – under the deal – is set to release nearly 2,000 Palestinian security prisoners in exchange for around 20 living hostages as part of the deal. The figure includes 250 terror convicts serving life sentences and 1,700 others detained since the start of the war. The prisoner swap is expected to take place within 72 hours of the deal's implementation, with both sides having given it the greenlight. IDF troops will nonetheless, continue to be in possession of over 53% of the Strip until all the hostages are released, and gradually retreat from various areas of the enclave, with an international security force coming in to handle security.

accused, identified as Syed Rahim Adnan Ali (21), a B.Tech student in the Electronics and Communication Engineering department, is accused of digitally generating explicit content of nearly 36 female students studying at the institute. The incident came to light

when some students discovered the manipulated material and lodged a complaint with the institute's management. Following the complaint, the IIIT administration immediately searched the student's hostel room and seized his mobile phone, laptop, and pen drives. A preliminary inquiry reportedly confirmed the allegations, after which the student was suspended and ordered to vacate the

campus. The institute subsequently formed an internal inquiry committee comprising female staff members to investigate the technical and behavioural aspects of the case. Based on its findings, the administration lodged a written complaint at the Rakhi police station.



Acting on the complaint filed by Dr. Srinivas K.G., Registrar (In-Charge) of IIIT Raipur, the police registered FIR No. 164/25 under Section 352 of the Bharatiya Nyaya Sanhita (BNS) and Sections 66(G) and 66(D) of the Information Technology Act against the accused. A joint team of the Anti Crime and Cyber Unit and Rakhi police swiftly arrested the student on Thursday.

During interrogation, he reportedly confessed to creating the AI-generated images using digital tools. Police officials said the act had caused serious mental and social distress to the victims and tarnished the institution's reputation. "The accused used AI based image generation

SC issues notice to Centre, ECI on plea seeking voting rights for undertrial prisoners

New Delhi, Oct 10 (Representative)

The Supreme Court today issued notice to the union Government and the Election Commission of India (ECI) on a Public Interest Litigation (PIL) seeking to extend voting rights to undertrial and pre-trial prisoners across the country. A Bench comprising Chief Justice of India B.R. Gavai and Justice K. Vinod Chandran sought responses on the PIL filed by Sunita Sharma, represented by Advocate Prashant Bhushan. The petition challenges Section 62(5) of the Representation of the People Act, 1951, which imposes a blanket ban on voting by individuals confined in prisons, irrespective of whether they are convicted or merely awaiting trial. The provision states that "no person shall vote at any election if he is confined in a prison or in lawful custody of the police," except for those under preventive detention.

The petitioner argues that such a sweeping disqualification violates the principles of democracy and the presumption of innocence, as nearly 75 percent of India's prison population comprises undertrial prisoners. She contends that the restriction should not apply uniformly but should be based on individualised judicial consideration,

particularly excluding only those convicted for electoral or corrupt practices. Filed under Article 32 of the Constitution, the plea seeks di-

rections to the ECI to set up polling stations within prisons and to make provision for postal ballots for prisoners lodged outside their home constituencies or states



It also urges the Court to fill the legal vacuum left by Section 62(5) by framing guidelines that limit disenfranchisement only in cases involving final conviction or specific ju-

dicial determinations. Citing global practices, the plea notes that most democracies restrict voting rights of prisoners only after final conviction or through individualised

judicial determinations. It highlights that even in Pakistan, undertrial and pre-trial prisoners retain their right to vote, making India's blanket ban an exception among democracies. The petitioner further argues that India's current approach contradicts its international obligations under treaties such as the International Covenant on

Civil and Political Rights (ICCPR), which recognises every citizen's right to participate in public affairs and vote in genuine periodic elections. Raising a constitutional ques-

tion, the plea asks, "If convicted persons can contest elections, why can't undertrials vote?" and points out that even individuals serving prison terms are allowed to contest elections, thereby influencing governance. The petition also distinguishes the current case from the 1997 Supreme Court judgment in Anukul Chandra Pradhan v. union of India, which upheld Section 62(5) on the ground that the right to vote was merely statutory. Referring to the 2023 Constitution Bench judgment in Anoop Baranwal, which recognised the right to vote as a constitutional right, the petitioner submits that the earlier view no longer holds good. The matter will now be listed for further hearing after the Centre and the ECI file their responses.

Cough syrup deaths: CDSCO orders crackdown on manufacturers

The Central Drugs Standard Control Organisation (CDSCO), India's top drug regulator, has directed all state governments to submit a comprehensive list of cough syrup manufacturers as it launches a joint audit of these companies. The move follows the tragic deaths of over 20 children in the past month, allegedly linked to contaminated cough syrups, a senior Health Ministry official said today. The CDSCO has informed the World Health Organization (WHO) that it has identified three contaminated cough syrup brands—Coldrif, Respifresh, and ReLife—containing toxic levels of Diethylene Glycol (DEG), a harmful substance linked to the recent child fatalities. Importantly, none of these products were exported from India, the regulator clarified. The implicated products have been recalled, and the manufacturers have been ordered to cease production of all medical products immediately, said the official. Taking serious noted of the tragic incidents, the WHO had reached out to the CDSCO on October 1, seeking clarification and details about the potential contamination and whether these products had been exported internationally.

The UN health agency noted that CDSCO's investigations revealed DEG concentrations of 48.6% in Coldrif (manufactured by Sresan Pharma, Tamil Nadu), 1.342% in Respifresh TR (Rednex Pharmaceuticals, Gujarat), and 0.616% in ReLife (Shape Pharma, Gujarat). Symptoms reported among the affected children—acute renal failure and acute encephalitis syndrome—are consistent with exposure to toxic oral syrups, WHO said. The agency added it is ready to assist Indian authorities in investigating and responding to the tragic events but has yet to receive official information regarding the source of the DEG contamination or the presence of any contaminated pharmaceutical materials. WHO also highlighted a critical regulatory gap: India currently lacks mandatory DEG/ethylene glycol screening for domestically marketed medicines. It emphasized the urgent need to identify the contamination source and remove any potentially tainted pharmaceutical materials in circulation.

ECI allows 12 alternative photo IDs for voting, EPIC not mandatory

New Delhi, Oct 10 (Agency)



Election Commission of India (ECI) announced today that voters can cast their ballots using one of 12 alternative photo identification documents, in addition to the Electors' Photo Identity Card (EPIC). The list of acceptable alternative IDs includes the Aadhaar Card, MN-REGA Job Card, passbooks with photographs issued by banks or post offices, health insurance smart cards issued under the Ministry of Labour or the Ayushman Bharat Health Card, driving licenses, PAN cards, smart cards issued by the Registrar General of India under the National Population Register (NPR), Indian passports, pension documents with photographs, service identity cards with photographs issued to employees by the central or state governments, public sector undertakings (PSUs), or public limited companies, as well Members of Parliament (MPs), Members of the Legislative Assembly (MLAs), or Members of the Legislative Council (MLCs). Additionally, the Unique Disability ID (UDID) Card, issued by the Ministry of Social Justice and Empowerment, is also acceptable. The ECI clarified that possessing an EPIC is not mandatory for voting; however, the voter's name must be present on the electoral roll. The commission has also made special provisions for women who wear burgas or purdahs, ensuring their dignified identification at polling stations.

WB municipality recruitment scam: ED raids Minister Sujit Bose's property among 11 locations

New Delhi Oct 10 (Agency)

The Enforcement Directorate (ED) is conducting extensive searches at 11 locations across West Bengal in connection with the alleged irregularities in the Municipality Recruitment Scam. The investigation stems from a CBI FIR, which was triggered after the Calcutta High Court ordered a probe into the alleged scam. The raids include the official and residential premises linked to Sujit Bose, the sitting MLA and Minister of Fire and Emergency Services for the state. This marks the second time the Minister's properties have been searched by the central agency in this case. The ED is also targeting the office premises of companies owned by Sujit Bose. The ED has argued that the recruitment irregularities extend beyond the school teacher recruitment scandal, involving various posts within municipalities across the state. Further details are awaited.

India to upgrade Indian technical mission in Kabul to normal embassy status: EAM to Afghan Taliban FM Muttaqi

New Delhi, Oct 10 (Representative)

ignalling the resumption of normal diplomatic ties with the Islamic Emirate of Afghanistan, India today announced the upgradation of its technical mission in Kabul to the status of Embassy of India, two years after the Afghan Taliban overran Kabul. External Affairs Minister S Jaishankar, in his address to visiting Afghan Taliban Foreign Minister Amir Khan Muttaqi, conveyed India's decision on upgradation of the Indian technical mission to full embassy status today. In his address, EAM Jaishankar said that the visit of the Afghan Taliban FM "marks an important step" in the advancement of India's ties with Kabul and is an affirmation of the enduring friendship between the two nations. He said the two ministers have spoken to each other, once after the Pahalgam terrorist at-

tack in April this year, and the second time, after the Kunar and Nangarhar earthquake in September. "However, a meeting between us in person has a special value in allowing us to exchange perspectives,

identify common interests and forge closer cooperation." He said as a contiguous neighbour and a well-wisher of the Afghan people, India has a deep interest in Afghanistan's development and progress. "Today, I reaffirm that our longstanding partnership that has seen so many Indian projects in Afghanistan stands renewed." he said. He said the two sides can discuss the maintenance and repairs of finished projects

as well as steps to complete others provide MRI and CT scan machines to which India has already committo Afghan hospitals and deliver vacted. The two sides can also discuss other development priorities of Afghanistan. As part of India's support for the health security of Afghaniopen to doing more. He pointed out that as a first responder, Indian relief materials were delivered to the earthquake sites within hours of the disaster in September. India also offered to contribute for the recon-

struction of residences in the affected areas. India has also been a significant provider of food assistance to the Afghan people, he said, in reference to the 500,000 tonnes of wheat sent by India earlier, and added that New Delhi is delivering a further consignment in Kabul today. Pointing to the forcible repatriation of thousands of Afghan refugees, mostly by Pakistan and Iran, the EAM termed it a matter of deep concern.

"Their dignity and livelihood is important. India agrees to help construct residences for them and continue providing material aid to rebuild their lives," the EAM said. On water management, he said that India is ready to collaborate on the sustainable management of its water resources. "Your invitation to Indian companies to explore mining opportunities in Afghanistan is also deeply appreciated. This can be discussed further," he added. On trade, he said the two sides have a shared interest in boosting trade and commerce, and added that he is glad to note the commencement of additional flights between Kabul and New Delhi. He said that India will expand the avenues for Afghan students to pursue studies at Indian universities. "Sports is another longstanding connection. The emergence of Afghan cricket talent has been truly impressive. India is glad to deepen its support for Afghan cricket." He said that India has introduced a new visa module for Afghan people in April 2025, and as a result New Delhi is now issuing greater number of visas, including in medical, business and student categories. Raising the

issue of terrorism, especially crossborder terrorism, he said while the two nations have a common commitment towards growth and prosperity, it is endangered by the shared threat of cross-border terrorism that both our nations face, in reference to the Tehreek-e-Taliban Pakistan terror group. "We must coordinate efforts to combat terrorism in all its forms and manifestations. We appreciate your sensitivity towards India's security concerns. Your solidarity with us in the aftermath of the Pahalgam terrorist attack was noteworthy," the EAM said. "India is fully committed to the sovereignty, territorial integrity and independence of Afghanistan. Closer cooperation between us contributes to your national development, as well as regional stability and resilience. To enhance that, I am pleased to announce today the upgrading of India's Technical Mission in Kabul to the status of Embassy of India."
