Finance aligned with economic activity can drive inclusive growth: CEA

New Delhi, Jan 13 (FN Representative)

When finance is aligned with real economic activities, it becomes a strong catalyst for growth rather than a mere flow of credit, Chief Economic Adviser V. Anantha Nageswaran said on Tuesday, stressing that inclusive finance is essential for raising incomes and building a resilient economy. Nageswaran said finance should be viewed as a

complement to economic growth, supporting productive work and entrepreneurship. He noted that when financial systems are designed to match the rhythm of work, income cycles and business realities, people tend to behave more responsibly. This alignment, he said, improves repayment discipline, strengthens trust in the system and ensures that finance supports value creation. Referring to the challenges at



the grassroots level, the CEA said credit constraints continue to restrict entrepreneurs, particularly small and micro enterprises. However, he cautioned against viewing credit as a standalone solution. "Credit alone cannot produce independence," he said, adding that access to finance must be combined with skills, market access and supportive institutions to create lasting economic

empowerment. Nageswaran underlined the role of inclusive finance institutions as vital intermediaries between capital markets and small entrepreneurs. These institutions help mobilise capital from formal markets and channel it to productive activities at the bottom of the economic pyramid, enabling entrepreneurs who are otherwise excluded from mainstream finance to participate in growth. He also emphasised that financial literacy must be meaningful and contextual.

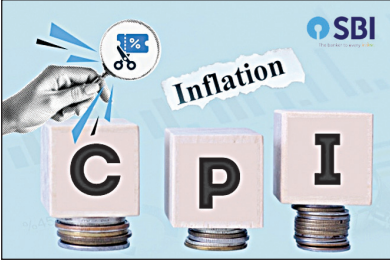
According to him, a financially literate entrepreneur is not just one who understands loans, but also someone who knows when to expand, when to pause and when not to take financial risks. However, he added that literacy by itself is not enough. "Literacy needs opportunity," he said, noting that people become financially capable only when they are connected to markets that allow them to apply their knowledge. CPI inflation surge will strengthen liquidity support: SBI

New Delhi, Jan 13 (Mayank Nigam)

India's inflation trajectory continued to surprise on the downside in December 2025, reinforcing expectations of sustained policy support for growth and liquidity, even as global geopolitical and financial uncertainties pose fresh risks to commodity prices and capital flows in 2026, according to SBI report released here on Monday. Headline inflation based on the Consumer Price Index (CPI) rose to a three-month high of 1.33 per cent in December 2025, from 0.25 per cent in October, driven primarily by a rise in food and beverage prices. Despite the uptick, inflation remained well below

long-term averages, with calendar year 2025 recording the lowest average CPI inflation of 2.2 per cent under the current base year. Food inflation remained the dominant disinflationary force in the economy.



For the first time in the history of the current CPI series, food inflation stayed in negative territory for seven

consecutive months, while annual food inflation averaged just 0.4 per cent in 2025, far below the 14-year average of 5.8 per cent. SBI Research attributed this trend largely to supply-side factors, particularly in food commodities. An item-wise decomposition of CPI showed that 171 of the 299 CPI items were driven by supply-side factors, including 123 food items, while 99 items were demand-driven and 29 neutral. This confirms that food-related supply dynamics played a decisive role in keeping inflation range-bound through most of 2025 and are likely to continue influencing prices into 2026. Fuel and light inflation moderated to 1.97 per cent in December, while inflation in miscellaneous ► **Cont. to Page-7**

Heritage enthusiasts visit birthplace of Odia lexicon Purnachandra Bhashakosha

At a time when Odia 'ashmita' or pride is the talk of the town, heritage enthusiasts and members of Puri Heritage Walks (PHW) under its 17th edition, visited Nuagan which includes Biswanathpur, felt extremely proud, seeing the birthplace of the renowned Odia lexicon Purnachandra Bhashakosha. It is widely believed that its compiler, Gopal Chandra Praharaj, composed the entire dictionary while residing in his farmhouse in his village. During PHW's Satyabadi Tour, the participants visited various "sashana" villages of Satyabadi block and closely observed several ancient

temple complexes. Setting out from Puri in the morning, they first reached Biswanathpur village under Jaipur gram panchayat of Satyabadi and offered prayers to Shri Gopinath Deb. After the original ancient temple had fallen into ruins, the deity is now inside a newly-built temple "Rakha Deul" a style. Temple priest Brundaban Dikshit said that the idol worshiped is actually the most ancient Madan Mohan idol of the Puri Srimandir. Earlier, during the Chandan Yatra festival, Madan Mohan used to come to the Chandan Pushkarini (sacred tank) located in this village to participate in the ceremonial "chapa khela". SC directs Coal India to create a supernumerary post for woman with multiple disabilities

New Delhi, Jan 13 (Bureau)

The Supreme Court on Tuesday directed the Chairman of Coal India Limited to create a supernumerary post for a woman who was denied employment despite qualifying for an interview in 2016, solely due to her multiple disabilities. A Bench comprising Justice J.B. Pardiwala and Justice K.V. Viswanathan passed the order in favour of the appellant, Sujata Bora, while clarifying that the decision was made in the peculiar facts of the case and should not be treated as a precedent. The Court noted that the

vacancy advertisement issued by Coal India did not mention multiple disabilities. As a result, Sujata Bora had applied under the visually handicapped category. Although she qualified for the interview and appeared for document verification and medical examination, she was denied an appointment after it was found that she suffered from multiple disabilities. Setting aside the Calcutta High Court's order dated July 3, 2024, the Supreme Court held that the appellant was denied employment through no fault of her own. The Court directed



She is to be posted at North Eastern Coal Fields, Coal India Limited, at Margherita in Tinsukia district of Assam. Reading out the order, Justice Pardiwala referred to international human rights instruments and principles laid down by the International Labour Organisation, emphasising the importance of disability inclusion. The Court observed that inclusion

of persons with disabilities is an essential part of social responsibility and sustainable governance, and that disability inclusion should be seen not merely as a legal obligation but as a strategic advantage. In its operative directions, the Court said the appellant's disability exceeded the benchmark disability requirement and that she was denied employment only because the recruitment notification failed to provide for multiple disabilities. Keeping these circumstances in mind, the Court ordered the creation of a supernumerary post and expressed confidence that the Chairman of Coal India would provide her ► **Cont. to Page-7**

LG, CM lay foundation stone for Rs.64 cr project to make Nangloi-Najafgarh road monsoon-proof

Stock market ends lower, Nifty slips below 25,750

New Delhi, Jan 13 (FN Representative) The Indian Stock Market today ended lower in another volatile session with the Nifty slipping below 25,750 due to brisk sell-off in auto, consumer durables, pharma and realty stocks. At close, the Sensex crashed by 250.48 points or 0.30 percent to 83,627.69, and the Nifty shed by 57.95 points or 0.22 pc to 25,732.30. The BSE Midcap index slipped 0.16 pc, but the Smallcap index strongly outperformed, rising 0.46 pc. On the sectoral front, IT, media, PSU Bank, metal ended in the green. On the other hand, FMCG, capital goods, consumer durables, pharma, realty fell between 0.3-0.5 pc. On Nifty, Eternal, ICICI Bank, and Tech Mahindra ended as the top gainers while Trent, Larsen and Toubro, and Reliance ended as the top laggards. PFDA sets up expert panel to frame assured payout structure under NPS

The Pension Fund Regulatory and Development Authority (PFDA) has constituted a high-level expert committee to design a regulatory framework for assured payouts under the National Pension System (NPS), a move aimed at strengthening retirement income security for subscribers, an official statement said on Tuesday. The committee has been tasked with developing guidelines that will enable predictable and assured pension payouts when subscribers move from the accumulation phase to the withdrawal phase. This initiative is seen as a significant step towards improving post-retirement financial certainty while retaining the core market-linked structure of the NPS. The 15-member panel will be chaired by Dr MS Sahoo, former chairperson of the Insolvency and Bankruptcy Board of India, and comprises experts from diverse fields including finance, law, insurance, actuarial science, capital markets and academia. The committee may also invite additional subject-matter specialists as needed to support its work. As part of its mandate, the panel will examine various mechanisms to ensure assured payouts, including the use of market-based solutions and legal constructs such as novation and settlement. It will also propose operational norms covering lock-in periods, withdrawal options, pricing structures and fee mechanisms applicable under the assured payout model. The committee will review risk management and capital adequacy requirements to safeguard subscriber interests while maintaining financial stability within the pension ecosystem. It will also assess tax implications to ensure that assured payout structures can be implemented without compelling subscribers to exit the NPS framework. Another key focus area will be consumer protection. The panel is expected to recommend standardised disclosure norms to enhance transparency, reduce mis-selling risks and clearly communicate the nature and extent of payout assurances to subscribers. The move comes amid growing policy focus on retirement preparedness as India's subscriber base under NPS continues to expand. Currently, NPS payouts are largely market-linked, exposing retirees to fluctuations in financial markets. The proposed assured payout framework aims to address this gap by offering greater income predictability in retirement.

Bartronics India to acquire 51 pc stake in agritech firm AYOU

Bartronics India Limited on Monday announced it has received board approval to acquire a 51 percent strategic stake in AYOU, the fresh produce brand operated by Shree NagaNarasimha Pvt. Ltd. (SNN), marking the company's formal entry into organised agri trade under its Project Avio Agritech initiative. AYOU is a Bengaluru-based fresh produce aggregation and processing company that sources fruits and vegetables directly from farmers, farmer producer organisations (FPOs), mandis and collection centres, the Hyderabad based company said in a release here. The company undertakes grading and processing before supplying to leading quick commerce and modern retail platforms, including Blinkit, Zepto, Swiggy Instamart, BigBasket, Ninjacart and More Retail. The company operates a 6,000 sq. ft. processing and grading facility in Bengaluru with a capacity of up to 900 tonnes per month, supported by sourcing hubs across multiple agricultural belts. While demand from organised buyers has remained strong, AYOU's growth has been constrained by working capital and scale limitations. Bartronics' investment is expected to support expansion in aggregation volumes, processing capacity, trade cycles and the addition of higher-margin, processing-led categories. As part of the strategic partnership, Bartronics and AYOU are also evaluating export-led opportunities, with Dubai being assessed as a potential base for agri exports, particularly premium fruits and vegetables. The companies are exploring selective imports of dry fruits and exotic produce into India, with Singapore and other international markets under evaluation for the longer term. Commenting on the development, N. Vidhya Sagar Reddy, Managing Director of Bartronics India Limited, said the investment represents an execution-focused step in the company's agritech journey. AYOU's established operating platform and strong off-take relationships across quick commerce and modern retail would allow Bartronics to scale alongside existing demand while building capabilities in aggregation, value addition and agri commerce, he added.. With this investment, the company moves from strategy articulation to on-ground execution in organised fresh produce, processing and agri trade.

Direct Tax Collections rise nearly 9pc to Rs 18.37 lakh crore in FY26 so far: Govt data

India's direct tax collections recorded a robust growth in the current financial year,

with net collections rising by 8.82 per cent to Rs 18.37 lakh crore as on January 11, 2026, compared to the corresponding period last year, according to official data released on Monday here. The provisional figures show that gross direct tax collections for FY 2025–26 stood at Rs 21.49 lakh crore, marking a 4.14 per cent increase over Rs 20.64 lakh crore collected during the same period of FY 2024–25. Corporate tax collections continued to form a significant share of the revenue. Gross corporate tax collection increased to Rs 10.46 lakh crore in FY26 (up from Rs 9.72 lakh crore last year), while net corporate tax collections rose to Rs 8.63 lakh crore, reflecting steady profitability in the corporate sector. Non-corporate tax collections which include taxes paid by individuals, Hindu Undivided Families (HUFs), firms, associations of persons, and other entities, also showed healthy growth.

Gross non-corporate tax receipts increased to Rs 10.58 lakh crore, while net collections rose to Rs9.29 lakh crore, indicating sustained momentum in personal income tax payments. Collections from Securities Transaction Tax (STT)

remained broadly stable at around Rs 44,866 crore, while receipts under other taxes were comparatively marginal. A notable feature of the data is the sharp decline in tax refunds. During FY 2025–26 (up to January 11), total refunds issued stood at Rs 3.11 lakh crore, down 16.92 per cent from Rs 3.75 lakh crore in the corresponding period last year. Lower refunds contributed to the stronger growth in net tax collections. The improvement in direct tax collections is seen as a positive signal for the government's fiscal position ahead of the union Budget. Higher tax buoyancy provides additional headroom for capital expenditure while supporting fiscal consolidation efforts. With nearly three months still remaining in the financial year, officials expect direct tax collections to remain on a firm trajectory, reinforcing confidence in achieving the annual revenue targets.

Venezuela crisis unlikely to impact Indian corporates: Crisil Report

New Delhi, Jan 13 (Reporter)

The developments in Venezuela are unlikely to have any material impact on India's trade flows or the credit profiles of Indian companies, according to the Crisil report released on Tuesday here. Crisil said India Inc remains largely insulated from the situation given Venezuela's limited role in global crude supply and India's minimal trade exposure to the South American nation. India Inc is a media term for India's formal corporate and government sector, representing its business landscape. Crisil noted that even if the situation in Venezuela escalates and disrupts crude oil production, the impact on global oil prices is expected to remain contained. Venezuela accounts for only about 1.5 per cent of global crude oil supply, making it insufficient to trigger sustained

volatility in international oil markets. Reflecting this, Brent crude prices have remained broadly stable in recent days, hovering just above \$60 per barrel. India's direct trade linkages with Venezuela are marginal. Imports from the country account for less than 0.25 per cent of India's total imports. Crude oil remains the dominant component, with India sourcing around one per cent of its crude oil requirement from Venezuela. In value terms, crude oil and related products formed over 90 per cent of India's total imports from Venezuela, estimated at approximately Rs 14,000 crore in fiscal 2025. While India depends on imports for nearly 85 per cent of its crude



oil needs, Crisil said the current situation does not pose any near-term risk to oil supply or pricing for the country. The rating agency added that Venezuela's vast untapped crude reserves could, in fact, support global oil supply over the medium to long term if investments in production increase, potentially leading to softer crude prices — a positive outcome for Indian corporates. On the exports front, India's exposure is even smaller. Exports to Venezuela stood at under Rs 2,000 crore in fiscal 2025, accounting for less than 0.1 per cent of India's total exports. These exports are diversified across sectors such as pharmaceuticals, ceramics, textiles and two-wheelers. Pharmaceuticals were the largest

export category, valued at around Rs 900 crore last fiscal. However, this represented less than 0.5 per cent of India's overall pharmaceutical exports. Shipments of ceramics, textiles and two-wheelers ranged between Rs 80 crore and Rs 120 crore each and constituted a negligible share of sectoral exports as well as Crisil's rated universe. Given the modest scale of trade exposure, Crisil Ratings said it does not expect any material impact on the credit profiles of Indian companies dealing with Venezuelan customers. However, the agency added that it will continue to closely monitor developments in the region for any potential spillover risks. The assessment follows recent geopolitical developments in Venezuela, including a military operation launched by the United States earlier this month, which has heightened global attention on the country's political and economic stability.

Centre persuades delivery aggregators to take down mandatory 10-minute delivery deadline

New Delhi, Jan 13 (Representative)

Coming as a major relief to the gig workers, union Labour Minister Mansukh Mandaviya has persuaded major delivery aggregators to remove the mandatory 10-minute delivery deadline. A meeting was held with leading platforms including Blinkit, Zepto, Zomato and Swiggy among others to address concerns related to delivery timelines. As per the reports, quick commerce firms, such as Blinkit and Zepto, have voluntarily decided to halt 10-minute delivery claims after Minister Mandaviya raised the issue. Blinkit's principal

tagline has been revised from "10,000 plus products delivered in 10 minutes" to "30,000 plus products delivered at your doorstep." The development comes after the delivery workers staged a nationwide strike on New Year's Eve 2025. They protested the physical strain, safety risks and income instability caused by aggressive delivery timelines, and said the race to meet 10-minute targets was pushing them to take risks on the road while also limiting their ability to earn fairly. Reacting on the protests, the Eternal Group CEO Deepinder Goyal had defended the delivery model saying it does not encourage unsafe driving. He had said the delivery partners are

not shown customer-facing delivery timers on their apps and are not under direct pressure to meet the 10-minute promise. Welcoming Mandaviya's move, Aam Aadmi Party (AAP) MP Raghav Chadha called it a win for gig workers, saying "Satyamev Jayate. Together, we have won". "This is a much-needed step because when "10 minutes" is printed on a rider's t-shirt/ jacket/ bag and a timer runs on the customer's screen, the pressure is real, constant, and dangerous. This step will help ensure the safety of

the delivery riders and everyone who shares our roads," he said. "This step will help ensure safety of the delivery riders, and everyone who shares our roads. Over the past months, I



have spoken to hundreds of delivery partners. Many are overworked, underpaid and risking their life to fulfil an unrealistic promise. I thank every citizen who stood with us - you stood firmly on the side of human life, safety & dignity. And to every gig worker - you're not alone, we're all with you," he said in a post on social media platform X. Notably, during the Parliament session, Chadha had demanded regulations for quick commerce and other app-based delivery and service businesses, emphasising the need for social security benefits for gig

workers. The definition of gig workers and platform workers and provisions related to the same have been provided in the Code on Social Security, 2020, coming into force on November 21, 2025. The Code provides for framing of suitable social security measures for gig workers and platform workers on matters relating to life and disability cover, accident insurance, health and maternity benefits, old age protection, etc. Notably, the Ministry of Labour and Employment had also launched the e-Shram portal in 2021 for the creation of a Comprehensive National Database of Unorganised Workers, including platform workers, migrant workers, etc.

TCS posts 14 pc YoY fall in Q3 FY26 profit after tax at Rs 10,657 cr

Tata Consultancy Services (TCS) officially announced a decline in its profit after tax (PAT) for the third quarter of the financial year (Q3 FY26), on Monday, though its revenue rose by 5%. The company has attributed its Q3 FY26 PAT decline to a one-time charge related to the labour code and legal claims, along with restructuring expenses, according to its statement. TCS posted a 13.9% (calculated as 14%) year-on-year (YoY) decline in its consolidated net profit to Rs 10,657 crore as compared to Rs 12,380 crore

for the same period last year. On a sequential basis, PAT was lower by 11.7% from Rs 12,075 crore posted in the previous September quarter of FY26. The decline in Q3 FY26 PAT was despite a marginal growth of almost 5% YoY in the company's topline during the period under review to Rs 67,087 crore from Rs 63,973 crore in Q3FY25. On a sequential basis, TCS has seen a 2% rise, while in constant currency terms, its revenue growth stood at 0.8%. The company's bottom line was impacted after it provided for certain exceptional items during the quarter, including the provisions for a one-

time charge related to the labour code besides legal claims, along with restructuring expenses. TCS stated



that the statutory impact of new labour codes of Rs 2,128 crore, comprised Rs 1,816 crore towards gratuity and Rs 312 crore towards long-term compensated absences, which primarily arose due to changes in the wage definition under the new labour code. TCS also made a provision

towards a legal claim of Rs 1,010 crore pertaining to a 2019 claim filed by an American company called Computer Sciences Corporation (CSC) against TCS, in the US District Court for the Northern District of Texas, Dallas Division, alleging "misappropriation of trade secrets as well as other confidential information" belonging to CSC. However, the company's net income stood at Rs 13,438 crore, a growth of 8.5% YoY with net margins rising to 20%, a growth of 60 basis points for the year and 40 basis points sequentially. The total contract value (TCV) stood at US \$9.3 billion, but

missed estimates of US \$11 billion which brokerages had pegged for Q3 FY26. TCS announced a bumper payout of Rs 57 per share as a dividend, including a third interim dividend of Rs 11 and a special dividend of Rs 46. "The third interim dividend and the special dividend shall be paid on Tuesday, February 3, 2026, to the equity shareholders of the Company, whose names appear on the Register of Members of the Company or in the records of the Depositories as beneficial owners of the shares as on Saturday, January 17, 2026, which is the Record Date fixed for the purpose," according to the TCS statement.

E2E Rail secures Rs 134.41 cr railway orders post IPO

Uniper-AM Green sign long-term renewable ammonia offtake from India

Hyderabad, Jan. 13 (Representative)

German energy company Uniper and AM Green Ammonia India Pvt. Ltd. on Monday announced the signing of a long-term, binding offtake agreement for up to 500,000 tonnes per year of renewable ammonia from India, marking one of the first large-scale green fuel supply corridors between India and Europe. The agreement was exchanged between Uniper CEO Michael Lewis, CBE, and AM Green Founder and Group Chairman Anil Kumar Chalamalasetty in the presence of German Chancellor Friedrich Merz and Indian Prime Minister Narendra Modi at an event in Ahmedabad, a release said here on Monday. Under the deal, Uniper will source renewable ammonia certified as a Renewable Fuel of

Non-Biological Origin (RFNBO) from AM Green's projects in India. First deliveries are expected as early as 2028, from AM Green's 1 million tonnes per annum (MTPA) green ammonia plant currently under construction in Kakinada, Andhra Pradesh, the company said in a release here.



The agreement supports India's ambition to become a leading global exporter of green hydrogen and green ammonia under the National Hydrogen Mission, while helping European industry decarbonise hard-to-abate sectors such as chemicals, fertilisers,

refining and, over time, shipping. Michael Lewis said the deal was a "key building block" in Uniper's strategy to secure reliable access to renewable and low-carbon molecules at scale, adding that green ammonia offers competitive CO2 avoidance costs due to its mature production process and lack of fossil carbon feedstocks. Anil Kumar Chalamalasetty described the partnership as "a milestone for India's role in the global energy transition," noting that AM Green's renewable ammonia is designed to meet stringent European RFNBO standards through firm and dispatchable clean electricity solutions. Both companies said they will continue working with certification bodies to ensure full traceability and high-integrity emissions reporting for European end users.

For many involved, this marks their initial encounter with organised contests and supervised instruction. Furthermore, the Council regards chess as a mechanism for developing character and supporting mental health in students suffering from Autism. Consistent play of the game has been shown to enhance concentration, lessen reactive actions, and elevate self-assurance among participants with special needs. Pursing the Council’s ‘Chess for Autistic People’ program, adults involved in these programs, both parents and teachers, have observed favorable changes in behavior, particularly in children who previously faced challenges with focus and self-control. Crucially, these undertakings are not conducted in isolation. They form part of a wider framework linking community coaching with regional and national events, ensuring ongoing progress and encouragement. Promising players identified through these schemes are directed towards official competitions and rating progression, establishing a link between social growth and competitive avenues. By framing chess as a vehicle for positive social change, the Rai Sahab Council for Sports and Education is building trust through dependable fieldwork. As discussions about youth advancement, digital equilibrium, and valuable athletic involvement gain importance, efforts such as these highlight how mission-driven organisations can generate quantifiable change while reinforcing India’s wider sports structure.

Colleen Hoover shares update on cancer treatment

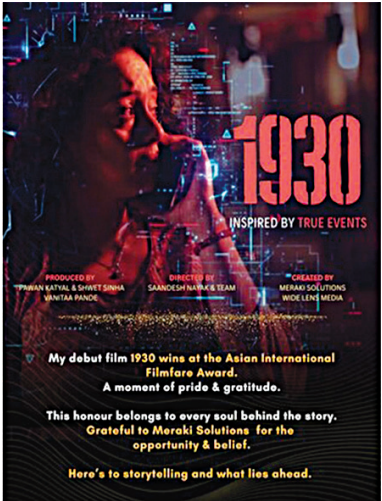

I’ll live vicariously through you guys. So sad to miss this movie release and premiere, but so grateful to all the actors and the team who put this together,” she wrote. Last week, Hoover shared additional details, noting that genetic testing indicated her cancer was not inherited and was unlikely caused by HPV or hormonal factors. “This means it was more than likely environmental or lifestyle-related, such as lack of exercise, poor diet, and stress,” she explained.

Ajit Pawar rules out merger amid NCP alliances speculation

Amid alliances between the Nationalist Congress Party (Ajit Pawar faction) and the Nationalist Congress Party led by Sharadchandra Pawar in some municipal corporation elections across Maharashtra, speculation has intensified about a broader coming together or even a merger of the two parties. Clarifying the matter, Deputy Chief Minister Ajit Pawar said on Tuesday that an appropriate decision would be taken at the right time, adding, "There are currently no discussions on reunification or merger." Speaking to reporters, Pawar noted that following the municipal elections, elections to district councils and panchayat samitis are due. As seen in some municipal bodies, there is political curiosity over whether the two NCP factions will come together for these elections as well. He said, "Preliminary discussions have taken place with MP Supriya Sule and Shashikant Shinde, the state president of the Sharadchandra Pawar-led party, and the response has been positive. However, no concrete decision has been taken yet." Responding to allegations of corruption levelled by him against local BJP leaders in the Pimpri-Chinchwad Municipal Corporation, Pawar hit back at BJP leaders who revived allegations against him related to the alleged Rs 75,000 crore irrigation scam during the municipal election campaign. Pawar said he has discussed the matter in detail with senior leaders at both the state and central levels and does not feel the need to respond to anyone else on the issue. Ajit Pawar asserted that despite being part of the BJP-led Mahayuti alliance and the state government, he has not abandoned the principles of secularism and the ideology of Shivaji, Shahu, Phule, and Ambedkar. He added, "The Constitution guarantees freedom to every citizen," but emphasized the need for a law providing capital punishment for those involved in anti-national activities.

GMR Aero Cargo launches India's first airside reefer truck at Hyderabad Airport

Hyderabad, Jan 13 (Bureau) GMR Aero Cargo & Logistics on Tuesday launched India's first airside reefer truck at Hyderabad Airport, marking a major upgrade in temperature-controlled cargo handling. The specialised truck is designed to maintain cold-chain integrity during airside movement of sensitive consignments between the cargo terminal and aircraft, reducing temperature exposure during ramp transfers. It supports a temperature range of 2°C to 25°C and can carry pharmaceuticals, seafood, dairy, meat, flowers, fruits, vegetables and other perishables. Built on a Tata chassis with a 10-tonne payload, the reefer truck can accommodate two lower-deck ULDs, improving operational efficiency and cutting multiple trips during aircraft loading. GHIAL CEO Pradeep Panicker said the initiative would set new standards in perishable and pharma logistics and strengthen Hyderabad's position among global cargo hubs.

Kharge's development plea adds fuel to Siddaramaiah-Shivakumar fracas

Kalaburagi, Jan 13 (Reporter)

Senior Congress leader and AICC President Mallikarjun Kharge on Tuesday sparked speculation about internal party dynamics in Karnataka by calling for development in Kalaburagi and the broader Kalyana Karnataka region to match that of Mysuru and other southern constituencies. Speaking at a public gathering in Jevargi town, Kharge, a native of Kalaburagi, highlighted persistent regional disparities under the special status law (Article 371J) and

urged Chief Minister Siddaramaiah and Deputy Chief Minister DK Shivakumar to prioritise northern Karnataka. "We do not want Kalaburagi to become London or Singapore. We want development similar to Mysuru and your constituencies," he said, while emphasizing equitable allocation of resources. Observers say Kharge's remarks carry a subtle political undertone amid ongoing debates within the state Congress over leadership roles and

the distribution of influence between Siddaramaiah and Shivakumar.



Recent media reports have chronicled a continuing tussle between the

two senior leaders, with exchanges over administrative control and the implementation of agreed power-sharing arrangements fuelling perceptions of friction. Reports have noted past disagreements, such as a bureaucratic transfer dispute involving Shivakumar's department and tensions over rotational leadership expectations, that have kept the spotlight on internal dynamics. Chief Minister Siddaramaiah has repeatedly denied any rift with his deputy, asserting

there is no conflict and dismissing rumours as media speculation, while Shivakumar too has insisted on party unity and denied any personal differences, calling reports of discord "creations of the media." DCM Shivakumar, who was present at the event, noted that Rs 1,000 crore had been released for Jevargi, acknowledging the region's electoral support to Congress. Analysts say Kharge's public appeal, coupled with Shivakumar's response, underscores growing scrutiny within the party on governance and leadership priorities in Karnataka.

'Jana Nayagan' censor row: Rahul jumps to Vijay's defence, blames Modi govt for attempting to block movie

Chennai, Jn 13 (Representative)

After senior AICC leaders and MPs, Congress icon and Leader of the Opposition in the Lok Sabha Rahul Gandhi on Tuesday has come to the aid of a beleaguered actor-politician and Tamilaga Vettri Kazhagam (TVK) Founder Vijay whose swansong movie 'Jana Nayagan' is in the crosshairs of securing censor certification, charging the Prime Minister Narendra Modi government with attempting to block the film which is an attack on Tamil culture. "Mr Modi, you will never succeed in suppressing the voice of the Tamil people," Gandhi said in a terse but acerbic post on his 'X' handle. The former Congress President further said, "The I&B Ministry's attempt to

block 'Jana Nayagan' is an attack on Tamil culture." Ahead of landing in Tamil Nadu for a private school event at Gudalur in the hilly Nilgiris district, he had posted it. During his Bharat Jodo Yatra, the Gandhi family scion had stayed at the school and assured to visit the institution later. And, his support could not have come at a better time for a beleaguered Vijay, who was grilled by the CBI yesterday in New Delhi for six hours in the horrendous Karur stampede which claimed 41 lives during his rally last September. The actor, heading the fledgling TVK will be questioned again on January 19, after the Pongal festival. Within hours the 'X' post has gone viral with the fans of the iconic actor and TVK supporters profusely thanking him besides retweeting it by tagging with pictures of Vijay and

Rahul being together. Welcoming it, a TVK supporter commented thus "Great move Congress. The BJP has unwittingly turned the movie 'Jana Nayagan' into a Pan India film. By addressing the Jana Nayagan issue, Rahul and the Congress have sharpened the strong aversion towards the BJP in the minds of the TVK supporters." This is not the first time that Rahul is extending solidarity with Vijay. Earlier, in the immediate aftermath of the Karur tragedy, he had spoken to him over phone assuring his support. Since then, speculation is rife that the Congress is open to the option of teaming up with Vijay's TVK for the upcoming assembly election. Congress leaders like Girish Chodankar and Praveen



Chakravarty as well as local MPS, Manickam Tagore and Jothimani have sprung in support of Vijay when the Censor Board delayed the certification for 'Jana Nayagan' which was earlier scheduled to have hit the screens for Pongal festival season on January nine. However, the First Bench of the Madras High Court stayed the Single Judge Ms Asha's order directing the CBFC to give U/A certification for the film. The Bench also posted the case after Pongal festival holidays to January 21 and till that date the film could not be screened. Meanwhile, the producers of the film have moved the Supreme Court seeking relief and the matter was yet to be taken up for hearing. Vijay has identified the BJP as the TVK's ideological enemy and thus far remains wedded to secularism, which has not gone down

well with the BJP. Meanwhile talking to reporters at the airport on arrival from Delhi along with Vijay, TVK Joint General Secretary C T Nirmal Kumar, while welcoming the support extended by Rahul Gandhi for the film, said there was no change in TVK's already decided stand, effectively dousing speculations of possible alliance with the National party, which has been demanding share in power from the DMK, heading the alliance in Tamil Nadu. Vijay had already assured that his party was ready for alliance and was also ready for power sharing if his party wins the elections and forms the next government. "Vijay is a spoiler," was the reaction of union Minister Piyush Goyal, Tamil Nadu in-charge of the BJP. This is a clear indication of the BJP realising that Vijay is out to split the anti-DMK votes.

Khaira flags environmental governance risks in PLPA recast, writes to Governor

Chandigarh, Jan 13 (Representative)

Punjab Congress MLA Sukhpal Singh Khaira has written to Governor Gulab Chand Kataria expressing serious concern over recent amendments made to the Punjab Land Preservation Act (PLPA) by the Bhagwant Mann-led AAP government, warning that the changes could have damaging ecological and governance consequences. In his letter, Khaira said the amendments pose a threat to Punjab's fragile environment, particularly the Kandi belt and eco-sensitive zones around Chandigarh. He noted that the PLPA was originally enacted to protect forests, prevent soil erosion, conserve groundwater,

and maintain the state's ecological balance. Any dilution of restrictions on land use and non-agricultural construction, he argued, defeats the very purpose of the law and risks irreversible environmental damage, he added. The Congress legislator voiced apprehension that the amended provisions could facilitate the unchecked construction of farmhouses and commercial projects under the pretext of development. He alleged that individuals with prior knowledge of policy changes, including those linked to the ruling establishment, could benefit disproportionately. Khaira also flagged concerns about an emerging land mafia potentially exploiting the amendments to acquire large land holdings at

low prices, leading to long-term ecological harm. Khaira questioned the manner in which the amendments were introduced, pointing to the absence of transparent public consultation, credible environmental impact assessments, and broad legislative



consensus. He said Punjab is already under severe environmental stress due to groundwater depletion, deforestation, and climate vulnerability, and cannot afford

what he described as a reckless weakening of protective laws. Urging the Governor to intervene, Khaira requested a thorough examination of the constitutional, legal, and environmental implications of the amendments. He appealed for steps to ensure a transparent and accountable review process, continued statutory protection for ecologically sensitive areas under the PLPA, and safeguards against misuse of policy changes for speculative land grabbing or profiteering. The MLA stressed that Punjab's land and natural resources are a shared legacy for future generations and said policy decisions affecting them must be guided by long-term public interest rather than short-term political or commercial considerations.

Nashik shaken! SIT ordered into looting of container carrying Rs 400 crore in demonetized banknotes

Nashik, Jan 13 (FN Bureau)

A Special Investigation Team (SIT) has been constituted to investigate the alleged looting and kidnapping case involving 400 crore rupees in demonetised banknotes that occurred in the Ghoti-Wadivarhe area. The police have initiated a technical investigation to uncover the financial irregularities and identify the suspects in this case. A Special Investigation Team (SIT) has been appointed under the leadership of the District Superintendent of Police to investigate the alleged crimes of kidnapping, death threats, extortion, and the looting of a container carrying a staggering 400 crore rupees in demonetised banknotes, which occurred in the Ghoti-Wadivarhe area in October 2025.



The investigation will be conducted under the guidance of Superintendent of Police Balasaheb Patil, and supervised by Additional Superintendent of Police Aditya Mirakhelkar and Sub-Divisional Police Officer Harish Khedkar. This decision was taken after swift action by the police and administration following a report published by the

'Sakal' newspaper in its Sunday (Jan 11) edition. According to the complaint filed by Sandeep Datta Patil (resident of Nashik Road), the suspects Jayesh Kadam, Vishal Naidu, Sunil Dhumal, Virat Gandhi, and Janardan Dhaygude (Mumbai) allegedly kidnapped him, threatened him and his family with death at gunpoint, and four of the aforementioned individuals are accused by Sandeep Patil of looting the container containing 400 crore rupees in banknotes.

The mention of a financial scam involving 400 crore rupees in demonetized currency in the complaint is extremely shocking. The investigation is now focused on determining the source of the 400 crore rupees in banknotes and where they were being transported. The police administration has clarified that due to the extremely serious, sensitive, and high-value nature of this case, and considering the possibility of involvement of politically and socially influential individuals, a SIT has been appointed for an impartial and independent investigation. The committee includes experienced and senior officers, and the Economic Offences Wing, cyber experts, and technical analysts have also been included in the investigation.

China rejects India's claim over Shaksgam Valley

Beijing, Jan 13 (Representative)

Chinese Foreign Ministry Spokesperson Mao Ning on Monday rejected India's claim over the Shaksgam Valley in Jammu and Kashmir."The territory you mentioned belongs to China. It's fully justified for China to conduct infrastructure construction on its own territory," Mao said when asked about border issues and the China-Pakistan Economic Corridor (CPEC).The spokesperson further said, "China and Pakistan in the 1960s signed a boundary agreement and delimited the boundary between

the two countries, which is the right of China and Pakistan as sovereign countries. The China-Pakistan Economic Corridor (CPEC), as an economic cooperation initiative, aims at promoting local socio-economic development and improving people's livelihood. The China-Pakistan boundary agreement and CPEC do not affect China's position on the Kashmir issue and the position remains unchanged."India strongly rejected "Chinese infrastructure projects" in the Shaksgam Valley, asserting that the region is an integral part of its territory and condemning any attempts to alter the ground reality.The Ministry of External Affairs (MEA) emphasised

that projects under the CPEC passing



through this area are "illegal" and "invalid", reiterating India's consistent

stance on "sovereignty and territorial integrity".MEA spokesperson Randhir Jaiswal said: "Chinese infrastructure buildup via CPEC in the Shaksgam Valley, which is Indian territory. We have never recognised the so-called China-Pakistan boundary agreement of 1963. We have consistently maintained that the agreement is illegal and invalid."He added, "We do not recognise the so-called China-Pakistan Economic Corridor either, which passes through Indian territory, currently under forcible and illegal occupation by Pakistan."He stressed, "The entire union Territories of J&K and Ladakh are an integral and inalienable part of

India."This has been clearly conveyed to the" Chinese and Pakistani authorities" several times."We have consistently protested with the Chinese side for its attempts to alter the ground reality in the Shaksgam Valley. We further reserve the right to take necessary measures to safeguard our interests," MEA said in a statement.The latest tensions come amid reports that China has constructed a road across the Aghil Pass, at an altitude of 4,805 meters, reaching the lower Shaksgam Valley.India has repeatedly conveyed its objections to both Chinese and Pakistani authorities and reserves the right to take all necessary measures to safeguard its interests.

UK govt to criminalise creation of nude deepfakes



London, Jan 13 (Agency)

The UK government

will launch criminal prosecutions for the creation of intimate images online without the user's consent, UK Secretary of State for Science, Innovation and Technology Liz Kendall said. On Monday, British media regulator Ofcom launched an investigation into xAI and Elon Musk's chatbot Grok, which were used to generate pornographic images using artificial intelligence. If a violation is found, Ofcom could impose a fine equal to 10 percent of the company's global revenue. "Under the Online Safety Act 2023, sharing or threatening to share intimate images without someone's consent, including images of people in their underwear, is a criminal offence for both individuals and platforms. The Data (Use and Access) Act 2025 made it a criminal offence to create or request the creation of non-consensual intimate images, and today I can announce to the House that this offence will be brought into force this week," Kendall said in the UK parliament on Monday. The minister also criticized X's recent decision to restrict access to the Grok image-creation feature to paid subscribers, claiming that this is only "monetising abuse." On January 3, Musk said on X that "anyone using Grok to make illegal content will suffer the same consequences as if they upload illegal content." The UK's Online Safety Act 2023 grants Ofcom wide-ranging powers to enforce consumer protection legislation on television, radio, and the internet. It restricts access to content deemed harmful to children, including pornography, content promoting self-harm, eating disorders, and suicide. Violations can result in heavy fines and prison terms for platform operators.



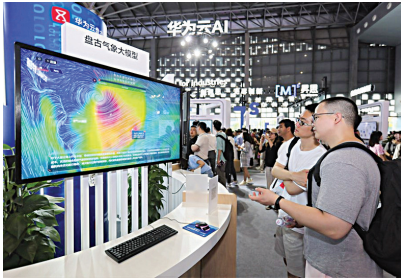

China unveils first AI model to gauge weather's impact on stock market

Beijing, Jan 13 (Bureau)

China has revealed its first artificial intelligence (AI) model designed to analyze the impact of weather patterns on financial markets, marking a novel step in climate-aware risk management, the China Meteorological Administration (CMA) has said. The model Shangji, or Stock, was jointly developed by the Shanghai-based Fudan University and the National Meteorological Information Centre. Its core function is to assess how meteorological factors influence asset pricing, offering a new tool for investment decisions and financial risk assessment, the CMA was quoted as saying by Science and Technology Daily on Tuesday. Zhao Yanxia, a lead developer of the model and director of the

CMA key open laboratory for financial meteorology, said the model, utilizing global reanalyzed meteorological data and historical stock trading data, is able to forecast short-term returns for the majority of stocks on China's A-share market. Validation tests indicate that the model is capable of accurately



identifying industries highly sensitive to weather conditions, such as wind and solar power, traditional petrochemicals, construction and agriculture, thereby aligning with

international standards.

Back-testing of investment strategies based on the model's predictions has shown "sustained and stable positive returns" over various historical periods, suggesting practical potential, Zhao explained. The model holds broad application prospects in the financial sector, said Li Hao, a professor at the Artificial Intelligence Innovation and Incubation Institute of Fudan University and one of the model's creators. Companies in weather-sensitive industries can use it for climate risk management, while banks and insurers can apply it to control risks in businesses, like equity pledges, and explore climate-related financing, Li noted. Li added that the model is useful for investors as an aid in quantitative investing, and that academics can employ its output to test and refine asset pricing theories.

Australian neo-Nazi group to disband in response to proposed hate speech laws

Sydney, Jan 13 (Bureau)

Australian neo-Nazi group the National Socialist Network (NSN) on Tuesday announced it will disband in response to new hate speech laws proposed by the federal government following the Bondi Beach terror attack. The NSN said in a statement posted on social media that it will close down by January 18, one day before the federal parliament is set to reconvene to debate legislation for the hate speech laws. Under the proposed laws, which were promised in the wake of the Bondi Beach terror attack that killed 15 people on December 14, it would be

easier for the federal government to designate organizations as prohibited hate groups.

Once a group is prohibited, it would become a criminal offense to be a member, direct the activities of the group, recruit for the group, provide, receive, or participate in training involving the group, get funds to, from, or for the group, or provide support to the group, with penalties of up to 15 years in prison. The statement said that there would be "no way" to avoid the neo-Nazi group from being banned if the laws pass the federal parliament. "This disbandment is being done before the laws take effect to avoid former members of the organizations from being arrested and charged," it said.

Iran to evacuate its diplomatic mission personnel in UK

Tehran, Jan 13 (Agency)

Iran will be forced to consider evacuating its diplomatic mission personnel in London if the United Kingdom fails to ensure their safety, Iranian Foreign Minister Abbas Araghchi said. "In a phone conversation with the UK Foreign Secretary this evening, I made clear that the UK is, by international legal obligations, duty-bound to ensure the safety and security of Iran's London Consulate and Embassy. If the UK cannot uphold its duty to protect diplomatic missions, Iran would be left with no choice but to consider evacuating our personnel," Araghchi said on X on Monday. "I also urged the UK to avoid interfering in Iran's internal affairs, including by continuing to refrain from taking action against Israeli-backed terrorists posing as news organizations. Ofcom has clear rules and regulations about the incitement of violence and glorification of terrorism. The UK Government must take action to ensure that its own domestic laws are upheld," he added.



US Congressman introduces bill for "Annexation and Statehood" of Greenland

Washington, Jan 13 (Reporter)

US Congressman Randy Fine has introduced a bill to make Greenland the 51st state of the United States, giving further momentum to President Trump's long-standing push to acquire the Danish territory. The "Greenland Annexation and Statehood Act" was introduced Monday by the Florida Republican, according to a statement from his office. The bill's stated goals include enabling "the annexation and subsequent admission to statehood of

Greenland." In a post on X, Fine said, "Today, I am proud to introduce the Greenland Annexation and Statehood Act, a bill that allows the President to find the means necessary to bring Greenland into the Union." "Let me be clear: our adversaries are trying to establish a foothold in the Arctic, and we can't let that happen," Fine added. "By acquiring Greenland, we would prevent our adversaries from controlling the Arctic region and secure our northern flank from Russia and China." "Greenland is not a distant outpost we can afford to ignore, it is a vital national security asset," Fine said

in the press release. "Whoever controls



Greenland controls key Arctic shipping lanes and the security architecture protecting the United States." "America cannot leave that future in the hands of regimes that despise our values and seek to undermine our security," he added. The bill states that President Trump "is authorized to take such steps as may be necessary, including by seeking to enter into negotiations with the Kingdom of Denmark, to annex or otherwise acquire Greenland as a territory of the United States." After the US acquires Greenland, the bill would require Trump to submit a report to Congress

outlining possible federal law changes "as the President may determine necessary to admit the newly acquired territory as a State." White House Press Secretary Karoline Leavitt said Monday that there is no specific timeline for the U.S. to take over Greenland. "President Trump has not set a timeline, but it's definitely a priority for him," Leavitt told reporters. "I think the president was very clear last night," she continued. "He said that he wants to see the United States acquire Greenland because he feels that if we do not, it will eventually be acquired, or even perhaps taken over hostilely, by either China or Russia."

US imposes 25 percent tariffs on countries trading with Iran

Washington, Jan 13 (Representative)

United States President Donald Trump on Monday announced the imposition of 25 percent tariffs on countries that continue to do business with Iran, as anti-government protests persist across the country. In a post on Truth Social, Trump reiterated that the decision would take effect "immediately" and emphasised that the "order is final and conclusive." "Effective immediately, any Country doing business with the Islamic Republic of Iran will pay a Tariff of 25% on any and all business being done

with the United States of America. This Order is final and conclusive," Trump said in his post. Trump has repeatedly warned that the US could be forced to take action against Iran as nationwide protests continue, even as he disclosed that Tehran has reached out to Washington to seek negotiations. Speaking to reporters aboard Air Force One, Trump said Iranian leaders had contacted Washington to discuss diplomatic engagement. Asked if Iran was seeking negotiations,

Trump said it was, adding, "They do. They called. Iran called to negotiate yesterday. The leaders of Iran called. They want to negotiate. I think they're



tired of being beat up by the United States. Iran wants to negotiate." The US president added that while a meeting was in the process of being arranged, developments on the ground could force Washington to act before talks take place. Meanwhile, Republican Senator Lindsey Graham praised Trump's decision to impose the 25 percent tariffs, calling the move to economically isolate Iran's leadership "most impressive." Sharing a post on X, Graham wrote, "Mr President: your decisive

leadership in isolating this regime economically through your actions today are most impressive. Your promise to have the protestors' back and put the regime on notice that you will not tolerate the killing has led to the largest outpouring of demonstrators against this fanatical regime since its founding. Mr President: I believe the Iranian regime has crossed red lines. They are killing their people in large numbers and mocking your leadership. It is now time to take decisive military action — no boots on the ground — going after those who do the killing." Trump's decision could have significant implications

for India, which maintains substantial trade ties with Iran through both exports and imports. India already faces a 50 pc tariff on its exports to the United States, 25 percent of which Washington attributes to India's purchase of Russian oil, an activity the US says helps fund Moscow's war in Ukraine. India and Iran are key trade partners, with India ranking among Iran's five largest trading partners in recent years. The announcement comes as the death toll from Iran's nationwide protests has climbed to at least 646 people, according to activists US-based Human Rights Activists News Agency.

15,000 nurses go on strike at major New York City hospitals

New York, Jan 13 (Agency)



A strike by nearly 15,000 nurses at several major New York City hospitals entered its first day on Monday after talks over a new contract collapsed, triggering concern among patients and their families about ongoing care, CBS News reported. The strike began at 6 am EST on Monday at five privately run hospitals, including Mount Sinai, Mount Sinai Morningside, Mount Sinai West and NewYork-Presbyterian facilities in Manhattan. Patients' families said the absence of regular nursing staff has raised concerns about continuity and quality of care. Charlie Bravo, whose sister is currently admitted at Mount Sinai West, said the situation has made him uneasy. "They definitely need the nurses. They need to wrap this up quick," he said. "The city cannot have the nurses out here any longer than today," as reported by CBS News. Questions have also been raised about who is replacing the striking nurses. The Greater New York Hospital Association said hospitals have hired contract nurses, adjusted staff schedules, accelerated patient discharges, and rescheduled some planned procedures to manage operations during the strike.

New York Governor Kathy Hochul signed executive orders last week to ensure the state Department of Health deployed staff at the affected hospitals. However, striking nurses and some patients argue that patient care involves more than basic competence. Lin Geronimo, a nurse participating in the strike, said replacement nurses are unfamiliar with hospital-specific systems and routines. Negotiations between hospital management and the New York State Nurses Association failed to produce an agreement by Monday's deadline, despite talks continuing through the weekend. The union accused hospitals such as Montefiore, Mount Sinai, and NewYork-Presbyterian of prioritising profits over safe patient care, citing disputes over health coverage, wages, staffing levels, pensions, and workplace protections. Hospital officials described the strike as "reckless" in a joint statement. Some hospitals, including Northwell Health facilities in Nassau County, reached agreements with the union, while others withdrew strike notices. NewYork-Presbyterian officials said they had offered wage increases, improved benefits, and enhanced workplace safety, adding that "good faith bargaining requires compromise from both sides."

India eye series seal as NZ seek revival in Rajkot ODI

Sports Ministry directs NSF's to form panels to boost global sports ties

Rajkot, Jan 13 (FN Bureau)

There is something faintly familiar about the script as India and New Zealand assemble for the second one-day international at the Niranjan Shah Stadium here on Wednesday. India, efficient and unruffled, have taken a 1-0 lead in the three-match series, while New Zealand, gallant but short of the final touch, are once again searching for answers on Indian soil. The opening ODI followed a pattern that has come to define contests between these sides in recent years. New Zealand fought hard, batted with purpose and posted a competitive 300, yet India, powered by experience and composure, absorbed the pressure and chased the target down with four wickets to spare. Virat Kohli's 93 was not a blaze of strokes but a lesson in timing, judgement and restraint — a reminder that in limited-overs cricket, calm is often the most destructive weapon. India's batting depth continues

to be their greatest assurance. Shubman Gill and Shreyas Iyer provided solidity around Kohli, while KL Rahul once again played the role of the quiet finisher. Yet, beneath the victory lie questions India would prefer to answer sooner rather than later. Their bowlers, impressive in patches, allowed New Zealand to score freely in the final overs, conceding 88 runs in the last 10 — a generosity that could prove costly on flatter tracks. The venue adds an intriguing layer to the contest. Rajkot has never been entirely hospitable to India in ODIs, with the hosts losing three of the four matches played here. The pitch, red-soil and true, promises runs in abundance, as reflected in an average first-innings score exceeding 320. History suggests batting first is not merely an advantage here but almost a necessity, and the toss could once again tilt the balance before a ball is bowled. New Zealand arrive at this match nursing familiar

frustrations. Their top order laid a solid foundation in the first ODI, Devon Conway and Henry Nicholls batting with discipline and intent. Daryl Mitchell's authoritative 84



gave substance to the innings, while a late flourish ensured a round 300. What followed, however, was a story the Kiwis know too well — moments of control slipping away under sustained pressure. Kyle Jamieson stood tall with the ball, his 4 for 41 a reminder of his knack for unsettling Indian batters. But one bowler, however incisive, cannot carry an attack on a surface that rewards patience and

placement. For New Zealand to level the series, they will need collective discipline, sharper catching and a middle order willing to turn starts into statements. The weather is expected to stay out of the narrative — clear skies, warm temperatures and little wind — leaving the contest to be decided by skill and temperament alone. India, buoyed by form and familiarity, start as favourites, with an 83 per cent win probability reflecting both recent results and depth. New Zealand, written off before but rarely resigned, will look to challenge that arithmetic. Whether this match becomes a mere formality or a genuine contest depends on how long New Zealand can resist India's calm efficiency. For India, victory would seal the series at 2-0. For New Zealand, it is another examination of resolve — and an opportunity to prove that resistance, if sustained long enough, can still rewrite expectation.

New Delhi, Jan 13 (FN Representative)

The Ministry of Youth Affairs and Sports has notified all National Sports Federations (NSFs) recognised by the central government to constitute a dedicated "Committee on International Relations" within their organisations to strengthen India's engagement with the global sporting ecosystem. In an advisory issued on Tuesday, the Department of Sports said the move aligns with the recently notified Khelo Bharat Niti-2025, which outlines sports as an important instrument of international diplomacy and cooperation. The policy emphasises a multi-stakeholder approach to sports development, with greater coordination between domestic institutions and international sporting bodies. According to the ministry, the proposed committee will serve as an institutional mechanism to monitor developments within international and continental federations, including changes

in competition rules, governance structures, elections and athlete-focused programmes. NSF's have also been encouraged to formulate medium-term international cooperation plans covering bilateral and multilateral agreements, joint training camps, exchange programmes, knowledge-sharing initiatives, and the hosting of international competitions in India. The advisory underlined that all international engagements must remain consistent with Government of India policies, the Olympic Charter or relevant international federation statutes, and principles of good governance, anti-doping and athlete safeguarding. Collaboration with foreign national federations, as well as international sports research and academic institutions, has been highlighted as a key area to improve access to advanced training and sports science support for Indian athletes. NSF's have also been asked to



prepare periodic briefs for submission to the ministry, detailing proposed or ongoing collaborations with international counterparts. These briefs are expected to focus on initiatives that enhance performance pathways, including exposure to elite competitions and overseas training opportunities. In addition, federations have been directed to coordinate closely with international bodies for timely participation in bidding processes and to inform the ministry in advance of any intent to bid for hosting international events in India, as per existing guidelines. The ministry stated that the committee should comprise senior federation members, former international athletes, coaches and subject experts with experience in global sports administration and diplomacy. Details of the committee's composition and terms of reference are to be submitted to the ministry within 30 days of the advisory.

Vidarbha crush Delhi to enter Vijay Hazare Trophy SFs

Bengaluru, Jan 13 (Representative) Vidarbha's emerging star Yash Rathod led from the front as the team secured a commanding 76-run victory over Delhi in the 4th Quarter-Final of the Vijay Hazare Trophy Elite 2025-26 at the BCCI Centre of Excellence Ground 2 here on Tuesday. Opting to bat first, Vidarbha posted a formidable total of 300 for 9 in 50 overs, powered by Rathod's brilliant 86 off 73 balls, which included eight boundaries and two sixes. Atharva Taide provided solid support with 62 runs, while Dhruv Shorey added 49 to keep the scoreboard ticking. Ravikumar Samarth chipped in with 23 runs, and Yash Kadam contributed 19. Delhi's pace duo of Ishant Sharma (2/47) and Navdeep Saini (2/68), along with Prince Yadav (2/59), shared the wickets, but could not contain Vidarbha's aggressive batting. Vidarbha's bowlers then executed a disciplined and strategic plan. Medium-pacer Nachiket Bhute (4/51) exploited Delhi's middle-order weaknesses, while spinner Harsh Dubey (3/36) and fast Praful Hinge (2/54) applied consistent pressure. The visitors were eventually bowled out for 224 in 45.1 overs, handing Vidarbha a comprehensive victory. West Indies begin T20WC build-up with Afghanistan series

Barbados, Jan 13 (Reporter) Cricket West Indies (CWI) has unveiled its 16-member squad for the upcoming three-match T20 International series against Afghanistan, to be played at the Dubai International Cricket Stadium in the United Arab Emirates from January 19. With regular T20I captain Shai Hope unavailable due to commitments in the ongoing SA20 tournament, Brandon King has been appointed stand-in captain. King brings prior leadership experience, having led West Indies in T20 internationals, including the home series against South Africa in early 2024. According to the ICC, a notable inclusion is Quentin Sampson, the Breakout Player of the 2025 Caribbean Premier League, who has earned his maiden international call-up. He replaces Rovman Powell, who, along with Jason Holder and Romario Shepherd, has been rested for the series as part of the team's workload management plan. Evin Lewis and Shamar Joseph also return to the side after clearing their return-to-play protocols for injuries sustained in previous assignments. Fast bowler Alzarri Joseph, sidelined with injury towards the end of 2025, has not been selected at this stage, his progress will be monitored as part of considerations for West Indies' T20 World Cup squad. Head Coach Daren Sammy emphasised the importance of competitive cricket in subcontinental conditions as West Indies finalise their combinations and assess returning players ahead of the global showpiece. "This series presents a valuable platform to fine-tune our preparations and build confidence ahead of a competitive T20 World Cup," Sammy said.

Gold inflation stood at 68.6 per cent in December, up from 58.6 per cent in November, while silver inflation rose sharply to 97.1 per cent from 65.6 per cent. SBI Research noted that the surge in precious metals reflects strong demand from jewellery, industrial use and portfolio diversification amid rising global uncertainty and scepticism over dollar dominance. The report highlighted that the December CPI data marked the final release under the 2012 base year, with a new base year of 2024 and an updated consumption basket set to be introduced with the January 2026 data. Under the revised base, inflation is expected to rise modestly to around 2.4-2.5 per cent by March 2026, reflecting statistical changes rather than a sharp shift in underlying price pressures. On the global front, SBI Research cautioned that geopolitics has decisively shifted toward geoeconomics, with conflicts and policy uncertainty across multiple regions likely to introduce volatility in energy and commodity prices. Rising US Treasury yields, uncertainty surrounding the US Federal Reserve's leadership, and increasing fragmentation in global capital flows could create disorderly price movements, particularly for key imports. Looking ahead, SBI Research said global developments will be a key determinant of inflation trends in 2026. While weak crude prices are expected to keep fuel inflation contained in the near term, volatility in commodities, capital flows and exchange rates could test price stability. In this environment, sustained liquidity support and careful policy calibration are likely to remain central to maintaining financial stability and keeping bond yields in check.

He said the current global environment presents complex and inter-linked challenges, geo-political uncertainties, complicated economic landscapes, climate-related risks, technological changes and persistent development gaps which continue to affect countries across regions. In this context BRICS remains an important forum that encourages dialogue and cooperation and practical responses taking into account nations' priorities at different stages of development. Dr Jaishankar said the logo combines elements of tradition and modernity, and the petals incorporate the colours of all BRICS member countries, representing unity and diversity and a strong sense of shared purpose. The logo conveys the idea that BRICS draws strength from the collective contributions of its members while respecting their distinct identities, he said. India took over the rotating presidency from Brazil. Although details were not immediately available, India plans to emphasize on Global South cooperation, inclusive governance and innovation. After having successfully hosted the G20 Summit, India intends to host the presidency on a large scale, showcasing its emergence as a major global power. Ahead of the Summit, India plans to host more than 100 meetings in 60 cities throughout the year. Prime Minister Narendra Modi has suggested redefining BRICS as an acronym for "Building Resilience and Innovation for Cooperation and Sustainability". Prime Minister Narendra Modi has said earlier that "reform of institutions of global governance has been on the BRICS agenda since its inception." He also has clarified that BRICS was never meant to be against anyone or anti-western, and that it is only non-western. At the Rio BRICS Summit in July 2025, Modi announced India would give a "new form" to BRICS during its presidency in 2026. He has already proposed redefining BRICS as "Building Resilience and Innovation for Cooperation and Sustainability" and emphasized a people-centric approach. The financial architecture of BRICS constitutes the New Development Bank (NDB) and the Contingent Reserve Arrangement (CRA). The founding members of BRICS including Brazil, Russia, India, China, and South Africa initially contributed 10 billion USD each to bring the total to 50 billion USD. On January 1, 2024, four new members—Egypt, Iran, the United Arab Emirates and Ethiopia—officially entered BRICS. At the 2024 BRICS Summit in Kazan, Russia, it was decided to establish a category of BRICS partner countries. The first countries to become partners were Belarus, Bolivia, Kazakhstan, Cuba, Malaysia, Thailand, Uganda and Uzbekistan. The expanded BRICS generates 36 percent of global GDP and comprises more than 25 percent of the global economy and nearly half the world's population. As of early 2026, Saudi Arabia is frequently listed in "BRICS Plus" contexts and invited to member events. But it

has not fully formalized its membership, continuing to balance its ties between the bloc and Western allies. The bloc now consists of the following full members: Original Five: Brazil, Russia, India, China, and South Africa. 2024 Additions: Egypt, Ethiopia, Iran, and the United Arab Emirates. 2025 Addition: Indonesia. Saudi Arabia remains in a transitional or "pending formalization" status despite participating in bloc activities.

The Bench clarified that the order was passed keeping in view Articles 14, 21, and 41 of the Constitution, and also in exercise of the Supreme Court's powers under Article 142. The Court also appreciated the assistance of Advocate Vivek Narayan Sharma, appearing for Coal India Limited, for helping resolve the matter, and thanked the doctors who examined the appellant. After pronouncing the judgment, Justice Pardiwala wished Sujata Bora well and encouraged her to make the country proud. The case arose after Sujata Bora applied for the post of Management Trainee (Personnel and HR) as a reserved candidate in the visually handicapped category. Though she cleared the interview stage, medical examination revealed that she had 60 percent low vision in both eyes along with residual partial hemiparesis. She was denied relief by the Calcutta High Court, following which she approached the Supreme Court. During the proceedings, Coal India argued that the appellant did not meet the benchmark disability requirement under the RPwD Act.

SC hears Abu Salem’s plea for premature release

The Supreme Court on Tuesday sought an explanation from 1993 Mumbai serial blasts convict Abu Salem on his claim that he has already completed 25 years of imprisonment, while hearing his plea seeking premature release. A bench comprising Justice Vikram Nath and Justice Sandeep Mehta asked Salem to justify the computation of his jail term and directed him to place on record the relevant Maharashtra state rules to ascertain whether remission is permissible for a convict sentenced under the Terrorist and Disruptive Activities (Prevention) Act (TADA). Questioning the claim, the bench asked Salem’s counsel, “How do you calculate 25 years from 2005?” after it was submitted that Salem had completed the maximum period of

incarceration as per the assurances given during his extradition from Portugal. Abu Salem was extradited from Portugal on November 11, 2005, following a prolonged legal process, after India assured Portuguese authorities that he would neither be awarded the death penalty nor be imprisoned beyond 25 years, in line with Portugal’s domestic law and international obligations. Salem was subsequently convicted in June 2017 and sentenced to life imprisonment by a special TADA court in the 1993 Mumbai serial blasts case. Earlier, Salem had approached the Bombay High Court seeking premature release under the extradition assurances, while clarifying that he had not yet completed the 25 years stipulated by the Supreme Court in accordance

with international commitments. In its landmark judgment in Abu Salem v. State of Maharashtra (2022), the Supreme Court held that Salem’s incarceration shall not exceed 25 years, to be counted from the date of



his extradition to India on November 11, 2005. A bench comprising Justice Sanjay Kishan Kaul and Justice MM Sundresh of the Supreme Court had ruled that the union of India is bound

to release Salem upon completion of 25 years in custody to honour the assurance given to Portugal. The court had further directed that the Central government should advise the President of India to exercise powers under Article 72 of the Constitution upon completion of the said period. The 2022 ruling came in a plea filed by Salem challenging the life sentence awarded to him on the grounds that his imprisonment could not extend beyond 25 years due to the assurances furnished during extradition. Advocate Rishi Malhotra, appearing for Salem, had argued that under Portuguese law, life imprisonment or incarceration beyond 25 years is unconstitutional, and therefore the assurance given by India was binding. Salem was arrested in

Portugal on September 18, 2002, along with actor Monika Bedi. Extradition was granted in relation to the Pradeep Jain murder case, the 1993 Bombay bomb blasts case, and the Ajit Diwani murder case. Upon his arrival in India on November 11, 2005, Salem was arrested by the CBI in the bomb blasts case and later taken into custody by the Mumbai Anti-Terrorist Squad in the Pradeep Jain murder. In June 2017, a Special TADA Court found Abu Salem and five others guilty of conspiring in and executing a series of bomb blasts across Mumbai in 1993 that claimed 257 lives. Salem was convicted under various provisions of the Indian Penal Code, TADA, the Arms Act, the Explosive Substances Act, and the Prevention of Damage to Public Property Act. The matter remains under consideration before the Supreme Court.

RBI DG calls for agile, risk-based regulation in digital era

The Reserve Bank of India (RBI) Deputy Governor, Shirish Chandra Murmu, highlighted the rapid transformation of the financial ecosystem driven by digitalisation, and said regulators must adopt agile, forward-looking, and risk-based approaches to safeguard financial stability while enabling innovation. Delivering a special address at the third Annual Global Conference of the College of Supervisors in Mumbai, Murmu noted that while digitalisation has improved efficiency, transparency, competition, and access to financial services, it has also introduced new and complex risks that can spread rapidly across interconnected systems. He cautioned that machine-speed transactions, automated decision-making, and always-on digital services have compressed response times for regulators, increasing the potential for operational failures, cyber incidents, fraud, and sudden loss of confidence. According to him, traditional regulatory frameworks built around periodic reporting and post-facto action must evolve towards proactive detection and timely intervention without compromising regulatory judgement.

RBI DG pointed out that digital finance has blurred regulatory boundaries, with financial services increasingly being delivered through non-financial platforms involving both regulated and unregulated entities. This fragmentation, he said, often leaves no single authority with a complete view of risks across the activity chain, increasing the scope for regulatory arbitrage domestically and across borders. On the nature of regulation, the Deputy Governor observed that overly prescriptive rules risk becoming obsolete as technology evolves, while purely principle-based regulation can lead to uneven application if governance is weak. He advocated a balanced approach combining clarity with flexibility, supported by strong supervision and enforcement. Addressing financial stability concerns, Murmu flagged emerging systemic risks from increased reliance on cloud services, algorithms, and third-party technology providers. He stressed that accountability for technological outcomes must remain firmly with regulated entities, even when operations are outsourced or automated. He also highlighted cyber threats, data integrity issues, and the rapid spread of misinformation as growing challenges in the digital age, underscoring the need for strong operational resilience and clear regulatory communication to maintain public trust. At the same time, the RBI DG said digitalisation offers regulators powerful tools to enhance supervision. He cited RBI initiatives such as MuleHunter.ai for detecting mule accounts, the PRAVAAH portal for digital regulatory services, and DAKSH, an end-to-end supervisory workflow system, as examples of how technology can improve risk monitoring while reducing compliance burden.

Artificial Intelligence an asset to media but not a substitute

At the ongoing World Book Fair 2026 in New Delhi, the Abu Dhabi-based Muslim Elders Council organised a panel discussion on "AI for Humanity: Religious Perspectives on Ethical AI", chaired by former ambassador Dr. Zikrur Rehman, former Indian Ambassador to the Palestinian Authority and Consul General in Riyadh. Sanjay Kapoor, veteran journalist and president of the Editors Guild of India, said that reporting is a profession with far greater power than Artificial Intelligence (AI). However, he cautioned, most news organisations today are now spending less on reporting and becoming increasingly dependent on the internet. Quoting Elon Musk, Kapoor noted that in the future, jobs like plumbing may be safe, but journalism, especially roles limited to questioning, could be at risk. Kapoor added that, in fact, by doing so, the reporter is inadvertently strengthening AI. Kapoor also warned about the dangers of AI and said that the media community in India is not fully aware of the dangers of AI. For example, ChatGPT, despite being two years old, can write better than a regular journalist. He cautioned that if journalism fails to preserve emotional depth, on-the-ground reporting, and human experience, AI could replace journalists without the public even realising it when and how it happened. Kapoor stressed that there exists a dire need for regulation and oversight to control AI and unless developers and institutions take ethics and journalistic values seriously, misinformation will continue to spread. Dr. Mudassar Qamar, Assistant Professor at Jawaharlal Nehru University, discussed AI’s evolving role in academics, calling it both a significant achievement and a cause for concern. Today, there are AI tools that do everything from reference lists, literature reviews, and grammar checking, etc. Some students have become completely dependent on AI, which makes research dehumanised and uncreative, but it also offers positive aspects, such as supporting students with language difficulties. Dr. Qamar emphasised that both teachers and students need to strike a balance between caution and responsible use of AI.

Delhi Police nabs hundreds of criminals in 48-hr “Operation Gang Bust”

Delhi Police apprehended hundreds of criminals linked to multiple crime networks across the national capital. The two-day “Operation Gang Bust” was carried out across various districts of Delhi, aimed at dismantling active criminal networks and gangs involved in multiple illegal activities, as well as curbing incidents that endangered the public due to the presence of such gangs. Teams from different units of the law enforcement agency of the national capital conducted searches and raids as well as closely monitored by the senior officials. During the operation, several proclaimed offenders and wanted criminals were apprehended, and their hideouts were raided. The exercise not only led to arrests of criminals but also uncovered important information about the linkages between criminals and their networks. Special units of the Delhi Police were also involved to ensure a significant impact on organised crime syndicates. The operation also made it very clear that the Delhi Police maintains zero tolerance against crimes, emphasizing on crimes against women, children and various other serious offences, also including narcotics and others.

Atishi video FIR: Speaker gives Punjab cops 3 days to reply, rejects extension

The Delhi Assembly Secretariat on Tuesday directed Punjab Police to submit its response by January 15 in connection with an FIR registered in Jalandhar about a video clip allegedly involving Atishi, leader of Opposition in the Assembly. Speaker Vijender Gupta said the events began on January 6, when the leader of Opposition did not attend the House, leading to repeated disruptions and the Assembly being unable to function for three consecutive days. He said the disputed video was sent to the Forensic Science Laboratory (FSL) for examination on January 8, while an FIR was registered by the Punjab Police in a dramatic manner on January 9. The Speaker alleged that the Punjab Police attempted to influence the Assembly’s ongoing inquiry and intervened under political pressure even before the Privileges Committee could arrive at any decision, creating confusion in the process. He said a notice was subsequently issued to the Punjab Police. Gupta expressed surprise that while the Punjab Police completed



the FSL examination and registered an FIR within hours, it later sought an extension of 10 days to submit its reply, raising questions over the impartiality of the police. He said considering the circumstances, the Assembly found the request for 10 days inappropriate and granted only three days’ time, directing the Punjab Police to submit a factual report by January 15 to enable further action. According to an official communication issued by the Delhi Assembly Secretariat on January 12, the matter relates to an FIR registered under the Jalandhar Police Commissionerate concerning a video clip of Atishi. The Secretariat stated that a request from the Punjab Police seeking additional time to submit its reply was placed before the Speaker of the Delhi Assembly. The letter, addressed to the Special Director General of Police, State Cyber Crime, Punjab, Mohali, said that considering the seriousness of the issue, the Speaker has directed that the reply must be submitted on or before January 15. Earlier, the Office of the Director General of Police, Punjab, in a communication dated January 12, sought an extension of 10 days to apprise the Speaker of the Delhi Assembly about the factual position of the case. The Punjab Police stated that the additional time was required in the interest of justice.

SC delivers split verdict on Section 17A of prevention of corruption Act

The Supreme Court on Tuesday delivered a split verdict on the constitutional validity of Section 17A of the Prevention of Corruption Act, which requires prior government approval before starting an investigation against a public servant for decisions taken in official duty. A two-judge Bench comprising Justice B.V. Nagarathna and Justice K.V. Viswanathan differed in their views on the provision, which was inserted through the 2018 amendment to the Act. Due to the difference of opinion, the matter has been referred to the Chief Justice of India for constituting an appropriate Bench to finally decide the issue. Justice Nagarathna held that

Section 17A is unconstitutional and should be struck down. She observed that the provision tends to shield corrupt officials instead of protecting honest officers. According to her, the requirement of prior approval blocks inquiry at the very beginning and goes against the purpose of the anti-corruption law. She noted that similar protections had earlier been struck down by the Supreme Court in the Vineet Narain and Subramanian Swamy cases, and Section 17A was an attempt to revive those invalid provisions. On the other hand, Justice K.V. Viswanathan upheld the validity of Section 17A but gave it a limited interpretation. He ruled that the decision on granting sanction should not rest with the government or the executive, but must be taken by an

independent body such as the Lokpal at the Centre or the Lokayukta in the States. To this extent, he “read down” the provision. Justice Viswanathan observed that striking down the law entirely could expose honest public servants to frivolous and malicious complaints, leading to policy paralysis. He said a balance must be maintained between protecting honest decision-making and ensuring accountability in public office. He added that the possibility of misuse is not, by itself, a valid reason to invalidate a law. The judgment arose from a writ petition filed by the Centre for Public Interest Litigation (CPIL), which challenged

the constitutional validity of the 2018 amendments to the Prevention of



Corruption Act, particularly Section 17A. The judgment had been reserved on August 6, 2025. Section 17A bars any police officer from initiating an enquiry, inquiry, or investigation

against a public servant for actions taken in discharge of official duties without prior approval from the competent authority of the Central or State Government. An exception is made in cases where a public servant is caught red-handed while accepting a bribe. The provision also requires the authority to decide on approval within three months, extendable by one more month with reasons. Advocate Prashant Bhushan, appearing for the petitioner, argued that the provision reintroduced executive control over investigations, which had already been declared unconstitutional by the Supreme Court in earlier

rulings. He contended that allowing the executive to decide whether an investigation should begin creates a clear conflict of interest, especially when ministers themselves may be involved in the decisions under scrutiny. Representing the union government, Solicitor General Tushar Mehta defended the provision, stating that earlier judgments did not prohibit all forms of prior approval. He argued that Section 17A is narrowly framed to protect bona fide official decisions and prevent harassment of honest officers through baseless complaints. He maintained that safeguards are necessary to ensure fearless and effective governance. With the split verdict, the final word on the validity of Section 17A will now be decided by a larger Bench of the Supreme Court.
