Fin Min. inter-departmental committee reviews expansion proposals for foreign and Indian banks



New Delhi, Nov 20 (FN Representative)

Secretary of the Department of Financial Services (DFS), Ministry of Finance, M Nagaraju, chaired a crucial meeting of the Inter-Departmental Committee (IDC) on Thursday, focusing on proposals related to the expansion and relocation of foreign and Indian bank branches. The Ministry of Finance issued a statement outlining the key discussions and decisions. The IDC, comprising representatives from key ministries including the Ministry of Home Affairs (MHA), Ministry of External Affairs (MEA), Department of Commerce (DoC), and the Reserve Bank of India (RBI), reviewed applications from foreign banks seeking to establish new branches, representative offices, and subsidiaries in India.

Simultaneously, the committee evaluated proposals from Indian banks aiming to expand their overseas footprint through similar structures. Additionally, the committee examined requests from foreign banks for relocating their existing branches within India. After thorough deliberations, the IDC recommended the proposals under consideration, signaling a positive step toward enhancing banking connectivity and cooperation. Operating under the Department of Financial Services, the IDC serves as the nodal authority for appraising expansion requests from both foreign and domestic banks. Its consultative process with multiple ministries ensures that decisions are made through a comprehensive, consensus-driven approach that balances economic, security, and diplomatic considerations. This meeting reflects the government's commitment to fostering a robust, globally integrated banking sector while maintaining regulatory oversight and safeguarding national interests.

G20 Summit to see focus on Global South, PM Modi to hold key bilateral meetings on sidelines

New Delhi, Nov 20 (Reporter)

India said on Thursday that it is looking forward to a Lsuccessful and productive G20 summit in Johannesburg that will see continued focus on the Global South, as Prime Minister Narendra Modi embarks tomorrow on a three-day visit to South Africa. Secretary (ER) at the Ministry of External Affairs, Sudhakar Dalela, briefing reporters ahead of PM Modi's November 2123 visit, said the prime minister will be holding several important bilateral meetings on the sidelines of the summit. "The summit will be important for India to ensure continuity of its priorities in the G20 after having hosted a very successful presidency in 2023," he said. Pointing out that it is for the first time that a G20 summit is happening in Africa, Secretary Dalela said, that it was under India's G20 presidency in 2023, that the African union was included in the grouping.

"Under their overall presidency on the theme of solidarity, equality



and sustainability, South Africa has identified four key priority areas for the G20 presidency strengthened disaster resilience and response, debt sustainability low-income countries. mobilising finance for just energy transition, and harnessing critical minerals for inclusive growth and sustainable development," the Secretary said. He pointed out that the priorities identified by South Africa are aligned with those of India's G20 presidency and that of Brazil's last year, "ensuring continuity in the G20 discussions from the perspective of matters that are important to the Global South". At the Summit, Prime Minister Modi will put forth India's perspectives on the G20 agenda. He is expected to speak in all the three sessions of the Summit. These sessions are on: i. Inclusive and Sustainable Economic Growth Leaving No One Behind: Building our economies; the role of trade; financing for development and the debt burden ii. A Resilient World – the G20's Contribution: Disaster Risk Reduction; Climate Change; Just Energy Transitions; Food Systems iii. A Fair and a Just Future for All: Critical Minerals; Decent ▶ Cont. to Page-7

Strong growth in imports, sluggish exports led to widening of India's merchandise trade deficit

New Delhi, Nov 20 (FN Bureau)

India's merchandise exports fell 11.8 percent on-year which is the steepest since August 2024, said a report released by CRISIL on Wednesday. It followed a 50pc increase in US tariffs effective from Aug 27, a move which has subdued exports for the second month in a row. Credit Rating Information Services of India Limited (CRISIL) said that on-year decline in exports was broad-based across petroleum products, gems, jewellery and core sectors. "Petroleum products exports declined 10.4pc year-on-year in October, compared with a growth of 15.1pc in September.



Similarly, core exports fell 10.2pc compared with 6.1pc growth in September. The gems and jewellery sector was hit the hardest, while exports plummeting 29.5pc year-onyear, the biggest decline since July 2023, compared with 0.4pc growth in September," CRISIL said. The rating agency said that merchandise exports to the US decreased 8.6pc year-on-year to USD 6.3 billion in October, but this was an improvement from the 11.9pc decline in September. A potential silver lining is the proposed US-India trade agreement, which could alleviate some of the pressure on exports. CRISIL said that India's merchandise exports face headwinds this fiscal from the hike in US tariffs and ▶ Cont. to Page-7

■ Delhi's air quality hovers near 'severe' for second straight day

New Delhi, Nov 20 (Representative) The city's air quality hovered near the severe category on Thursday, with the 24-hour average Air Quality Index (AQI) at 391, showing no improvement from the previous day, according to the Central Pollution Control Board (CPCB). On Wednesday, the AQI was 392 at 4 pm and remained at similar levels through the day due to calm winds. According to CPCB, an AQI between 0 and 50 is considered 'good', while 51 to 100 is 'satisfactory'. The levels climb from 'moderate' (101-200) to 'poor' (201-300), before entering the 'very poor' band (301-400). Any reading from 401 to 500 is classified as 'severe', where prolonged exposure can cause respiratory illness even in healthy individuals. Air quality monitors across the city painted an even grimmer picture. Eighteen of the 39 monitoring ▶ Cont. to Page-7

The revitalised partnership will unlock new opportunities for bilateral trade and investment to thrive, strengthen our defence cooperation to keep our people safe, and nurture the next generation of global talent. ■ CAs need not have 25 years' experience for Tribunal posts, rules SC

New Delhi, Nov 20 (FN Reporter) The Supreme Court today clarified that Chartered Accountants (CAs) are not required to have a minimum of 25 years' experience to be eligible for appointment as technical members in tribunals such as the Income Tax Appellate Tribunal (ITAT). The Bench, comprising Chief Justice of India BR Gavai and Justice K Vinod Chandran, directed that the union Government must keep this clarification in mind while drafting fresh legislation to replace the Tribunal Reforms Act, 2021, which was struck down on November 19. The Court extended to CAs the same parity it had granted to advocates in its November 19 judgment striking down the Tribunal Reforms Act, 2021. The clarification was made after the counsel for the Institute of Chartered Accountants of India (ICAI) raised the matter > Cont. to Page-7

■ Putin's visit to India to unveil "substantial package

of ambitious decisions": Russian Envoy

New Delhi, Nov 20 (Reporter) Ahead of Russian President Vladimir Putin's expected visit to New Delhi later this year, Russian Ambassador to India Denis Alipov said that trade and economic cooperation between the two countries continues to strengthen, reaffirming that bilateral engagement remains resilient despite global geopolitical headwinds. Alipov revealed that a "substantial package of ambitious decisions" is being prepared for President Putin's visit in December for the annual bilateral summit, which coincides with the 25th anniversary of the Russia-India strategic partnership and the 15th anniversary of its elevation to a "special and privileged" status. The new agreements are expected to cover defence cooperation, nuclear energy, energy security, science, education, and emerging areas of collaboration. ▶ Cont. to Page-7

■ ED introduces QR code verification to combat fake summons fraud

New Delhi, Nov 20 (FN Representative) In response to rising reports of fake summons being circulated in the name of the Enforcement Directorate (ED) for cheating and extortion, the ED has implemented new measures to help citizens verify the authenticity of summons notices, the Finance Ministry's official account announced today. Fake ED summons closely mimic genuine notices, making it challenging for recipients to distinguish between legitimate communication and fraudulent attempts. To tackle this growing menace, the ED now issues systemgenerated summons embedded with a QR code and a unique passcode. "Summons issued by the Enforcement Directorate can be verified by scanning the QR code printed on them or by visiting the official ED website, the Ministry of Finance stated. > Cont. to Page-7

State Governors cannot indefinitely sit on Bills: SC

New Delhi, Nov 20 (Bureau)

n a significant constitutional pronouncement, the Supreme Court on Thursday held that State Governors cannot indefinitely sit on Bills passed by State Legislatures. However, the Court also made it clear that it cannot prescribe mandatory timelines for the President or Governors to grant or deny assent under Articles 200 and 201 of the Constitution. However, it clarified that Governors cannot indefinitely sit on Bills. In cases of prolonged, unexplained inaction, courts may issue a limited mandamus directing them to decide within a reasonable time without examining the merits of the Bill.

The Court categorically ruled that the concept of courts declaring "deemed assent" in cases of delay is unconstitutional and violates the doctrine of separation of powers.



that judicially imposed deadlines

would be contrary to the "elasticity" envisaged in the constitutional scheme. The reference was made in May, soon after the Supreme Court's judgment in the Tamil

Nadu Governor case, which had laid down timelines for constitutional authorities to act on Bills. The Bench heard arguments over ten days and had reserved its opinion on September 11.

The key questions and the Supreme Court's answers before a Governor under Article 200? The Governor may assent to

1. Constitutional options the Bill, withhold assent (which must necessarily be accompanied by returning the Bill to the Assembly), or reserve the Bill for the President. Withholding assent without returning the Bill is impermissible and violates federalism. 2. Is the Governor bound by the aid & advice of the Council of Ministers under Article 200? The Governor ordinarily acts on aid and advice, but Article 200 confers limited constitutional discretion particularly in returning or reserving a Bill. 3. Is the Governor's discretion justiciable? Merits of the decision are not justiciable. However, prolonged, unexplained inaction may invite a limited judicial direction to decide. 4. Does Article 361 bar judicial review? The Governor enjoys personal immunity, but the office of the Governor remains subject to limited ▶ Cont. to Page-7

Earth Summit begins in Hyderabad, focus on rural innovation, digital infra

Hyderabad, Nov 20 (Representative)

The first edition of the two-day Earth Summit 2025, organised by NABARD and the Internet and Mobile Association of India (IAMAI), began at Hitex Exhibition Centre, Madhapur, here on Thursday with a focus on 'Empowering Rural Innovation for Global Change'. Speaking at the inaugural session as chief guest, Telangana Deputy Chief Minister Bhatti Vikramarka Mallu said it was significant that the national initiative was being launched in Hyderabad and projected Telangana as "living proof" that rural transformation is possible when innovation meets intention. He highlighted the state government's farmer-centric measures, including one of the country's largest loan waivers of about Rs 20,000-21,000 crore, the Rythu Bharosa income support scheme of Rs 12,000 per acre annually, procurement of

paddy through self-help groups with prompt payment, and an additional bonus of Rs 500 per quintal over MSP. He also underlined investments in irrigation, digital crop records, post-harvest systems, and a 43,000-km digital backbone connecting nearly every gram panchayat, as well as a thrust on renewable energy and womensolar entrepreneurship. The Deputy Chief Minister said agriculture is not just an economic sector but the very soul of India. He stressed that institutions like NABARD play a crucial role in protecting and strengthening this foundation. He called for moving forward with compassion, courage and confidence, noting that India's best days lie ahead. He added that the present government, under the leadership of Chief Minister Revanth Reddy, will



complete two years in office at the end of this month. On December 8 and 9, the government will host a summit at 'Future City', a visionary project aimed at showcasing Telangana's long-term development goals.

He urged people to participate in the event, which will feature a comprehensive visual presentation of the state's progress and aspirations. NABARD Chairman K V Shaji in his address said the summit aims to build a national platform for problem-solving, innovation and institution-building in rural India. Stressing that villages must now become "engines of growth", he said India is moving from subsidy-driven to solutiondriven development, from isolated schemes to integrated digital public infrastructure. He outlined NABARD's work on a rural digital public infrastructure

stack, including agronomy DPI, geospatial agriculture, digital credit highways, digitisation of Kisan Credit Cards and cooperatives, climateresilient agriculture, and a new 'Rural Finance 2.0' architecture to reduce risk and turnaround time while improving access to credit. Shaji said over 75 exhibits and around 50 startups are showcasing innovations "from soil to satellite" at the summit, with multi-track sessions on digital public infrastructure, geospatial intelligence, climate action, cooperatives, rural enterprises and agri-fintech. He emphasised that the future of India will be shaped in its villages, powered by digital infrastructure, climate resilience, cooperative institutions and youth and women leadership. Telangana Agriculture Minister Tummala Nageswara Rao, NABARD Deputy Managing Director Goverdhan Singh Rawat, IAMAI President Dr Subbo Rao and other dignitaries also took part in the inaugural programme.

CM Yogi approves 95 new projects to strengthen canal network

Minister Yogi Adityanath on Wednesday approved 95 new projects aimed at further strengthening the state's canal system during a comprehensive review meeting of the Irrigation and Water Resources Department here on Wednesday. He said these projects would significantly boost the agricultural sector by ensuring timely and reliable irrigation for farmers. Once completed, the projects, worth Rs39,453.39 lakh, will restore irrigation capacity across 36,000 hectares, directly benefiting nearly 9 lakh farmers and rural communities. In addition, 273 hectares of departmental land will be safeguarded. The Chief Minister instructed officials to complete all sanctioned works within the stipulated timeframe, emphasizing that there must be no compromise on quality. Officials informed in the meeting that the 95 canal restoration projects include closing gaps in the canal network, construction of head and cross regulators, siphons, falls, and other concrete structures. The projects also encompass improvements to internal and external canal sections, lining and filling of reaches, reconstruction of damaged culverts, construction and repair of bridges and culverts along canal tracks, and installation of kerbs on canal routes.

Renovation of inspection structures, buildings, office and watermills, as well as the construction of boundary walls to protect departmental land, are also planned. These interventions will significantly enhance the irrigation network's capacity and ensure an uninterrupted water supply across various regions. Farmers in Purvanchal, Terai, Bundelkhand, and Western Uttar Pradesh are expected to benefit the most. The Chief Minister noted that the vision behind these projects extends beyond physical construction. Their broader aim is to improve water management. promote farmer welfare, increase agricultural productivity, and strengthen the rural economy. He reaffirmed the government's commitment to ensuring that no farmer in the state faces irrigation shortages. During the meeting, the Chief Minister also directed the department to survey unused land and prepare a detailed plan for its optimal utilization. Effective use of such land, he said, will help generate additional departmental revenue. Reviewing flood management efforts, the Chief Minister instructed officials to begin preparations in January, keeping in view the requirements of the coming year. He called for a detailed action plan to be prepared in consultation with public representatives to ensure timely and effective implementation.

Delhi-NCR leads India's rental market amid cooling national momentum

elhi-NCR has cemented its position as the strongest performer in India's rental housing market, even as the broader national market shows clear signs of cooling after three consecutive quarters of heightened activity. According to the Magicbricks' Rental Index for the July-September 2025 (JAS '25) quarter reports, Greater Noida led the country with a striking 29.5pc quarter-on-quarter (QoQ) surge in rental demand, followed by Delhi at 17.8pc and Noida at 10.8pc. This sharp rise comes at a time when nationwide rental demand grew only 0.2pc QoQ and 0.4pc year-on-year (YoY), while supply increased 0.6pc QoQ and 5.9pc YoY, indicating a gradual rebalancing of the market. Despite the moderation in overall activity, rents continued to rise across India. Average rents climbed 4.4pc QoQ and a substantial 18.1pc YoY, reflecting sustained demand for mid-sized, well-connected homes. Thane posted the steepest rise in rents at 12.5pc QoQ, while Chennai (6.7pc), Mumbai (4.9pc) and Delhi (4.5pc) also recorded notable increases. Delhi's strong performance was further supported by a robust 17.6pc QoQ jump in supply, the highest among major markets. Speaking on the report, Magicbricks CMO Prasun Kumar said the contrasting national and NCR trends point to a market gradually returning to equilibrium. He noted that infrastructure upgrades, improved connectivity, and a steady flow of mid-sized homes continue to power NCR's momentum, even as most other markets witness moderate rent growth. The stabilisation in rents, he added, reflects a healthier balance between supply and demand. Tenant preferences across the country remained largely consistent during the quarter. Two-bedroom homes (2BHKs) accounted for 44pc of demand, followed by 1BHKs at 32pc. Semifurnished units continued to dominate both demand (51pc) and supply (54pc). Homes sized between 500 and 1,500 sq. ft. drew the most interest, capturing 77pc of tenant activity. These patterns align strongly with NCR's growing mid-income housing supply, particularly in fast-developing hubs such as Greater Noida and Noida Extension.

Swadeshi drone technique to be developed

Collector Prithwish Dasgupta Wins Vermeil Award at Bongopex 2025 for Extraordinary Netaji & Azad Hind Collection

elebrated Netaji and Azad Hind collector Prithwish Dasgupta has been awarded the prestigious Vermeil Award at the 10th Philatelic Exhibition Bongopex-2025, organised by the West Bengal Circle of the Department of Posts. The exhibition, held at Science City from 14 to 17 November, brought together philatelists from across West Bengal, Sikkim and the Andaman & Nicobar Islands. Dasgupta, known nationally for his unparalleled research on Netaji Subhas Chandra Bose and the Indian National Army (INA), impressed jurors with his rare and historically invaluable exhibit. With over twenty-five years of collecting experience, he presented one of the most comprehensive displays of Netaji's life, ÎNA's military history and the material culture of Azad Hind. Handwritten Netaji Letters Draw CrowdsOne of the most striking components of Dasgupta's awardwinning entry was a collection of handwritten letters authored by Netaji Subhas Chandra Bose between 1936 and 1939, during his period of British-imposed house arrest. Many

of these letters carried the official markings "Censored & Passed by the British Police", offering a direct glimpse into the surveillance and restrictions placed on Netaji by the colonial administration. Philatelists, historians and visitors described these letters as "living pieces of India's freedom struggle," and they formed an emotional centrepiece of the display. INA Medals Manufactured in Vienna: A Rare HighlightA major attraction at Bongopex 2025 was Dasgupta's extraordinary collection of military decorations issued by the Provisional Government of Azad Hind. These medals were manufactured during World War II by Rudolf Souval, a renowned Vienna-based maker of German military decorations. Therefore each medal bears the embossed mark "RUDOLF SOUVAL" on the reverse. Dasgupta's collection includes almost every known variety of INA medals, such as the Sher-e-Hind (Grand Star), the highest military decoration conceived by Azad Hind; the Sardare-Jung (1st Class Star), regarded as the second-highest honour; the

the Shahid-e-Bharat Bronze, often compared to the modern Param Vir Chakra; and the Tamgha-e-Azadi and Tamgha-e-Bahadur, issued in gold, silver and bronze grades. Each

Collectors described Dasgupta's display as one of the finest ever presented in India, especially since it

issued in territories influenced by Netaji's movement. A highlight for military-history enthusiasts was a hand-embroidered "Freies Indien" Jumping Tiger shoulder patch, once worn by INA officers. The patch is considered one of the rarest artefacts linked to INA uniforms and is seldom seen in the Indian philatelic circuit. Dasgupta further displayed multiple covers sent to INA families in India from Rangoon, Malaya, Singapore and Burma after Independence, many adorned with hand-drawn portraits of Netaji. Experts remarked that this unique combination of postal history and patriotic art elevated the exhibit to museum-level significance. Post-Independence Memorabilia & Global Tributes to NetajiThe exhibit extended beyond wartime material and included First Day Covers, Special Covers, commemorative postcards and stamps issued in India after Independence, celebrating Netaji and the INA. Dasgupta also showcased global philatelic releases honouring Bose from countries across Europe and Asia, alongside rare INA currency used in Japanese-occupied

Burma. Complementing the philatelic items was a curated selection of vintage matchboxes featuring Netaji's image, precious research publications by INA veterans, and badges and tokens issued by Netaji-inspired organisations in the decades following Independence. Collector Speaks on Preserving Netaji's LegacySpeaking after receiving the Vermeil Award, Prithwish Dasgupta said that documenting Netaji's journey and the INA's sacrifices remains his life's mission. "Any item connected with Netaji Subhas Chandra Bose or the INA is precious and worthy of preservation. Collecting and conserving these materials is my way of honouring India's freedom struggle," he said. With the honour at Bongopex 2025, Dasgupta has been widely acknowledged as one of India's foremost Netaji collectors and among the rare experts preserving the legacy of Azad Hind through authentic archival material. His work continues to contribute to historical research, public exhibitions and a deeper national understanding of one of India's most inspiring chapters.

Bihar sees history: Nitish Kumar sworn in as CM for 10th time

Patna, Nov 20 (Representative)

Tanata Dal (United) (ID(U)) chief Nitish Kumar on Thursday took oath as Bihar Chief Minister for a record 10th time, in a grand ceremony at Patna's historic Gandhi Maidan. Prime Minister Narendra Modi and several prominent leaders of the National Democratic Alliance (NDA) attended the event. Gandhi Maidan, which has previously Nitish Kumar's oath ceremonies in 2005, 2010, and 2015, is also historically significant as the site where Jayaprakash Narayan called for a "total revolution" in 1974. Chief Ministers from NDAruled states, including Haryana's Singh Saini, Assam's Himanta Biswa Sarma, Nagaland's Neiphiu Rio, Andhra Pradesh's N. Chandrababu Naidu, Uttar Pradesh's Yogi Adityanath, and Uttarakhand's Pushkar Singh Dhami, were present, along with Bihar Governor Arif Mohammad Khan and LJP (RV) chief Chirag Paswan were also present in the event. On Wednesday, Nitish Kumar

unanimously elected as the leader of the JD(U) Legislature Party during a meeting with newly elected MLAs at his official residence in Patna. He was also elected as the leader of the NDA Legislature Party ahead of forming the new government. During the BJP Legislature Party meeting, Samrat Choudhary and Vijay Kumar Sinha were elected as leader and deputy leader, respectively, with the proposal put forward by Uttar Pradesh Deputy



Chief Minister Keshav Prasad Maurya, who served as the central observer.

The 2025 Bihar Assembly elections, considered a litmus test for Nitish Kumar, saw the NDA secure a historic

landslide victory, winning 202 of the 243 seats. The alliance secured a commanding three-fourths majority in the state assembly, marking the second time the NDA crossed the 200-seat threshold (the first being in 2010 with 206 seats). Within the NDA, the BJP won 89 seats, JD(U) 85, LJP (RV) 19, Hindustani Awam Morcha (Secular) five, and Rashtriya Lok Morcha four seats. Among the opposition, Rashtriya Janata Dal (RJD) won 25 seats, Indian National

Congress six, CPI(ML)(L) two,

Indian Inclusive Party one, and

CPI(M) one seat. All India Majlis-E-Ittehadul Muslimeen (AIMÍM) secured five seats, and the Bahujan Samaj Party (BSP) won one. The Bihar elections were held in two phases on November 6 and 11. The state recorded a historic voter turnout of 67.13 percent, the highest since 1951, with women voters (71.6 percent) outpacing men (62.8 percent). Nitish Kumar, has served as Bihar Chief Minister since November 2005, with a brief nine-month gap in 2014-15, and continues to play a central role in shaping Bihar's political landscape.



cientists from Physical Research Laboratory (PRL) Observed the interstellar comet 3I/ATLAS currently on its way out of the inner Solar system after perihelion passage. These observations were made during November 12 to 15. Observations were carried out in imaging and spectroscopic (analysis of the constituent wavelengths of the light emitted) modes with PRL's 1.2m telescope. The images show a near-circular coma, ISRO said in an update. The coma of a comet is the large, glowing atmosphere of gas and dust that forms around its nucleus as it gets closer to the Sun. It is created when the Sun's heat causes the frozen ices on the nucleus to vaporize or "sublimate," releasing gas and dust that form a large, diffuse cloud. In the present observing geometry, the dust tail, if present, would be pointing away from the Sun behind the comet as seen from the Earth, while deep wide field multiband images may show the ion tail. Apart from imaging, scientists also acquired a spectrum of the light from the comet, before the start of morning twilight.

The result shows prominent emission features commonly seen in Solar system comets the CN, C2 and C3 bands in the shorter wavelength side of the spectrum. In the terminology of comet, the rate of release (or sublimation) of gas from the nucleus into the coma is referred to as the 'production rate', which is a measure of the comet's activity level. The production varies significantly throughout the comet's orbit and is driven by factors like distance from the sun and the comet's internal composition. In case of 3I/ATLAS, the production rates for the prominent bands (emissions pertaining to the constituent molecules) were computed with limiting values around 1025 molecules/sec. The production rate ratios seem to place this comet in the class of 'typical comets' of the solar system. Further observations will be continued as the comet gradually comes into the darker part of the night. The Physical Research Laboratory (PRL) 1.2 m telescope at Mount Abu, located at an altitude of 1,680 m near Gurushikhar, is a groundbased observatory that is used astronomical research, including exoplanet hunting, high-energy phenomena, and solar system studies.

Centre must take responsibility for cotton procurement, says Farmers' Commission Chairman




Hyderabad, Nov 20 (Agency) Commission Chairman Kodanda Reddy tonday strongly criticised the union government for what he described as its failure to take responsibility for cotton procurement in the state. In a statement here, he said that it is the duty of the Centre to procure cotton through the Cotton Corporation of India (CCI), but recent decisions indicate an attempt to withdraw from this obligation. Reddy said the Centre's move in the NITI Aayog meeting to reduce its role in cotton procurement was deeply concerning. He alleged that purchase centres are being opened late "with malicious intent," creating hardship for growers at a time when they need immediate support. He also lashed out at the introduction of the Cotton Kisan app, calling it a tool that forces farmers into unnecessary procedures. "Asking farmers to book through an app and limiting procurement to 7 quintals per acre is nothing but cheating poor cultivators," he said. Reddy further claimed that after the NDA government came to power, policies appear to be moving in the direction of restricting agricultural support with the aim of gradually pushing the sector towards privatisation and handing it over to multinational companies. He urged the Centre to immediately intervene and begin cotton procurement through CCI to protect farmers during the crucial marketing season.

Tripura govt clears University status for two institutes, sanctions 400 new jobs

Agartala, Nov 20 (Representative)

Tripura government has approved the upgradation two key educational institutions, Tripura Institute of Technology (TIT) to Tripura State Technical University and Women's College of Agartala to Tripura Women's University. Additionally, the government has sanctioned the recruitment of 400 new positions across various government departments. These decisions were announced by Cabinet spokesperson Sushanta Chowdhury following a Cabinet meeting chaired by Chief Minister Dr. Manik Saha. The Cabinet, in its meeting on Wednesday, approved the elevation of TIT and Women's College of Agartala, which will now become fully-fledged universities. This move also includes the creation and filling of

over 400 posts in critical government sectors. Speaking on the upgrades, Sushanta Chowdhury emphasized that the establishment of Tripura State Technical University will broaden

opportunities for postgraduate education and research. Currently, such opportunities are primarily offered by a few private universities and the National Institute of Technology (NIT), Agartala. Tripura Polytechnic Institute had begun its journey with a few diploma courses in 1958, and in 2007, it was elevated to TIT with degree-level courses. With the elevation of status, infrastructure, faculties, and the quality of education in TIT has now reached a level where demand

for elevating it to a technical university gained momentum, and finally cabinet approved it to enhance the scope of

higher-level technical education," Choudhury said.

He pointed out that demand for a Women's University in the state has been pressing for a long time



to give more opportunities to girls in higher education. Since the BJPled government came to power in 2018, the government has upgraded

its infrastructure and facilities over the year, and now it has attained the position to become a university, which the cabinet approved. Both the newly elevated universities would start

functioning from the coming academic year, and next six months, the department will complete administrative including processes, the appointment of Vice Chancellor, Registrar, Controller of Examination, and others. So that from the next session, students can get admission, he stated. He announced that the state government has

approved the creation and filling of over 400 posts in different departments, aimed at strengthening administrative efficiency, improving infrastructure,

and expanding welfare services. The cabinet approved filling up 97 vacant Group-C posts, including Auditor (Operation), Investigator (Operator), and Statistical Investigator through JRBT examinations. Sanction has been given to fill 28 Supervisor posts under the ICDS projects through direct recruitment. Creation and filling of 14 new technical posts across civil, mechanical, electrical, and public health engineering sections. Appointment of eight faculty members and supporting staff on a contractual basis for the Tripura Film and Television Institute has been approved. To strengthen early childhood care, the government has decided to open 119 new Anganwadi centres and create 119 Anganwadi Worker posts and 119 Anganwadi Helper posts. The cabinet also approved the simplification of the Journalist Pension Scheme to offer more benefits to a larger number of journalists.

Singapore expresses concern over indecision over adaptation measures as COP30 nears conclusion



ith the UN climate summit (COP30) nearing conclusion, Singapore's for Sustainability and Environment, Grace Fu, said that the lack of consensus by countries on how they should measure their progress on climate adaptation has become a cause for concern, as this continuous spree of indecision has repeatedly stalled the implementation of any measures for adaptation. Adaptation measures consist of a wave of actions that could either mitigate the vulnerability or the damage caused by climate disruptions. This includes actions such as creating sea walls to strengthen flood defences, improving drainage, or creating systems for integration of rainwater harvesting with desalinated water access to ensure a stable supply of drinking water, all seen as measures, crucial for the security of island nations. "Many small island states, like Singapore, face existential threats storm surges, which could wipe out our people," Fu told reports, as per Strait Times. "Coastal protection and flood management infrastructure is of great urgent need." A central and contentious — task for COP30 delegates is deciding on a standardised list of indicators that countries should use to track their adaptation progress, helping governments better assess their exposure to climate risks and respond accordingly. For example, if countries start tracking deaths due to heat exposure and see a growing trend of such mortalities, they can start taking steps to reduce this. Ahead of COP30, experts from across the board cut an initial list of thousands of possible indicators before narrowing them down to around 100. They include measures such as whether a country has a nationwide early warning system, or whether its water and sanitation infrastructure can withstand climate hazards.

Almost 200 countries are meeting in the Brazilian city of Belém to decide

whether to adopt the list, which would shape global adaptation planning and monitoring in the years ahead.

Key disputes include how wealthier nations should support developing countries in adaptation, particularly



However, even after a week of talks, the draft released on Monday is riddled with loopholes, and unresolved text — shown in square brackets — and even left open the option of delaying the decision to a future COP, greatly compounding the many existing problems over reaching a decision. through finance, technology transfer and capacity building. Speaking hours after the draft's publication, Fu said she hoped negotiations would "make more headway" on resolving differences. Nearly half the world's population about 3.6 billion people — is highly vulnerable to droughts, floods, storms

Adding that climate threats do not respect borders, she stated "A severe flood in one part of the world disrupts the food supply and price stability across the world. The same applies to human health. "For example, as rising temperatures expand the range of disease vectors like mosquitoes, the spread of diseases such as dengue across borders is exacerbated.'

IAEA urges Iran to resume full cooperation & grant it access to all nuclear facilities hit in June strikes



Vienna/Tehran, Nov 20 (Agency) The UN nuclear watchdog today warned that it still lacks critical access to Iranian facilities damaged in the June strikes, calling verification of Tehran's enriched-uranium stocks "long overdue". Delivering his opening statement to the International Atomic Energy Agency (IAEA) Board of Governors in Vienna, Director-General Rafael Grossi said the agency urgently needs to examine Iran's inventories of low- and high-enriched uranium, which inspectors have not been able to verify for five months, as per media reports. Grossi noted that he remains in regular contact with Iranian officials following the inspection framework agreed in Cairo in September, but noted that "further constructive engagement is needed" if the deal is to be fully implemented. His remarks coincide with a coordinated push by the US, France, Germany and the UK, who have jointly tabled a draft resolution demanding that Iran resume its full cooperation with the UN watchdog, and grant its inspectors unrestricted access.

ehran has warned that such a resolution would jeopardise the September understanding reached with the IAEA director. Earlier this week, Deputy Foreign Minister Kazem Gharibabadi slamming Western nations, said that their actions risked "compromising" the agreement, with Iranian officials linking the stalled access to the reimposition of UN sanctions under the snapback mechanism at the end of September. As per a partly declassified IAEA report, Iran has still not allowed inspectors to visit the nuclear sites damaged in Israeli and US strikes during the 12-day war in June, when inspectors last verified roughly 440kg of uranium enriched to 60 percent. Grossi told the board today that establishing the current status of Iran's enriched-uranium stockpile "needs to be addressed urgently", warning that prolonged gaps in oversight undermine the safeguards system. "It is critical the agency be able to verify this material as soon as possible," he said. He acknowledged that Iran has granted scheduled access to "almost all unaffected facilities", welcoming Tehran's greater cooperation, though still deemed it insufficient. The latest diplomatic pressure comes after what has been a particularly tense and chaotic year for Iran's nuclear programme, which has been greatly affected following the Israeli and US strikes during the 12-day war in June, when Tel Aviv and Washington targeted several key sites, causing massive damage to Tehran's atomic programme, as well earned the IAEA its ire, with authorities accusing the IAEA of political bias, spying, and sending sensitive data to enemy nations, due to the UN nuclear watchdog's non-condemnation of the attacks. The IAEA Board of Governors will continue discussions in the coming days as Western governments push Tehran to re-establish full compliance, while Iran maintains that sanctions and security concerns must

A wild West: Macron demands crackdown on social media's grip on teenagers



Berlin, Nov 20 (Agency) French Emmanuel Macron has warned about the growing influence of major social media platforms over young people, urging Europe to rapidly

tighten digital regulation to protect teenagers and uphold democratic norms. Speaking Tuesday at the European Digital Sovereignty Summit in Berlin, Macron said European teenagers now spend "four to five hours per day" on social networks, where much of what they see is shaped by opaque algorithms run by a handful of global tech giants. This concentration of influence, he argued, exposes young people to "hyperbullying, pornography, mental-health issues and other harmful content," while governments have effectively outsourced responsibility for children's online safety to foreign platforms. "Let's be clear: these platforms design the content your children consume," Macron said. "We have de facto given them exclusivity over our teenagers' digital lives." President Macron contended that the issue extends past child protection, striking at the heart of Europe's democratic stability. The French leader stressed that the problem extends far beyond child protection, warning that algorithmic control over what billions of people see threatens the foundations of democratic life. When platforms influence public debate without transparency, accountability or compliance with national laws, he said, the conditions for genuine free expression no longer exist. He warned that when algorithms shape public discourse without transparency or oversight, such influence cannot qualify as true free expression. "For me, we don't speak about free speech when the algorithm is hidden and in the hands of very few players, and when they don't implement the laws decided by the citizens of the country," Macron said. "This is a Wild West, not free speech." Macron urged EU member states to accelerate efforts to regulate platform algorithms, enforce existing rules more aggressively, and introduce stronger safeguards for minors. Protecting young people online, he said, is essential not only for mental health and education but for the long-term stability of democratic societies. "If we want digital sovereignty, we must protect our children, our teenagers and our democratic space," he said.

UAE to seize drug traffickers' assets at France's request: French Minister



Paris, Nov 20 (Bureau) For the first time, UAE authorities have agreed to seize tens of millions of euros worth of drug traffickers' assets at France's request as part of a joint effort to combat drug trafficking, French Justice Minister

Gerald Darmanin said. "I have handed over to the UAE authorities a list of assets worth tens of millions of euros so they can freeze the colossal criminal assets of drug traffickers in Dubai, in particular apartments and luxury villas purchased with cash or cryptocurrency. For the first time, the UAE has agreed to seize approximately 40 apartments. This is a major victory," Darmanin said on X on Wednesday. France has also handed over to the UAE authorities a list of "very dangerous drug traffickers" whose extradition Paris is seeking, Darmanin added. According to him, 14 criminals have been handed over to French authorities since the beginning of the year, and Paris now wants to secure the handover of about 15 others.

Congress caught off guard by Trump's 28-point peace plan to end Russia-Ukraine war

Washington, Nov 20 (Reporter)

The Trump administration is renewing efforts to end Russia's war in Ukraine, with a reported 28-point peace plan that has surprised Kyiv's supporters in Congress and prompted one Republican to warn against what appears to be a largely pro-Moscow proposal. The plan was reportedly worked out by President Trump's top envoy for peace negotiations, Steve Witkoff, along with Trump allies Jared Kushner, Vice President JD Vance, and Secretary of State Marco Rubio, in coordination with Kirill Dmitriev, a close associate of Russian President Vladimir Putin and discussed with only a few top senior Ukrainian officials. Russian officials, such as Foreign Ministry spokesperson Maria Zakharova, said no official information had been received from the U.S. regarding any agreements on Ukraine. Likewise, Ukraine's top supporters in Congress appeared to

be in the dark. According to reports from Axios and the Financial Times, the plan would require Ukraine to give up full control of the Donbas region while maintaining control of roughly 12 percent of the territory and would also call for Ukraine

Russian Orthodox Church. The plan is reportedly structured around four main themes: peace in Ukraine, security guarantees, European security, and the future drawing inspiration from Trump's

But Graham added that any plan must be buoyed by strong U.S. military commitments to Ukraine and measures targeting Putin's ability to fund the war. Some lawmakers were left to learn the details of the 28-point peace plan largely from reporting in Axios, which broke the story, and the Financial Times, which followed up with details of the plan. I just heard about it but have not seen any of the details," Sen. Mike Rounds (R-S.D.) told reporters. "I have not been read in on the details of that," The Hill quoted Sen. Pete Ricketts (R-Neb.), a member of the Senate Foreign Relations Subcommittee on Europe and Regional Security Cooperation, as saying. Trump lauds stronger US-Saudi Alliance, confirms advanced military equipment sale to Riyadh

resident Donald Trump declared that he and Saudi Crown Prince Mohammed bin Salman are making the alliance between the United States and Saudi Arabia "stronger and more powerful than it's ever been before," as he announced that Washington will be selling some of the "greatest military equipment ever built" to Riyadh. After having given Saudi Arabia the status of a major non-NATO ally of the United States, Trump said, "A stronger and more capable alliance will advance the interests of both countries, and it will serve the highest interest of peace. And we all share in peace, and we've never had and been so close to truly everlasting peace in the Middle East," Trump emphasized.His comments came during the US-Saudi Arabia

Investment Forum on Wednesday, a day after the crown prince pledged that Riyadh would increase its investment in the United States to nearly USD 1 trillion. Trump pushed bin Salman to

go higher. "Could you make it \$1.5 trillion?' he asked. Trump and bin Salman applauded 270 billion in agreements and signed between dozens of companies the Kennedy conference, Center including planned purchases of 600,000 Nvidia (NVDA.O) AI chips by HUMAIN, a government-backed Saudi AI firm. "The

partnership between our two nations is among the most consequential in the entire world, and together, the

crown prince and I are making an alliance stronger and more powerful than it's ever been before," Trump said. He contrasted his relationship with Saudi Arabia to those under previous



administrations, asserting that ties had been weaker with former presidents Barack Obama and Joe Biden. "We've

The B2s were undetectable and they dropped their payload and every single bomb hit its exact mark, which was a shaft going deep into the mountain...and it was total obliteration. But they want to make a deal. We'll see what happens," Trump said.Additionally, groundbreaking agreements were signed in civil nuclear energy, critical minerals, and artificial intelligence, alongside the expanded investment commitments. Trump thanked Crown Prince for bringing "thousands of jobs and great opportunities" to the United States, emphasizing the economic benefits of the deepening US-Saudi partnership.

'Parents Now Want Daughters to Emulate Richa, Harmanpreet'

Tokyo, Nov 20 (Agency)

Indian golfer Diksha Dagar made history on Thursday by defending her gold medal at the 25th Summer Deaflympics in Tokyo, Japan. Diksha produced rounds of 68, 65, 72 at the par-72 Wakasu Golf Links in Tokyo to top the podium by a whopping 14-stroke margin in women's individual strokeplay competition. Diksha, who had won gold at the 2021 Deaflympics and a silver at the 2017 edition of the Games, posted a threeday total of 11-under 205. Margaux Rezo of France ended second with an overall total of three-over 219 followed by Canada's Erica Dawn Rivard at five-over 221. The 24-year-old is the only hearing-impaired player across the globe to have represented the country in both Deaflympics and Olympic Games.

She represented India at the Tokyo 2020 and Paris 2024 Olympics. Her compatriots Harsh Singh with a three-day tally of 22-over 238 finished solo 12th and Vibhu Tyagi finished his campaign in tied 14th place with overall score of 24-over 240. "I am very happy to have won back-to-back gold medals at the Deaflympics. The

competition is getting tougher every year. I had to compete against girls from 20 different countries. I stuck to my plan – attacking the flags on par-5s and focusing on my short game and approach shots," Diksha told IGU Media. "I would like to thank the Sports Authority of India (SAI) and the Indian Golf union for supporting me throughout this journey. I would also like to thank my sponsors and

Ladies European Tour (LET) and Women's Golf Association of India for providing me the exposure to deal with stiff competition,' said the Target Asian Games Group (TAGG) athlete. Congratulating Diksha on her fantastic feat, IGU president Brijinder Singh said: "On behalf of the Indian Golf Union, I would like to extend my heartiest congratulations to Diksha Dagar for her historic gold. It is a proud moment for the entire nation not just us. Diksha is the only golfer on the planet to have played both the Olympics and Deaflympics. All the best to her for her future endeavours!" IGU Honorary Secretary Shashank Sandu said: "Diksha is a product of the IGU system. At IGU, we strive to provide the best exposure and the platforms to our talented youngsters to shine both nationally and internationally. Many congratulations to Diksha."

■ Shubman Gill likely to miss out as Pant expected to captain Guwahati Test

Guwahati, Nov 20 (Reporter) Shubman Gill is set to miss out on the second Test against South Africa in Guwahati, with the opener still recovering from a neck injury that has kept him under continuous medical supervision. With Gill unlikely to take the field, Rishabh Pant is expected to step in as the stand-in captain for the Guwahati Test. Gill sustained a neck injury on Day 2 of the Kolkata Test against South Africa and was taken to the hospital for further examination after the close of play.

Gill was kept under observation overnight before being discharged the following day with BCCI stating that he has been "responding well to the medical treatment provided". The BCCI added that Gill will continue to be monitored by the BCCI medical team, and a decision on his participation in the 2nd Test will be taken accordingly. "See, he is definitely recovering really well, because I also met him yesterday," batting coach Sitanshu Kotak said ahead of a practice session that the Captain skipped. Kotak emphasized the caution required before deciding on Gill's participation.

■ Deaflympics: Mahit wins silver in 50m Rifle Prone

Tokyo/New Delhi, Nov 20 (Agency) Rifle shooter Mahit Sandhu won silver in 50m Prone event, her third medal at the ongoing 25th Summer Deaflympics in Tokyo. Mahit also broke the World Deaf Record in qualification enroute to the finals. She shot 246.1 in the finals to secure the silver medal while Eliska Svobodova of Czechia won the gold, with a score of 247.2. Hungary's Mira Zsuzsanna Biatovszki won bronze with a score of 225.0. The other Indian shooter in the finals, Natasha Joshi finished in eighth position, going out after a shoot-off. In the finals, Mahit was in fourth position after the completion of 14 shots.

She moved into a bronze medal after the next series of two shots, overcoming Violeta Lykova of Ukraine and remained in the same position until the completion of 20 shots. Mahit then hit a 9.8 and 10.2 in the next series, but a 9.4 and 9.8 from the Hungarian shooter ensured the Indian moved up into silver position. Mahit then finished the finals with scores of 10.0 and 10.7, but could not match up to Svobodova's total score as the Czech shooter also hit both her final shots in the 10s. Earlier in qualification, Mahit created a new Deaf World Record finishing the six series with a score of 619.7 while Natasha Joshi booked her place in the finals in seventh place with a score of 611.6.

■ Fluminense beat Flamengo 2-1 with Acosta and Serna goals

Rio de Janeiro, Nov 20 (Agency) Luciano Acosta and Kevin Serna scored first-half goals as Fluminense clinched a 2-1 home victory over leader Flamengo in Brazil's Serie A. Former Boca Juniors midfielder Acosta put Fluminense ahead by lifting a first-time effort from the edge of the area over the head of goalkeeper Agustin Rossi and into the far corner. The second goal came after Rossi failed to control a routine back pass, leaving Colombian forward Serna with an easy tap-in. Former Chelsea and Arsenal midfielder Jorginho pulled a goal back from the penalty spot, but Fluminense held on to secure its 16th win of the campaign. Despite the result, Flamengo remains top of the 20-team standings with 71 points, two ahead of second-placed Palmeiras, which was held to a goalless home draw by Vitoria earlier on Thursday. Fluminense is sixth with 54 points. In other Brazilian top-flight fixtures on Wednesday, Santos was held to a 1-1 home draw by Mirassol, and Gremio prevailed 2-0 at home to Vasco da Gama.

■ Roger Federer elected to International Tennis Hall of Fame

London, Nov 20 (Agency) Swiss tennis legend Roger Federer, a former World No. 1 who spent 310 weeks atop the PIF ATP Rankings, has been elected into the International Hall of Fame as part of the Class of 2026, the ATP announced. Federer winner of 103 tour-level titles, second only to Jimmy Connors (109), also claimed 20 major trophies and earned 28 ATP Masters 1000 crowns. "It's a tremendous honor to be inducted into the International Tennis Hall of Fame and to stand alongside so many of the game's great champions, Federer said. "Throughout my career, I've always valued the history of tennis and the example set by those who came before me. It was very special to receive the news at Swiss Tennis, surrounded by the next generation of players the place where my own journey first began." Federer was informed of his induction by fellow Hall of Fame members in a call that included Stefan Edberg and Boris Becker, two players who helped inspire the Swiss superstar. The 43-year-old holds the record for most consecutive weeks at World No. 1 at 237 from February 2004 to August 2008. He finished as ATP Year-End No. 1 presented by PIF honours five times, received the Stefan Edberg Sportsmanship Award 13 times, and was named ATP Fans' Favourite for a record 19 consecutive years from 2003-21.

G20 Summit to see focus...

Work; Artificial Intelligence Dalela, Secretary ER, also said that the New Delhi Leaders' Declaration of 2023 has "provided a strong basis for many of the G20 outcome documents adopted this year in the various ministerial tracks. "G20 provides an excellent opportunity for the leaders of these large and emerging economies, representing over 85% of global GDP and around three-quarters of the world population, to come together and discuss important issues impacting the world. These include important matters such as accelerating progress on the Sustainable Development Goals, reform of global institutions of governance, tackling environmental and climate challenge, debt sustainability, bridging the digital divide, energy transition, emerging technologies -- underscoring the importance of international coordination and cooperation in addressing contemporary global challenges.

"Our joint UK-India Vision 2035 has the landmark free trade agreement at its core. During my visit, I will see the impact of our revitalised partnership: creating thousands of jobs, driving innovation, and delivering investment in both our countries." In Bengaluru, the Minister will confirm that the British Council's Women in STEM Scholarship programme will return to South Asia and India after a gap of one year. These scholarships provide full funding—currently worth at least £40,000—for one-year master's degrees at leading UK universities, covering tuition, living costs, travel, and health insurance. This year, 10 scholarships will be reserved for South Asia, worth £400,000, with applications for the 2026-27 academic year opening in January. The Minister will hold bilateral meetings with Karnataka State Industries Minister, M B. Patil, and Karnataka Higher Education Minister, Dr. M. C. Sudhakar, to discuss advanced manufacturing, research, and skills collaboration. She will meet Tamil Nadu's Minister for Industries, Investment Promotion and Commerce, Dr. T. R. B. Rajaa, to discuss opportunities in advanced manufacturing, green technologies, innovation-driven investments, and skill development for future-ready industries. The Minister will also see how joint UK and India efforts are raising awareness of visa fraud in hotspot regions, helping to protect families from exploitation and reduce the number of illegal entrants into the UK. In Chennai, she is expected to expand the UK's campaign to tackle visa fraud in India to Tamil Nadu. The campaign will aim to reduce the number of people travelling to Britain on fake visas, with the UK and India cooperating to protect people from scams and tackle illegal migration at its source. The new campaign follows a successful pilot already underway in the Punjab region in northern India. It will include targeted outreach in high-risk areas, plus a Tamil-language WhatsApp chatbot to help Indian nationals identify visa scams and avoid fraudulent agents.

before the Bench. The counsel pointed out that while the Court had struck down the requirement of a minimum age of 50 years for advocates to be considered for tribunal appointments, the parallel requirement for CAs, 25 years of experience, which effectively pushes eligibility to around age 50, remained unaddressed. Accepting the submission, the Court said, "It is argued on behalf of the Institute of Chartered Accountants that the requirement of 25 years of experience for Chartered Accountants for appointment as technical members is arbitrary. A CA would be entitled to be considered only after attaining the age of 50 years. A similar condition for lawyers has already been held to be invalid and unconstitutional." Agreeing with ICAI's position, the Bench held, "We are in agreement with the submissions... If such a provision is held valid, CAs would enter service only after age 50. We have already held a similar provision unsustainable for advocates. The same analogy must apply to CAs. We therefore hold that the requirement of 25 years' experience for CAs to be appointed as technical members is unconstitutional." The Court also directed that the union Government must keep this clarification in mind while drafting fresh legislation to replace the Tribunal Reforms Act, 2021, which was struck down on November 19.

Olympics 2020 (able bodied). The Silver medal went to Margaux Brejo of France and Bronze was won by Canada's Erica Dawn Rivard. The Deaflympics are being played here in Tokyo from November 15-26 and a 111-strong Indian contingent is participating in it.

The Court questioned whether Governors could withhold Bills indefinitely, warning that such a practice could place democratically elected governments at the "whims of the Governor." Attorney General R. Venkataramani and Solicitor General Tushar Mehta opposed judicial timelines, arguing that courts cannot assume the functions of constitutional offices. They also rejected the idea of "deemed assent." Senior Advocates Kapil Sibal, Dr. AM Singhvi, KK Venugopal, Gopal Subramanium, and Arvind Datar argued in favour of judicially enforceable timelines to prevent constitutional paralysis caused by delayed assent. Senior Advocates Harish Salve and Mahesh Jethmalani supported the Union's stand against fixed timelines.

US approves sale of Javelin missiles and Excalibur projectiles to India worth USD 47.1 million

New Delhi, Nov 20 (Agency)



United States has approved the sale of FGM-148 Javelin anti-tank guided missile systems and M982A1 Excalibur precision-guided artillery projectiles, along with associated equipment, to India, with an estimated value of USD 47.1 million. The U.S. State Department has made a determination approving a possible Foreign Military Sale to India for the Excalibur projectiles and related equipment. The Defense Security Cooperation Agency has delivered the required certification notifying Congress, the Defence Security Cooperation Agency said in a statement. The Government of India has requested to purchase up to 216 M982A1 Excalibur tactical projectiles. Additional non-MDE items to be included are ancillary items, Portable Electronic Fire Control Systems (PEFCS) with Improved Platform Integration Kit (iPIK), primers, propellant charges, US Government technical assistance, technical data, repair and return services, and other related elements of logistics and program support. The total estimated cost is USD 47.1 million. The proposed sale will support US foreign policy and national security objectives by strengthening the US-Indian strategic relationship and enhancing the security of a major defense partner. India continues to be an important force for political stability, peace, and economic progress in the Indo-Pacific and South Asia regions. The sale will improve India's ability to meet current and future threats by providing precision capability equipment, enhancing first-strike accuracy in its brigades. India is fully capable of absorbing these articles and services into its armed forces. The proposed sale of this equipment and support will not alter the basic military balance in the region. The principal contractor will be RTX Corporation, located Arlington, VA. Currently, the U.S. Government is not aware of any offset agreement proposed in connection with this potential sale; any such agreement will be defined in negotiations between the purchaser and the contractor. Implementation of the proposed sale will not require the assignment of additional U.S. Government or contractor representatives to India. There will be no adverse impact on U.S. defense readiness as a result of this proposed sale. The description and dollar value reflect the highest estimated quantity and cost based on initial requirements. Actual value may be lower depending on final requirements, budget authority, and signed sales agreements, if and

residents of the area also alleged that it was due to the collusion between some civic body staff and private rickshaw operators, that private waste at the particular spot.



Jairam Ramesh demands govt response to US-China commission's controversial report on India



New Delhi, Nov 20 (Agency) Congress MP Jairam Ramesh on Thursday raised sharp questions for Prime Minister Narendra Modi, urging the government to clarify its stance on the recent US-China Economic and Security Review Commission's (USCC) annual report. The report's portrayal of sensitive security issues involving India has sparked concerns over India's diplomatic positioning. Ramesh asked pointedly, "Will the Prime Minister and the Ministry of External Affairs register their objections and lodge a protest against this report? Our diplomacy has suffered yet another severe setback." He specifically questioned the government's response to the USCC report's description of the Pahalgam terror attack as an "insurgent attack" orchestrated by Pakistan. "What action will be taken regarding the report's claim of Pakistan's 'military success' over India during the fourday clash?" Ramesh demanded. Highlighting the government's silence amid these serious allegations, Ramesh also referenced former US President Donald Trump's repeated claims of halting Operation Sindoor, questioning the implications for India's diplomatic relations. "This report is simply unacceptable to India," Ramesh said in a post on X, pressing the government to address the contentious narrative and defend India's security interests on the global stage. The USCC report, submitted to the US Congress, assesses economic and security issues related to China but also touches upon South Asian geopolitical tensions, including India-Pakistan conflicts, thereby influencing international perceptions and diplomatic discourse. nion Minister of Home and Cooperation Amit Shah on Wednesday said that the government is committed to bringing positive change to the lives of farmers, rural families, fishers, small producers, and entrepreneurs through the cooperative movement, and cooperation is playing a vital role in the nation's efforts toward self-reliance. He said that following the establishment of the Ministry of Cooperation under the leadership of Prime Minister Narendra Modi, the cooperative sector has witnessed unprecedented progress, and the National Cooperative Development Corporation (NCDC) has emerged as the principal foundation of this

today, Shah said that NCDC, established to empower cooperative societies and make financial assistance accessible them, has increased its total disbursement from Rs 24,700 crore in the financial year 2020-21 to Rs 95,200 crore in 2024-25. Over the past four years, NCDC has undertaken initiatives

strengthen the cooperative sector and has set new benchmarks in financial inclusion, innovation, and expansion, he said. According to the minister,

cooperation is an excellent model for making India a developed economy because it ensures participation and livelihood opportunities in rural areas.



In the last four years, NCDC has registered a compound annual growth rate of over 40 per cent, maintained zero net NPA, and achieved its highesthas strengthened the institution's credibility and reputation, he added.

The minister said that NCDC has effectively worked in the sectors of dairy, food processing, textiles, marketing through District Central operative Banks (DCCBs), State Cooperative Banks, State Marketing Federations.

The efforts being undertaken to develop Primary Agricultural Credit Societies (PACS) as Farmer Producer Organizations will ensure that

farmers receive fair value for their produce and encourage community benefit over individual profit, he said. Shah further said that the circular economy should be encouraged in the sugar and dairy sectors to increase profitability. Based on the Rs 1,000 crore government grant provided for modernizing cooperative sugar mills, NCDC has disbursed Rs 10,005 crore to 56 sugar mills for ethanol plants, co-gen, and working capital, enabling mills to access alternative income streams and low-interest loans. As per HM, NCDC is playing a key role in establishing the cooperative-based "Bharat Taxi" ride-hailing service. The new multi-state cooperative society has been registered, and driver enrolment along with technological development is under progress, he added. NCDC has expanded the

reach of cooperation by establishing a new regional office in Vijayawada and sub-offices in Jammu & Kashmir, Ladakh, Sikkim, Manipur, Mizoram, Tripura, Arunachal Pradesh, Meghalaya, and Nagaland. To increase youth participation, NCDC's "Cooperative Intern" programme is being implemented effectively, under which selected interns are providing technical and managerial support to cooperative institutions, said Shah. The General Council of NCDC included 51 members, comprising senior officials from various ministries, state governments, top cooperative organizations, and NITI Aayog. This Council is the apex body responsible for formulating policies and guidelines for financing cooperative development, agriculture, rural infrastructure, and allied sectors.
