# Toxic air grips Delhi again as AQI climbs to 391; authorities tighten GRAP measures

New Delhi, Nov 23 (Representative)

elhi's air quality on Sunday recorded its 10th straight day in the 'very poor' category, with the city's 24hour average Air Quality Index (AOI) rising to 391 at 4 p.m., according to data from the Central Pollution Control Board(CPCB). Foul air was recorded at all 39 monitoring stations across Delhi. Wazirpur (459), Vivek Vihar (457) and Rohini (453) were the worst affected with AQI readings crossing the 450 mark, and several other stations reported severe pollution levels with readings breaching the 300 level. In the NCR region, Greater Noida's air quality hovered just below the severe mark with an AQI of 399. While in Noida and Ghaziabad, the levels crossed the severe mark and stood at 418 and 437, respectively. Gurugram and Faridabad fared slightly better, logging AQI levels of 295 and 237, respectively, both falling in the 'poor' range. As per the CPCB classification, air quality readings between 300-400 fall under the 'very poor' category,



which causes respiratory illness on prolonged exposure, while AQI levels above 400, in the 'severe' category, affect healthy people and seriously impact those with existing diseases. Amid rising pollution levels, the Commission

for Air Quality Management for NCR and adjoining areas on Saturday revised the Graded Response Action Plan(GRAP). In a press release, the CAQM said measures earlier reserved for the 'severe' category under GRAP Stage IV would now be enforced at Stage III.

The pollution watchdog also shifted several stricter measures from GRAP Stage 3 to Stage 2, and Stage 2 to Stage 1. The steps include ensuring an uninterrupted power supply to reduce diesel generator use, deploying additional personnel at traffic congestion hotspots, issuing pollution alerts across media platforms, and expanding CNG and electric public transport fleets with increased service frequency, along with differential fares to promote off-peak travel. Several measures earlier placed under Stage 3 for the 'very poor' category have now been moved ▶ Cont. to Page-7

# Scientific storage vital for India's food security: Report

New Delhi, Nov 23 (Reporter)



Efficient post-harvest management, particularly scientific storage of food grains, is vital to India's food security, farmer incomes and reduction of post-harvest losses, which can range from 6-10pc, said a report of PHD Chamber of Commerce and Industry (PHDCCI). Being one of the world's largest food gain producers, India is currently facing significant challenges in storage and supply chain infrastructure, which impact the preservation, quality and marketability of agriculture produce. India ranks highly globally in arable land and foodgrain production, with major contributions from states like Uttar Pradesh, Madhya Pradesh, Punjab, Odisha and Rajasthan.

The 'Foodgrain Warehouse Market in India 2025-30' report said that foodgrain production has shown consistent growth, reaching a record of 332.3 million metric tonnes in 2023-24, which is projected to further increase to approximately 354 million metric tonnes by 2024-25. Moreover, the food grain supply chain in India encompasses multiple policy incentives such as Minimum Support Price (MSP), milling (for rice), temporary storage in APMC Mandis, transportation mainly via Indian railways and final distribution through the Public Distribution System (PDS) via Fair Price Shops (FPS). The total scientific foodgrain storage capacity in India is around 87 million metric tonnes, primarily concentrated in the North and West zones, whereas production is projected to reach about 368 million metric tonnes by 2030-31. #### ■ ECI reports major progress in nationwide Enumeration during SIR phase II

New Delhi, Nov 23 (FN Reporter) The Election Commission of India (ECI) on Sunday announced remarkable progress in Phase II of the Special Intensive Revision (SIR), with over 99 per cent of electors across 12 states and union Territories receiving Enumeration Forms (EFs). The Commission's Daily Bulletin revealed that more than 50.47 crore EFs have been distributed, and nearly 40 per cent, over 20 crore forms, have already been digitised. Among the top performers in EF distribution are Goa and Lakshadweep, achieving 100 per cent coverage, closely followed by Andaman and Nicobar Islands at 99.98 per cent, Madhya Pradesh at 99.82 per cent, and West Bengal at 99.75 per cent. In the digitisation drive, Lakshadweep leads with an 88.20 per cent digitisation rate, with Goa and Rajasthan following at 69.38 pc ▶ Cont. to Page-7

# *India, Israel to implement FTA in two phases* to ensure early benefits: Piyush Goyal

union Minister of Commerce and Industry, Piyush Goyal, on Sunday said India and Israel are considering implementing their proposed free trade agreement (FTA) in two phases to ensure early benefits for the trade community of both countries, Commerce and Industry Minister Pivush Goyal said on Sunday. India and Israel on Thursday inked terms of reference (ToR) to formally launch negotiations for the agreement.

"We are considering doing this in two tranches. A decision will be taken when the talks begin. Both ministers are keen to finalise the first phase early so that the trade community benefits sooner," Goyal said. The minister said he and Israeli Economy and Industry Minister Nir Barkat have agreed that they will first focus on the low-hanging fruits in the FTA. Both leaders also decided not to touch the sensitive issues on both sides. He further said the two countries may look at how innovative and R&D can drive greater investments in each other's countries, work on joint projects where we can leverage on their skill sets and they can leverage on the economies of scale in a large market like India. # The Labour Codes celebrate formalisation as a central driver of Atmanirbhar Bharat, an Analysis

New Delhi, Nov 23 (Bureau)

India stands at the dawn of a historic era, amoment of national Lonfidence as the country implements the Labour Codes, widely regarded as among the most visionary and transformative reforms since independence. Their implementation marks the shedding of colonial-era labour laws and the adoption of a modern legislative framework aligned with the aspirations of Atmanirbhar Bharat and the long-term trajectory of Viksit Bharat 2047. These reforms uplift millions of workers and invigorate the Micro, Small

dignity, fairness and widened access to essential protections. The Code on Wages and the Code on Social Security reinforce equal pay for equal work, ensure the universalisation of protection, and create an environment that supports encourages women's full

participation. The expansion of Employees State Insurance Corporation coverage



# 58 pc GCCs in India investing in Agentic AI, 67 pc creating dedicated innovation teams



New Delhi (Agency): India-based global capability centres (GCCs) have moved from AI experimentation to enterprise-scale adoption, with 58 per cent of centres currently investing in Agentic AI and another 29 per cent planning to scale over the next year, a report said on Sunday. About 83 per cent of GCCs are already investing in GenAI, where pilots have increased from 37 per cent last year to 43 per cent as of 2025. According to the EY India's report, GCCs are applying GenAI where it matters most -- enhancing customer service (65 per cent), followed by finance (53 per cent), operations (49 per cent), IT and cybersecurity (45 per cent). Business intelligence adoption has increased to 86 per cent from 80 per cent last year, while data strategy has risen to 67 per cent from 51 per cent. Meanwhile, according to the report, two-thirds of GCCs (67 per cent) are creating dedicated innovation teams and incubation programs to generate, test and globalise ideas from India. "Global enterprises are rethinking how they run their operations. They want simpler models, tighter oversight and a place where AI, data and risk teams can operate in sync. Our survey shows that this shift is well underway at GCCs in India," said Manoj Marwah, Partner and GCC Sector Leader - Financial Services, EY India. The combination of talent, cross-functional maturity and a rapidly advancing AI ecosystem gives global firms something they can't easily build elsewhere. The GCCs we set up now are poised to operate as decision centres shaping enterprise strategy around risk, new products, digital transformation and more, he added. As per the report, GCCs in the nation are becoming key collaborators in global decision-making, with over half of India's centres (52 per cent) holding shared accountability for global decisions, while another 26 per cent are formally consulted. Nearly 20 per cent centres are on their way to operate with full ownership from India for select functions. Moreover, critical responsibilities are being driven from India GCCs, including global strategy leadership (45 per cent) and leadership pipeline development (35 per cent), the report noted.

# New Labour Code on Wages aims to safeguard workers, boost growth and jobs

New Delhi (Agency): The new Code on Wages that has now come into effect, promotes fairness, equity, and inclusivity in India's labour market. By ensuring uniform wage standards and social security, it safeguards both workers' rights and employers' interests. Overall, it strengthens economic justice, encourages formalisation, and enhances the dignity of labour, according to an official statement issued on Sunday. Section 5 of the Code on Wages, 2019 establishes a statutory right to minimum wages for all employees, extending its coverage to every sector, both organised and unorganised. Earlier, the minimum wages applied only to scheduled employment, covering roughly 30 per cent of the workforce. The Code ensures minimum pay for every employee, irrespective of industry, category, or nature of employment. It provides a uniform legal safeguard nationwide, reducing wage disparity and benefits vulnerable groups like casual employee, daily wagers, and migrant labourers, the statement explained. It standardises definitions of key



terms and streamlines procedures, reducing ambiguity and ensuring faster, time bound justice for employers. The bigger aim of the labour reforms is to drive economic growth through generation of decent employment opportunities for all, the statement explains. The second National Commission on Labour had recommended that the existing Labour Laws should be broadly grouped into four or five Labour Codes on a functional basis. Consequently, the Code on Wages,

2019 is one of the four codes of the labour laws that has been enacted. The Code safeguards employee interests through fair wages, social security, and protection against exploitation, ensuring dignity and stability at work. It supports women workers through equal pay and representation, fostering inclusive participation. By ensuring fair wages and social security for all workers, it drives productivity and labour welfare. The Labour Reforms simplify the registration and

licensing framework by introducing the concept of a Single Registration, Single License, and Single Return, thereby reducing the overall compliance burden to improve employment. The Code on Wages, 2019 has reduced the number of rules from 163 to 58, number of forms from 20 to 6 and number of registers from 24 to 2. The provision reduces regional wage disparities, provides social justice, prevents wage undercutting by states, and promotes equity across the country. Section 9 read with Rule 11 of the Code introduces floor wages as a statutory provision. The baseline wages will be fixed by the Central government on the basis of minimum living standards of an employee including food, clothing etc. It will be revised at regular intervals. State governments must ensure their minimum wages are not lower than this floor level. The code will reduce migration of labour from one state to another due to reduced wage differentials and prevents wage undercutting by states, and promotes equity and growth across

# Q2 GDP data, global signals to drive domestic indices this week

Mumbai (Agency): The second quarter (Q2) GDP data, foreign institutional investors' movement and global cues are projected to drive the Indian stock market sentiment this week. According to analysts, investors will have a close eye on trade developments and economic data like IIP and Q2 FY26 GDP data. "With macro signals turning mixed and global cues offering limited clarity, a balanced approach is advisable. Investors may prioritise sectors with visible earnings traction and renewed interest-such as banking, auto, IT, and consumption-while remaining selective in other pockets," said Ajit Mishra of Religare Broking Ltd. Traders should exercise caution around expiry and key macro releases, using a buy-on-dips strategy only near established support levels, he added. Nifty gave a decisive close above the



26,000 resistance, demonstrating sustained strength and buyers willingness to defend higher levels. "The index continues to trade above its key moving averages -- the 20-day, 50-day, and 200-day EMAs-- further confirming a broader bullish undertone. As long as it remains above these levels, market sentiment is expected to stay constructive and upward-biased," according to Amruta Shinde of Choice Broking.

Along with that, it announced a fresh reconstitution of several major indices, including BSE 100, Sensex 50, Sensex Next 50 and changes set to take effect on December 22



and December 26, 2025. The most direct reason for Tata Motors Vehicles Passenger Bankex, with the Ltd.'s exclusion is the demerger of its commercial vehicle (CV)

and passenger vehicle (PV) businesses. This split meant that the market capitalization of the new, separated Tata Passenger Motors Vehicles Ltd. (TMPVL)

fell below the threshold required to remain one of the top 30 stocks by Free-Float Market Capitalization in the index. Under BSE 100, IDFC First Bank will replace Adani Green Ltd. December 22, 2025. On the same date, Max Healthcare Institute will replace IndusInd Bank.

# New scientific study strengthens India's fight against illegal Mongoose trade

oncerned over large scale poaching of Mongoose for its 'fur (hair) used in clandestine markets for making costly fine quality brush for painting, the scientists and zoologists have made a major breakthrough, developing a mechanism to identify its fiber from the mammals or artificial. India is home of several species of mongooses- Small Indian Mongoose, Indian Grey Mongoose, Indian Brown Mongoose, Ruddy Mongoose, Crabeating Mongoose, and Stripe-necked Mongoose. These small carnivorous mammals play a crucial ecological role by regulating populations of rodents, snakes, birds, and various invertebrates. Despite their ecological

importance, they face severe pressure from illegal wildlife trade, primarily driven by the demand for mongoose hair used in high-quality paint brushes, according to Dhriti Banerjee, Director, Zoological Survey of India.

" Every year, an estimated 100,000 mongooses are killed, with nearly 50 animals required to produce just one kilogram of usable hair. These brushes are sold within India and smuggled internationally to markets in the Middle East, the United States, and Europe often without consumer awareness of their illegal origin," the ZSI chief said.

"Major trafficking routes pass through Uttar Pradesh, Maharashtra, and Tamil Nadu, while international smuggling commonly occurs via Delhi, Mumbai, Kolkata, and across the Indo-Nepal and Indo-Bangladesh borders," he said. To strengthen legal protection, all mongoose species were progressively elevated under the Indian Wildlife



(Protection) Act, 1972, ultimately being placed in Schedule I, the highest protection category. Despite these measures, enforcement agencies often face challenges in identifying mongoose hair in confiscated items. Modern paintbrush processing removes the follicle and basal region of the hair, leaving no nuclear DNA.

Mitochondrial DNA recovery is also frequently unsuccessful due to chemical processing and degradation.

In such cases, tricho-taxonomy the study of hair structure provides a practical, rapid, and non-destructive method for species identification, Banerjee said. He said a development toward this goal has been achieved through study published in Discover Conservation, which presents

the first complete tricho-taxonomic identification system for all these Indian mongoose species. The diagnostic features documented in this work provide a rapid and non-invasive method for identifying confiscated mongoose hair, thereby supporting law enforcement agencies in combating illegal wildlife trafficking.

The study was carried out using museum specimens housed at the Zoological Survey of India (ZSI). Scientist at the Zoological Survey of India M. Kamalakannan, who conceptualized and co-led the study, said "This research fills a critical forensic gap by providing specieslevel identification tools based entirely on hair morphology. It will greatly assist wildlife enforcement agencies in identifying mongoose hair in seized items and curbing illegal trade. The study will also serve as a useful and cost-effective reference for identifying mongoose species in India." Shantanu Kundu, foreign collaborator from Pukyong National University, Republic of Korea, added, "Our combination of microscopic analysis and statistical modelling provides a scientifically

solid baseline. These findings can also complement future molecular or DNA-based approaches to further enhance accuracy in species identification." As an authorised organisation of the Government of India, the Zoological Survey of India, functioning under the Ministry of Environment, Forest and Climate Change (MoEFCC), regularly receives confiscated materials from enforcement agencies across the country, including paintbrushes suspected to contain mongoose hair, for species identification. The ZSI provides the scientific analysis required to support investigations and curb illegal trade. "This study further strengthens our wildlife forensic capabilities and will assist frontline agencies in protecting India's native biodiversity," Banerjee concluded.

#### Generative AI at three: Promise, profit, or bubble

We are approaching the third anniversary of ChatGPT's release. When OpenAI launched it, the world was stunned. For the first time, the wider public directly experienced the power of Generative Artificial Intelligence (Gen AI): large language models (LLMs) could generate coherent, context-aware paragraphs from just a few words of instruction. Three years later, we stand at a crossroads, not only for the global economy but for human civilisation itself. It is now evident that Gen AI is a transformative technology that is reshaping nearly every aspect of our lives, from education to business and

Gen AI differs from every previous wave of disruptive innovation in several fundamental ways. Its adoption has been astonishingly rapid and global, both in the number of users and in its spread across borders. Nearly 70 per cent of new API users of OpenAI's platforms now come from outside the United States. In the last five decades of American technological dominance, no other innovation has seen such swift and widespread international uptake.

Moreover, with reinforcement learning and continuous model upgrades, LLMs are becoming increasingly adaptive, forming a self-improving loop that enhances their performance over time. While the industrial revolution automated muscle power, Gen AI automates cognition and decision-making. That marks a profound shift, as these were tasks once considered uniquely human.

As Prof Diganta Mukherjee of ISI Kolkata observes, "AI is the next big thing after computerisation. The way we replaced repetitive processes at the lower end of the value chain in the early 1990s is now being replicated at a higher level, with AI taking over more complex yet still repetitive tasks such as decision making."

While no oth

While no other technology has achieved such widespread adoption, the challenge with AI today lies in the scale of investment it has attracted. The top five AI-focused companies - Apple, Nvidia, Microsoft, Alphabet, and Amazon - now account for nearly onethird of the S&P 500 index. Overall, AIfocused companies have driven roughly 80 per cent of the S&P 500's gains in 2025. Yet, the incremental improvements in successive AI models, particularly LLMs, are becoming less visible to the public. The current challenges facing the AI ecosystem can be broadly grouped into three categories.

One: LLMs have already trained on nearly all publicly available human content, leaving little new data to improve them. Adding AI-generated material offers minimal gains. This saturation exposes ethical issues, especially around fair compensation for creators. In 2023, artists Sarah Andersen, Kelly McKernan, and Karla Ortiz sued AI image companies, claiming their works were used in training without consent or payment. They argue this violates copyright law through unauthorised copying and imitation of their styles, creating "21st-century collage tools". AI firms counter that using public images qualifies as fair use for transformative purposes. The case, still unresolved, will likely set a precedent for how copyright law, written long before AI, applies to systems that learn from creative works at scale. Its outcome could redefine how AI companies source data and how artists protect their work.

# India's just transition needs a broader blueprint

discussions COP30 in Belem, Brazil, have called for action on a just transition towards a low-carbon economy, underscoring that climate action and social equity cannot be separated. For India, the stakes are especially high. India surpassed 256 gigawatt (GW) of noncapacity September 30 2025 - a significant milestone in its net-zero journey. While this is commendable, it is important to ensure that the process is fair and inclusive from all aspects.

What is 'just transition'? The discussion of a just transition began in the late 1970s and early 1980s, as global awareness of environmental issues grew. In 1993, American labour leader Tony Mazzocchi proposed a 'Superfund for Workers' to support those leaving hazardous jobs. Trade unions later expanded the concept to ensure that workers are not disproportionately affected (in terms of livelihoods and health) while moving from high-carbon to low-carbon economies. International bodies  $\operatorname{such}$ as International Labour Organisation and United Nations now frame just transition as a process that delivers environmental sustainability alongside equity. However, in India, NITI Aayog has emphasised just transition primarily in the context of coal, ensuring that mine closures and workforce shifts are managed in a just, timely, and accountable way. This framing is important but partial. Countries such as Indonesia define just transition as 'An energy transition in which the conditions resulting in social, economic, and environmental risks and oppor-



tunities are equitably distributed among stakeholders according to their capacity and conditions. A just transition also affirmatively enables vulnerable, underserved stakeholders to participate in decision-making that mitigates the risks and captures benefits from opportunities'. India, too, would benefit from such a broader framing. Although just transition has become almost synonymous with coal in India, it needs to be considered in the context of the expanding renewable energy sector. Solar parks, wind farms, and associated transmission lines require significant tracts of land, which may affect local liveli-

hoods and ecosystems. For example, in Rajasthan, overhead transmission infrastructure across desert landscapes has contributed to the decline of the Great Indian Bustard, a critically endangered species. Another emerging challenge is solar waste. As India's earliest installations approach end-of-life (20-25 years), states such as Rajasthan, Gujarat, Karnataka, Andhra Pradesh, and Tamil Nadu home to large solar parks will face rising volumes of panel waste. In the absence of clear recycling pathways, toxic materials from this waste can leach into the environment, compounding the pressures on the very communities that parted with land for renewable projects. To ensure justice in the transition, there is a need for a universal framework that applies to all technologies and is based on shared benefits, transparent decision-making, and the repair of any harm. One such framework - proposed by McCauley and Heffron in 2018 - has three pillars: distributional justice (ensures that costs and benefits are shared fairly), procedural justice (makes decision-making transparent and inclusive), and restorative justice (includes restoring shared community resources. investing in health and education, and safeguarding ecosystems).

To avoid repeating the inequities of the fossil fuel era. India should embed a framework of justice into its institutional architecture. Clear indicators, for example, local jobs and benefitsharing (distributional), community participation and transparent approvals (procedural), and social and ecological investments (restorative), can applied across all renewable technologies.

# Congress power play risks governance vacuum

When the Congress returned to power in Karnataka in 2023, the first major challenge was not administrative but political: choosing between Siddaramaiah and D K Shivakumar for the Chief Minister's post. After days of infighting and intense negotiations in Delhi. Siddaramaiah was selected as Chief Minister while Shivakumar was made Deputy Chief Minister. Rumours of a '2.5-year formula' that circulated then - with Siddaramaiah handing over the reins mid-term have now grown into open demands. A group of MLAs aligned with Shivakumar rushed to Delhi to press the High Command to honour what they claim was a commitment made in 2023. Senior ministers have publicly stated that no such agreement existed and that Siddaramaiah was elected for a full term. The Congress leadership's silence has only deepened the uncertainty.

Adding to the confusion is Siddaramaiah's own ambiguous messaging. Though he had twice declared - before the 2018 and 2023 elections that they would be his last, he has now hinted he may contest once more under pressure from his supporters. He has swung between claiming he will complete the full term and saving he will continue only at the High Command's pleasure, even asserting he will present next year's budget, further fuelling speculation. Another twist is the widespread belief that he hopes to remain in office until January or February 2026, when he is expected to break D Devaraj Urs's record as the longest-serving chief minister. Meanwhile, Shivakumar's announcement that he would guit as KPCC president has only added to the theatre, intensifying rumours that he has received the green signal from the leadership. While these may appear to be internal matters for the Congress, the impact of this perpetual leadership suspense on governance is deeply disconcerting.

# Stand up and show respect, it's a government order

In the great art of Indian public life, few things are as revealing as the small notices pasted on government boards and department walls. They look like routine instructions, but often tell you where the State places itself, and where the citizen stands in the hierarchy of power.

The latest of these is a new government resolution in Maharashtra that quietly commands officials to be courteous to legislators. It frames this to make administration more 'reliable' and 'accountable'. On the surface, it sounds benign. Almost sweet, the way parents expect their children to behave. But the simplest rules often carry the most interesting subtext.

The resolution issued by the General Administration Department turns this expectation into formal instruction. Officers at every level, from Mantralaya to district and taluka offices, must extend full courtesy to public representatives. When an MLA or MP enters an office, officials are expected to stand. They must

listen attentively. They should speak politely, and avoid language that could be read as harsh or disrespectful. They must maintain a register of every correspondence, and reply issued to the elected representative. All replies must go out within two months, and any delay must be recorded with reasons. The order also warns that negligence or failure to follow the protocol will invite action under the Maharashtra Civil Services Rules and the state law that seeks to prevent delays in government work. It reads like a civics lesson wrapped in bureaucratic handwriting. A reminder that an elected representative is not an ordinary visitor. That the people's mandate deserves a visible gesture of



deference. All of this is fine. No citizen objects to politeness. Officials can show courtesy. They often do already.

Yet our public life whispers something about a democracy where the river of respect flows mainly upward, like water pumped against gravity. It

leaves us with a question that no one in the circular voices out loud. Will respect ever flow downward too? Even the word downward feels wrong in a democracy, because it implies citizens are lower in the hierarchy. The citizens who wait on the other side of the counter In

our everyday experience, it is not the MLA walking into the tehsildar's or registrar's office who feels helpless. It is the citizen who walks in clutching a document stamped by every office except the one that truly matters. It is the elderly pensioner who has no idea which counter to approach next. So, the rule reminds us of a truth we already know. Courtesy in India is often a political act. The namaste and the deference can feel staged, meant for the cameras and the permanent studio that many politicians carry with them, thanks to social media. It is the version of respect that starts at the top and trickles down only when the person below has power of a different kind. What the citizen wonders is this.

# UP Deputy CM on SP chief's 'SIR misuse' remark

New Delhi (Agency): After Samajwadi Party chief Akhilesh Yadav accused the BJP and Election Commission of India of "misusing" the ongoing Special Intensive Revision process, Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya on Sunday said the former Chief Minister's remarks indicate "nervousness" as his party has "no real ground presence". Deputy CM Maurya said, "After the NDA victory in the Bihar elections, Akhilesh Yadav claimed he would win in Awadh and defeat us in Magadh, but we have won in Magadh and we will also win in Awadh in 2027, despite their doubts about the outcome." BJP leader Shahnawaz Hussain also hit out at the SP leader, saying, "Since tasting defeat in Bihar, Akhilesh Yadav and his party have been making excuses. They know the Samajwadi Party will also perform poorly in Uttar Pradesh, so they are pre-emptively creating narratives. The same excuses Rahul Gandhi and Tejashwi Yadav gave during the SIR, and Yadav is following in their footsteps." Both leaders asserted that the BJP had no need to interfere with electoral processes and that the SP chief was attempting to "mislead voters" ahead of the next



Assembly elections. Yadav launched a strong attack on the BJP and the Election Commission, accusing them of "misusing" the SIR of electoral rolls. He claimed the BJP was working in tandem with the EC to "cancel" more than 50,000 votes in Assembly segments where INDIA bloc parties performed well in the 2024 Lok Sabha elections. Yadav warned that the SIR process was being conducted in a "targeted manner" in Uttar Pradesh and West Bengal, alleging political motives behind the voter verification drive. The Election Commission is currently conducting the SIR across 12 states and Union Territories, with the final electoral roll scheduled for publication on February 7, 2026.

#### After Karur tragedy, Vijay resumes public outreach at Kancheepuram, attacks DMK



Chennai (Agency): Tamilaga Vettri Kazhagam (TVK) leader Vijay returned to a public forum for the first time since the Karur stampede tragedy, addressing a tightly controlled indoor meeting near Kancheepuram on Sunday. The actor-turned-politician, who has kept away from public events after 41 people died in a stampede during his Karur rally, delivered a sharp political speech aimed at the ruling DMK, while outlining his party's welfare-focused agenda. The TVK had earlier planned to launch Vijay's campaign from Salem on December 4, after he met the families of those who died in the Karur tragedy, whom he invited to Mamallapuram for a private condolence interaction. However, citing the Karthika Deepam festival and other logistical concerns, the police advised that the Salem rally be postponed. In this backdrop, the party held a fully indoor "People's Meeting" at a private engineering college in Sunguvarchatram. Entry was restricted to 2,000 participants from Kancheepuram district, each carrying a QR-coded pass. The party emphasised that the session was not a public rally, but a controlled indoor interaction. Addressing the gathering, Vijay repeatedly invoked C.N. Annadurai and MGR, saying his political journey was inspired by their ideals. "Annaiyar was born in this very district. MGR kept him on the party flag because he believed in his vision. But what are those who inherited his party doing today?" he asked. Vijay said the ruling party's hostility towards TVK would not deter him. "Personally, I have no enmity towards anyone. They may hate me, but that does not matter. But if they come to power by lying and pretending to be doing good, how can we stay silent? We will question them,'

Nexus among the drug peddlers of Mizoram, Tripura, Assam and Myanmar are conducting the illegal trade of narcotics, whose main hub is Myanmar's Chin state. On November 17, dismantling an international drug syndicate involving Pakistan, in a breakthrough against narcotics trafficking, the Assam Rifles, in a joint operation with the Customs Department, seized 800 gm of cocaine valued at nearly Rs 8 crore and arrested two drug peddlers in Tripura. # S. Korean President Lee urges revitalisation of WTO at G20 Summit



Johannesburg (Agency): President Lee Jae Myung has urged the Group of 20 (G20) nations to work to revitalize the World Trade Organization (WTO) to enhance global growth potential, saying the world must establish a predictable trading and investment environment. Lee made the call during the first session of the G20 summit, as the multilateral trading system is facing turmoil, reports Yonhap news agency. "We must establish a predictable trading and investment environment to enhance growth potential," he said. "The revitalisation of the World Trade Organization serves the interests of all nations." Lee pledged active cooperation with the WTO Ministerial Conference to be hosted in Africa next year, saying South Korea will work to ensure the adoption of the Investment Facilitation for Development (IFD) Agreement into the WTO's legal framework at the upcoming meeting. Cameron hosts the next meeting in March. The IFD aims to make investment processes easier, more transparent and more efficient, particularly for developing countries. During the session, Lee also proposed solutions to ease excessive debt burdens on developing countries, which he said constrain their ability to invest in growth and the momentum for sustainable development. "To advance toward the future, we must strategically allocate resources toward sectors with the greatest growth potential, thereby creating a virtuous cycle that generates wealth and reduces our debt burden at the same time," he said. As an example, he highlighted South Korea's increased investment in future growth sectors, including artificial intelligence (AI), and introduced a fiscal policy that expands spending in high-performing sectors with the long-term goal of lowering the nation's debt ratio. Lee also stressed the need for stronger international cooperation to improve the effectiveness of development projects in developing nations. Noting South Korea's participation in the reform road map for Multilateral Development Banks (MDBs), he vowed continued efforts to improve the structure of the institutions that finance development projects in developing countries. He described the first G20 summit held in Africa as "highly meaningful," voicing support for the African Cooperation Framework, a multilateral policy initiative aimed at promoting the sustainable development of African nations.

# India welcomes key outcomes at UNFCCC CoP30; reaffirms commitment to equity, climate justice and global solidarity

expressed "strong support" to Brazil for the inclusive leadership at the 30th edition of the Conference of the Parties (COP 30) of the United Nations Framework Convention on Climate Change (UNFCCC) and reaffirmed New Delhi's commitment to equity, climate justice and global solidarity. India welcomed several significant decisions adopted at the conference, in the "High-level Statement" at the Closing Plenary of the UNFCCC CoP30 in Belem, Brazil, on Saturday. The statement conveyed India's gratitude to the CoP President for his leadership, which it said was rooted in inclusion, balance, and the "Brazilian spirit of Mutirão," and guided CoP30 with integrity. Welcoming progress under the Global Goal on Adaptation (GGA), India underscored the equity dimension of the decision, noting that it reflects recognition of the overwhelming need for adaptation in developing countries, according to a statement from the Ministry of Environment, Forest and Climate Change. A key element of India's address was the emphasis on the



long-standing obligations developed countries to provide climate finance. The statement expressed appreciation for the Presidency's efforts in supporting India in beginning the journey towards a long-overdue focus on Article 9.1. It added that India sincerely hopes that, in the spirit of international cooperation, promises made 33 years ago in Rio would now be fulfilled due to the first steps Parties have taken in Belem. India

expressed satisfaction with the major outcomes of CoP30, foremost among them the establishment of the Just Transition Mechanism. The statement called it a significant milestone and expressed hope that it would help operationalize equity and climate justice at both global and national levels. India thanked the Presidency for providing space to discuss unilateral trade-restrictive climate measures, which it said are increasingly affecting developing

countries and violate the principles of equity and CBDR-RC enshrined in Convention and its Paris Agreement. The statement stressed that these issues cannot continue to be brushed under the carpet, adding that Parties have made a beginning to reverse this trend. Reiterating India's principled approach to climate action, the statement highlighted that the burden of climate change mitigation must not be shifted onto those least responsible for causing the problem. It stressed the need for greater global support to vulnerable populations, a large majority of whom are in the Global South, so they may protect themselves from the escalating impacts of climate change. Washington (Agency): The Russia-Ukraine peace proposal has been prepared with contributions from Moscow, US Secretary of State Marco Rubio said, noting that earlier suggestions from Kyiv were also factored in. As he left for Geneva for discussions on the proposed settlement, Rubio stressed that the document had been drafted entirely the United States. State Department spokesman Tommy Pigott earlier stated that the peace framework was put together by Washington while incorporating views from both Russia and Ukraine. Pigott wrote on X that "as Secretary Rubio and the entire Administration has consistently maintained, this plan was authored by the United States, with input from both the Russians and Ukrainians." President Donald Trump has insisted that the USbacked peace blueprint aimed at ending the Russia-Ukraine conflict is not his "final offer" to Kviv. His comments came after a coalition of Ukraine's Western allies expressed concern that the current draft required major changes. Addressing reporters outside the White House on Saturday (local time), Trump said that if President Volodymyr Zelenskyy refuses the proposal, he can "fight his

Hanoi (Agency): The Authority. Torrential rains and flooding have damaged 1,154 houses and more than 80,800 hectares of rice and other crops in the region, reports Xinhua news agency, quoting the local media. Vietnamese Prime Minister Pham Minh Chinh and Dyke Management has called for stepping up

response measures to severe flooding and natural disasters in the central provinces. The Vietnamese government has provided emergency aid worth 700 billion Vietnamese dong (about 26.6 million US dollars) to certain hard-hit regions for recovery efforts, Vietnam News Agency reported. Over 28,400 houses remain inundated, while 946 others have been damaged, according to the report. The economic losses are estimated at nearly 9 trillion Vietnamese dong (about 358 million US dollars), the authority said. Power has been restored for most affected areas, with around 75,000 households still without electricity.

## Ukraine, US to hold consultations on peace plan in Switzerland



**Kyiv** (Agency): Delegations from Ukraine and the United States will hold consultations in Switzerland in the coming days on the possible parameters of a future peace agreement with Russia, Rustem Umerov, secretary of Ukraine's

National Security and Defence Council, said. "This is another stage of the dialogue that has been ongoing in recent days and is primarily aimed at aligning our vision for the next steps,' Umerov wrote on Facebook. He stressed that Ukraine is approaching the peace process "with a clear understanding of its interests," Xinhua news agency reported. Earlier in the day, Ukrainian President Volodymyr Zelensky signed a decree establishing a delegation for talks with the United States, Ukraine's other partners and Russia, on a peace deal to bring an end to the Ukraine crisis. The delegation will be led by Andriy Yermak, head Presidential Office.

#### Houthi court sentences 18 Yemeni UN aid workers to death for 'spying for Israel'

Sanaa (Agency): A Houthi-run court in Yemen's capital Sanaa sentenced 18 Yemeni aid workers employed by United Nations humanitarian agencies to death for allegedly spying for Israel. The ruling says that the "convicts" will be executed by firing squad in a public place in Sanaa. Meanwhile, the same court handed two others, including a woman, 10-year prison terms on the same charges. In a statement broadcast by Houthi-run al-Masirah TV on Saturday (local time), the court accused the convicts of providing Israel, the United States, Britain, and Saudi Arabia with information on dozens of Houthi leaders' locations, movements, and secrets related to political, military, and security matters, as well as information about missiles, including their launch sites and storage facilities. The court added that the convicts recruited several citizens, installed surveillance cameras, and received payments in return, actions that led to attacks on multiple military, security, and civilian sites, causing dozens of deaths and extensive infrastructure damage, reports Xinhua news agency.

## Number of Koreans aboard 1945 sunken Japanese ship likely to be unveiled by year-end

**Seoul (Agency):** The number of Koreans aboard a Japanese ship that sank in 1945, killing up to over 3,000 people, will likely be revealed by the year-end following an analysis of passenger lists, the interior ministry said on Sunday. The government has commissioned the Foundation for Victims of Forced Mobilisation by Imperial Japan to carry out an in-depth analysis of 75 passenger lists and related items received from the Japanese foreign ministry between



September last year and March this year. The analysis is expected to be completed by mid-December after the interior ministry sorts through passengers listed more than once and corrects misprints and mistranslations. Currently, a total of 18,300 people are listed in the documents, reports Yonhap news

The Ukishima Maru transporting Koreans, many of whom were forcibly mobilised for wartime labour, back to their homeland in August 1945, days after Korea's liberation from Japan's 1910-45 colonial rule, when it sank off Japan's Aomori Prefecture following an explosion in the hull.

## Former Brazilian President Bolsonaro arrested for preventive custody (Agency): Former Brazilian President

Jair Bolsonaro was taken into preventive custody by police in Brasilia under an order issued by the Federal Supreme Court. According to initial information provided by the Federal Police, the arrest is not the result of a sentence, but a precautionary measure requested by investigators. Bolsonaro was detained at around 6:00 a.m. local time (0900 GMT) on Saturday and immediately taken to the Federal Police headquarters in the capital.

The detention comes in the final phase of an investigation into an alleged coup plot in the country. Bolsonaro, who was in power from 2019 to 2022, had been under house arrest since August 4 and had his preventive detention ordered on grounds of safeguarding public order. As part of that process, he had been sentenced to 27 years and three months in prison, reports Xinhua news agency. On Friday, Bolsonaro's defence team submitted a request to Supreme Court Justice Alexandre de Moraes,



the case's rapporteur, seeking permission for the former president to remain under

house arrest, citing health problems. No timeline has been set for Bolsonaro's testimony, and authorities have not said whether additional measures will be taken throughout the day.

His legal team has not issued further statements on the next steps. The preventive arrest takes place amid multiple investigations opened by the Federal Supreme Court and the Federal Police related to Bolsonaro's actions during his administration and after leaving office.

# Muthusamy 109, Jansen 93 take SA to 489; India 9/0

wicket in the 140th over, followed by another boundary off the next ball. Jasprit Bumrah was driven through long-off as Jansen moved swiftly into



in the 138th over when Muthusamy, on 109 off 206 balls, top-edged a pull off Siraj to fine leg, departing to warm applause after South Africa's best innings of the series. India claimed the next wicket when Simon Harmer was bowled by Bumrah for 5 in the 143rd over. #### ■ Norris, Piastri disqualified from F1 Las Vegas GP

Beijing, Nov 23 (Reporter) Formula 1 championship leader Lando Norris and McLaren teammate Oscar Piastri have been disqualified from Las Vegas Grand Prix after postrace checks revealed excessive wear to the skid blocks on both cars. Norris had finished second behind race winner Max Verstappen, extending what had appeared to be a comfortable title lead over Piastri, who crossed the line fourth. But the FIA launched a formal investigation after the chequered flag, with both drivers summoned to the stewards at 11:45 p.m. local time on Saturday. Technical delegate Jo Bauer reported that the rearmost skid blocks on both McLarens measured below the mandatory minimum nine millimeters when inspected against the team's submitted legality documents. McLaren representatives were heard before the decision was issued. The ruling marks the first time in McLaren's history that both cars have been removed from a grand prix classification for the same infraction. The penalties significantly reshuffle the final order

Verstappen retains his win, but George Russell moves up to second, with Mercedes teammate Kimi Antonelli stepping onto the podium in third. The revised classification also sees Charles Leclerc move up to fourth, with Carlos Sainz fifth and Isack Hadjar sixth. Nico Hulkenberg is now seventh, ahead of Lewis Hamilton, while the Haas pair of Esteban Ocon and Ollie Bearman move up into the points-paying positions, in ninth and tenth respectively. The title picture also tightens. Rather than extending his advantage, Norris remains 24 points clear of Piastri. Verstappen's victory brings him level with the Australian in the standings, leaving the trio separated by fewer than 25 points with two grands prix and one Sprint remaining. Enforcement of skid block regulations has already impacted other drivers this season. Hamilton was excluded from the Chinese Grand Prix for the same breach, while Hulkenberg lost his points finish in Bahrain.

to Stage 2. These include staggered working hours for government offices in Delhi, Gurugram, Faridabad, Ghaziabad and Gautam Buddh Nagar. The Centre may also consider staggered timings for its offices in the region, the agency recommended. Restrictions previously meant for Stage 4 during severe AQI, such as allowing public, municipal, and private offices to function with only 50 per cent staff and requiring the remaining employees to work from home, will now be applicable at Stage 3, the notification stated. In line with the CAQM's directive, the Delhi government has directed private offices to operate with 50 per cent on-site staff and allow the rest to work from home as a precautionary measure, as the capital continues to grapple with deteriorating air quality. On Sunday, the city's minimum temperature recorded a drop of nearly 1.5 degrees Celsius from the previous day's minimum and stood at 10.4 degrees Celsius while the maximum settled at 26.7 degrees Celsius, according to the India Meteorological Department (IMD). The forecast for the minimum temperatures are likely to be normal during next 24 hours and below normal, registering a drop between 1.6 and 3.0 degrees Celsius thereafter, said the IMD.

Creation of a G20 Critical Minerals Circularity Initiative: This initiative would foster recycling, urban mining, secondlife battery projects and innovation of various types, and help in strengthening supply chain security, and develop cleaner pathways of development. \* Creation of a G20 Initiative on Countering the Drug Terror Nexus: This would address drug trafficking, , including of fentanyl, and break the drug-terror economy. Prime Minister Modi addressed a session on "A Resilient World- G20 Contribution to Disaster Risk Reduction; Climate Change; Just Energy Transition; Food Systems". He appreciated that the Disaster Risk Reduction Working Group initiated by India is being taken forward. He noted that the approach to disaster resilience should be "developmentcentric", rather than "response-centric" as exemplified in the Coalition for Disaster Resilient Infrastructure set up by India. ## Lakshya Sen clinches Australian Open title with dominant victory

Sydney, Nov 23 (Representative)

India's top-ranked men's singles shuttler Lakshya Sen clinched his sixth career BWF World Tour title, and his first of the season, by winning the Australian Open 2025 in commanding fashion on Sunday. According to Olympics.com, Sen, needed 38 minutes for a clinical 21-15, 21-11 victory over world No. 26 Yushi Tanaka of Japan in the final of the BWF Super 500 tournament.
