

# Revised Model Concession Agreement to be issued soon by Ministry of Ports, Shipping

Chennai / New Delhi, Aug 25 (FN Reporter)

The Indian Ministry of Ports, Shipping & Waterways will soon issue a Model Concession Agreement (MCA) after incorporating the changes suggested by the stakeholders for the Projects, Schemes & Public-Private-Partnerships (PSPPP), a top official said today. Speaking to the media here T.K.Ramachandran. departmental Secretary "We will shortly issue a Model Concession Agreement (MCA) after incorporating the suggestions." He also said, the tariff will be fixed, taking into account the stakeholders' views and the adjudication will be done faster. The government has set up a special cell called PSPPP project cell to understand the practical problems faced in implementing the PPP projects, said Sunil Paliwal, Chairman, Chennai Port Authority.

Ramachandran said several such cells formed last year have been working well in looking into the various issues and suggesting measures. They were speaking at the road show event held here



for the upcoming India Maritime Week 2025 to be held in Mumbai between October 27-31. Queried about the outcome of the ASEAN-Cruise Dialogue held at Mahabalipuram near here, Ramachandran said the focus of that meeting was on promoting cruise tourism between nearby countries and the aim was to start a Bay of Bengal cruise to link ASEAN countries and several countries have agreed upon a common framework.

Paliwal said there is good demand for cruise tourism and cited the Cordelia Cruise, which initially began operating cruises in India on the Western and Eastern coasts, and has now gone international. According to Paliwal, Cordelia

Cruise is planning to add one more cruise ship to its fleet and have it berthed at Chennai while the other one will be berthed on the western coast. He also said plans are being worked out to have cruise tourism between Rameswaram and Kanniyakumari in Tamil Nadu. Oueried about the expansion plans of Chennai Port, Paliwal said the port's investments are towards refurbishing its existing facilities while new infrastructure facilities will be done at the Kamarajar Port, also in Chennai. #### ■ SC Stays FIR against Psephologist Sanjay Kumar over Maharashtra Poll Tweet

New Delhi, Aug 25 (FN Representative) The Supreme Court today stayed proceedings in two FIRs registered by Maharashtra police against Professor Sanjay Kumar, psephologist and Co-Director of the Centre for the Study of Developing Societies (CSDS), over a tweet carrying a mistaken analysis of the 2024 Maharashtra Assembly elections. A Bench comprising Chief Justice of India B.R. Gavai and Justice N.V. Anjaria passed the interim order while issuing notice on Kumar's writ petition seeking quashing of the FIRs. On August 17, Kumar had posted on X (formerly Twitter) about changes in the number of voters in specific constituencies. Based on actionable intelligence gathered, ED officials located him at a prominent five-star hotel in South Mumbai, where he had been staying for the past two months," said the official. # No second thoughts on insurance law amendment proposals: Industry officials

Chennai / New Delhi, August 25 (Bureau)

oes the Indian insurance industry thoughts about some of the amendments proposed to the insurance laws? Or whether the government itself is planning to have a relook at the proposed amendments? These questions arise as the industry is silent on the delay in the introduction of the amendment bill in the Parliament said an industry expert. And the first Chairman of the Insurance Regulatory and Development Authority of India (IRDAI) N.Rangachary who had paved the

way for the private players came out strongly against some of the amendment proposals - saying 'God save the industry'.



Perhaps the big players are having

second thoughts. For instance, the world over the composite insurance concept is going out of favour. But the amendment bill is now proposing allowing composite insurance," the expert not wanting to be quoted told this writer. "Composite registration allows insurers to do life/general/health in a single registration/insurance company -this promotes operational efficiency for insurers having common brands across different lines of business," remarked Conjeevaram Baradhwaj, a company secretary specialising in insurance and corporate laws.

However head honchos of insurance companies refuted the notion that industry is having second thoughts on the amendments proposed.

Odisha Chief Minister Mohan Charan Majhi today said the state's aviation sector is poised for rapid growth with the Centre's support through a flexible national policy, financial assistance for regional routes, and technical collaboration for MROs and training centres. Addressing the Eastern Region Civil Aviation Ministers' Conference here today, Majhi said Odisha has made significant progress in aviation in recent years. The Chief Minister highlighted that the state now has three operational airports, nine UDAN routes, and a dedicated Civil Aviation Policy, which have collectively strengthened connectivity.

He noted that Jharsuguda has five additional flights, while Bhubaneswar is connected to eight domestic and one international destination, with 15 new destinations added in the last four months. Majhi further said the extension of UDAN and the development of airports at Puri, Rourkela, and Paradip will give a major

"For us, aviation is about connecting aspirations with opportunities and creating highways of prosperity in the sky,' the Chief Minister said. were voiced by another senior official of a private insurer. However the views of former IRDAI Chairman Rangachary on the proposed amendments are strong and cannot be taken lightly. According to him, the proposed amendments changes the basic structure of the insurance regulation. The government has proposed amendments to three key legislations — the Insurance Act, 1938, the IRDAI Act, 1999, and the Life Insurance Corporation Act, 1956. Major proposals include: -Halving the minimum capital requirement for general and life insurers to Rs 50 crore for entities serving underserved or rural segments. -Permitting composite licences to operate life, health, and general insurance under a single registration. -Increasing the foreign direct investment (FDI) cap from 74% to 100%. -Allowing non-insurance companies to acquire or amalgamate with insurance firms. -Expanding the range of permissible business activities for insurers. -Raising penalties for non-compliance and misstatements significantly. While some of these changes aim to increase market penetration and flexibility, critics warn they may undermine the sector's long-term stability. Speaking to this writer earlier Rangachary cautioned that the proposed changes could unravel two decades of regulatory progress since the sector was opened to private players in 2000. "God save the industry and the government. Slashing the minimum start-up capital to permit regional insurers, under the guise of enhancing insurance penetration, could trigger a proliferation of small, unstable insurers. We risk returning to the fragmented, unregulated pre-1956 era, when hundreds of insurers operated without accountability and often failed to honour claims," Rangachary said. Supreme court lawyer specialising in corporate and insurance laws D Varadarajan and former member of multiple insurance law reform committees, raised grave concerns about the proposed structural changes. According to him, some of the proposals if enacted is suicidal for the industry. "Doing away with uniform minimum capital requirements, introducing differential solvency norms, and allowing composite business licenses without adequate safeguards could destabilise the industry, he said. He likened the potential influx of undercapitalized insurers to the unchecked proliferation of "paan kiosks," with severe implications for policyholder protection. Both Rangachary and Varadarajan emphasized the fundamental differences between insurers and banks. Unlike banks that deal in shortto medium-term asset management, insurance companies manage risk. Failure in the insurance sector could result in irrevocable harm to policyholders, as there are no equivalent safeguards like deposit insurance. The relationship between a banker and his customer is short or medium term whereas the relationship between an insurer and the life insurance policyholder is long term. Despite their concerns, industry experts acknowledge that some proposals are beneficial like: -Elimination of out dated provisions. -Relaxing restrictions on insurance agents representing multiple insurers — provided safeguards are in place to prevent mis-selling and customer poaching. -Increasing operational autonomy by scrapping the three-year licence renewal requirement for intermediaries and raising the IRDAI approval threshold from 1% to 5% for transfer of shares. While not dismissing all proposed changes, Varadarajan urged a dispassionate re-evaluation of the more radical amendments. "The current regulatory framework has helped the sector withstand global financial crises, economic volatility, and corporate fraud. Undermining its core principles without due caution could jeopardize both the industry's

growth and the protection of policyholders."

## Flood situation remains grim in Rajasthan; 4 killed in rain related mishaps

Jaipur, Aug 25 (FN Representative)

The flood situation continued to be grim in more than half a dozen districts of Rajasthan even as the relief and rescue works were in full swing in the affected areas of Karauli, Tonk, Bundi, Sawai Madhopur and Kota. Four persons were killed in two rain related mishaps in Nagaur and Bhilwara on Sunday. Three persons remained untraced in Tonk. The Army and the Air Force were also on alert mode for helping the NDRF and SDRF rescuers in relief and rescue operations. The army rescuers were already at work in tandem with the NDRF, SDRF, Civil Defence sleuths in Kota, Bundi and Sawai Madhopur. Army teams have been provided to the Tonk district administration for engaging in relief - rescue operations as per the need. Official sources said in Kota that an Air Force MI-17 helicopter has been deployed there for use in providing relief or rescue to trapped people in flooded areas of Kota and Bundi.

The Air Force was also on ready mode for flying more helicopters for relief to people in distress. The Banas river was in spate in Tonk, Sawai Madhopur and Karauli districts intensifying the flood woes of the denizens. Kanthada village of Karauli district is cut off from all sides with flood waters of the Banas and the Morel, another river of the Arawali terrain, reduced the village into an



island. District Collector Neelabh Saxena deployed rescuers of SDRF and Civil Defence to the village-, situated along the inter district border with Sawai Madhopur and Harauti-, for evacuating more than 160 stranded villagers to safer areas. Besides, the two river huge discharge from the Kali Sindh Dam (Sapotara) and Panchana Dam has worsened the situation for rescuers. Flood inflow in Kali Sindh has given rise the water level 8-foot above the maximum permissible level. Huge discharge was released into the Gambhiri river through the 4 flood gates of Panchana Dam. Meanwhile, Sawai Madhopur remains most affected,

with most of the localities of the old city, railway station, it's yard being inundated. More than 15 surrounding villages have been submerged and half a dozen vital roads routes closed. In Jadawata village of the district, the Army has joined in the the rescue operations to deal with situation in the wake of major soil erosion through the village that damaged some houses and threatened demolition of the village temple and many houses. In Lakheri region of Bundi 25 denizens were rescued from Dadwada - Gangapuriya villages which were flooded by the Mej river. The Banas is following above the danger mark, two youths and a woman were trapped in the surging waters in Tonk, efforts to rescue them were ongoing. The incessant rains in Shahbad area of Baran district worsened the situation damaging several houses. In Nagaur a rain soaked house collapsed near old City bus stand killing two persons and injuring as many others. Many houses were partially damaged. In another incident of wall collapse two persons were killed in Bhilwara. Agriculture and Disaster Relief Minister Dr Kirodi Lal Meena was visiting the affected areas in Sawai Madhopur, including the Jadawata village. The Kota Open University has deferred the examinations.

### IIT-Madras develops low cost chip-based device for Antibiotic Susceptibility Testing

Chennai, Aug 25 (FN Representative)

Antimicrobial resistance (AMR) emerging as one of the major challenges and the World

Health Organization (WHO) identifying it as one of the top ten threats to global health as 4.94 million deaths worldwide in 2019 were associated with bacetrial AMR, researchers at the IIT-Madras have developed an innovative and affordable microfluidic device that could rapidly determine whether bacteria are resistant or susceptible to antibiotics. Unlike many modern techniques that rely on costly metals, complex fabrication processes, or require highly skilled technicians, this lab-onchip device is based on screen-printed carbon electrodes embedded in a simple microfluidic chip. This approach makes the device not only economical, but also suitable for deployment in smaller clinics and rural healthcare centres. Designed for speed, sensitivity, and ease of use, it holds strong potential for early diagnosis and better treatment of bacterial infections, particularly in regions with limited access to advanced laboratory infrastructure. A release from IIT-M today said the device can deliver results within three hours and is based on 'Electrochemical Impedance Spectroscopy'. "The device offers a faster, simpler and

more accessible alternative to conventional antimicrobial susceptibility testing, which typically takes 48–72 hours", it said. "AMR is one of the most pressing challenges facing global healthcare systems today, with the WHO identifying AMR as one of the top ten threats to global health", the release said. WHO estimates suggest that nearly 4.95 million deaths worldwide in 2019 were associated with bacterial AMR and the burden is especially high in low and middle income countries, where diagnostic

facilities are limited and infections often go untreated or are improperly managed. Antimicrobial Susceptibility Testing (AST) is an important method used to identify which antibiotics will work against a specific infectio. It helps doctors choose

the right treatment and avoid the misuse of antibiotics, which is a major cause of AMR. However, traditional AST methods, which involve growing bacterial cultures and observing their response to antibiotics, are labour-intensive and typically take 48 to 72 hours. This delay can lead to the use of broad-spectrum antibiotics as a stopgap, which in turn exacerbates the resistance problem. To address these limitations, the IIT Madras team developed this costeffective phenotypic testing device that uses electrochemical signals to assess bacterial growth and antibiotic susceptibility.

This device meets several key criteria outlined by the WHO, including affordability, speed, ease of use and reliability, it said, adding, by addressing these priorities, the device takes a significant step toward making antimicrobial susceptibility testing more accessible, especially in low-resource settings. This Research has been published in the prestigious Nature Scientific Reports, a peer-reviewed, open-access scientific mega journal published by Nature Portfolio (part of Springer Nature), covering all areas of the natural sciences. The paper was co-authored by Saranya Gopalakrishnan (Director Technology Innovation, Kaappon Analytics India Pvt Ltd, a startup incubated in the IITM Research Park, and Diksha Mall, Research Scholars from IIT Madras along side IIT Madras faculty Prof. Subramaniam Pushpavanam and Dr. Richa Karmakar. Prof. Pushpavanam of IIT Madras said, "An important aspect of our device is the use of a specially prepared

nutrient solution that serves a dual purpose. It not only supports bacterial growth, which is essential for testing, but also enhances the sensitivity of the electrical signals we use for detection." "As the bacteria grow, they cause measurable changes in the electrical properties of the solution, which our system can accurately track", he said. Explaining how this technology can be taken to the real world and possible initiatives in this direction, Prof. Pushpavanam said this approach will make a real impact on patients in Intensive Care Units, who could be suffering from complications due to bacterial infections. This will help the doctors prescribe the right treatment and can be life-saving.

"Currently, we are doing clinical validation in collaboration with the IITM Institute hospital", he said and added that "after rigorous clinical validation, we are planning to commercialise this through our startup, Kaappon Analytics India Private Limited." Dr. Richa Karmakar said the device monitors how the electrical signal changes over time to determine whether bacteria are continuing to grow in the presence of an antibiotic. If the bacteria are resistant, they multiply despite the drug, and this activity causes a distinct change in the electrical signal. In contrast, if the bacteria are killed by the antibiotic, their growth is inhibited and the signal remains relatively unchanged. A metric called 'Normalized Impedance Signal' (NIS) developed by the researchers allows clear differentiation between resistant and non-resistant bacterial strains in a matter of hours, Dr Richa said. The researchers tested the device on two types of bacteria - gram-negative E. coli and grampositive B. subtilis. They used two antibiotics with different modes of action -- ampicillin, which kills bacteria and tetracycline, which prevents them from growing -- to confirm the device's ability to detect both kinds of

#### Overthinking Leaves India Mentally Drained

At first, there was thought. Thinking, evolutionary science says, evolved even before Homo sapiens did and, over time, it became the basis of human existence: cogito, ergo sum, as René Descartes put it - to think is to exist. Philosophers from Socrates to Martha Nussbaum have underlined the centrality of thinking, especially critical thinking, to a good life and a better world. But Socrates had also warned that too much of any-thing is a trap for unhappiness, and Indians seem to have been ensnared. A recent study by YouGov and Center fresh shows that 81% of Indians say that they spend more than three hours a day overthinking. Where reflective thinking is purposeful and clarifying - it involves weighing options, questioning assumptions, and arriving at insight or a decision - overthinking is repetitive and unproductive, circling the same doubts or fears without resolution. Thinking sharpens understanding; overthinking blunts it; the former moves thought forward; the latter stunts it. It might be worth asking what is it that has Indians brooding thus. The answers are as illuminating as they are concerning - 61% of Indians, especially members of Gen Z and women, spend at least five hours overthinking whether their Instagram story is worth sharing, while some 42% people spend all their time thinking about whether people bosses, relatives, girlfriends - are offended with them. A whopping 63% also take longer to mull over what to order from a menu than which political leader to vote for. Their anxieties - the cause of overthinking - may seem trivial but they are instructive. This being the age of selfobsession, personal posts and images on social media are only to be expected. But this is also the Age of Censorship. Thus posting a political cartoon can lead to first information reports and even arrests; the cynic would also quip that keeping bosses happy matters in an economy blighted by soaring unemployment rates; moreover, friends and relatives have been driven to murder on account of heated WhatsApp chats. If this is how fraught and perilous everyday life is for Indians, spending hours exercising the mind on such issues can hardly be deemed as unproductive. There is perhaps another way of examining this trend of overthinking. Studies have found that channelling one's anxieties towards the seemingly mundane helps people live in denial about grave crises. Overthinking, then, becomes both a defence mechanism and a form of denial. Worryingly, the survey also shows that the final nail in the coffin of critical thought in India might be attributed to digital technology. People spend their time overthinking while outsourcing serious, contemplative queries to ChatGPT and Google, with 87% Indians turning to Artificial Intelligence for answers to the mundane and the profound. Be it whether to get married or what Article 370 entailed or what are the reasons to stay alive, the country seems to be entirely dependent on Google for questions that need ruminating, if Google's annual publications of most popular searches are anything to go by. When citizens outsource judgement on fundamental questions while hoarding their mental energy for menus and Instagram posts, collective intellectual life as well as the inner lives of individuals become shallow and vulnerable to manipulation. The burgeoning culture of overthinking is then a signpost of the death of cerebral engagement.

### Decoding Trump's Tariff Tantrums

Last month, I wrote here about India's splendid diplomatic isolation, but my prediction became fact sooner than I expected, with President Trump's withering attacks on India. Biden drove Russia into China's arms over Ukraine; Trump seems intent on driving India into China's arms; and Ukraine isn't even Asia's problem, but a likely Chinese invasion of Taiwan would be.

There are at least four different ways in which one rationalise Trump position: 1. A negotiating opening gambit to soften up India 2. Frustration from the lack leverage against Presidents Putin and Xi 3. Part of a regime-change operation planned by the Deep State and 4. A desire to force manufacturing and investment to move back to the US. I hope it is a combination of 1 and 2, and that better sense will prevail before a mutually-beneficial Indo-US relationship is damaged beyond repair. However, there is a nontrivial chance that, with prompting by Britain's Whitehall (which created Pakistan in the first place to keep India in check), the US Deep State has decided to target India. I wrote a couple of years ago that the Deep State, intimidated by China's rise, might accept a condominium with it, giving each a sphere of influence. China gets Asia and the Indian Ocean; the US gets the Americas, Europe and the Atlantic; and they share the Pacific. India, Japan, Australia (i.e. the Quad), and ASEAN become Chinese vassals. So like the

Vatican-brokered Treaty of larger scheme. Scenario 4

Tordesillas in 1494 that divided the world between Spain and Portugal! There is also the anti-Thucydides Trap, wherein the incumbent power (the US), instead of resisting the rise of the challenger (China), helped it grow, deluding themselves that China would be benign. However, both are now employing all possible means against new challenger India's rise, including trying to balkanise the latter. That is Scenario 3, the Deep State playbook of 'colour revolutions' against governments they don't like for whatever reason. There is context in the BJP's 2024 accusation that the US Deep State is trying to "destabilise" India and that efforts by the Opposition are aiding this

makes a strange sort of sense. Trump realises the US erred badly in relinquishing manufacturing to China, and wants to pull it back; also he has no interest in India becoming a new manufacturing power. Similarly, the 'deals' forcing Japan, the EU, Korea et al to invest billions of dollars in the US (and Ukraine, which receives extensive international aid, has promised to spend \$100 billion in the US) are extortionary: a sort of neoimperialism. The effort to browbeat India into buying more US weapons is part of this: Trump aide Peter Navarro grumbled that India buys 36% of its armaments from Russia. He omitted to mention that this is down from 70+% a

decade ago. Sadly, US armaments and aerospace products (e.g. the F-35 and Boeing 787) are now seen as not so reliable. The moral posturing about India's purchases Russian oil leading to Ukrainians' deaths bizarre. It's just business, Trump aide Scott Bessent, why repeat INDI's Ambani-Adani mantra? Remember your own 'robber barons' and "What's good for General Motors is good for America"? There are many examples of profit above morals. One is the 1973 oil price crisis, when OPEC suddenly quadrupled crude oil prices, forcing a massive transfer of wealth from developing countries, quite likely causing starvation deaths. The US could have persuaded (or bullied) OPEC into preventing the price rise. But it didn't. Why? Because those petrodollars were recycled into buying American weapons. The Military Industrial Complex prospered. No morality there. There is an earlier parallel. Tipu Sultan invaded Kerala in the 1780s with a reign of terror. The British did nothing, despite a treaty with Travancore.

### US Sending Sergio Gor To India Smells Of Reset, With A Whiff Of Re-hyphenation

Gorokhovsky is a surname which would hang from one's neck like a large rock in America's topmost echelons of power. Especially if one is born in the former Soviet Union. Gor, however, renders the rock somewhat invisible and much less weighty. Which is why Sergio Gor, who was born in Tashkent of Soviet-ruled Uzbekistan in 1986 and grew up as a child in Malta, breathes in the rarefied air of US President Donald Trump's innermost circle. And which is why his appointment as the next ambassador to India - with the extra charge as special envoy for South and Central Asian Affairs - is so consequential. Trump himself and a host of his most colleagues, Secretary of State Marco Rubio to Secretary of Health Robert F. Kennedy Jr., rushed to congratulate Gor. What was interesting to note was the tone of the messages, coming after Trump's tariff tantrums, a fiery hiatus in India-US ties. It suddenly seemed no water had flown under the bridge. "I am excited about the President's decision to nominate @SergioGor to be our next Ambassador to India. He will be an excellent representative of America in one of



the most important relationships our nation has in the world," Rubio posted on X. That "one of the most important relationships our nation has in the world" Rubio mentions has been lately hauled through childish claims of mediation in Operation Sindoor, serenading Pakistan, calling India's a "dead economy," and ratcheting up tariffs to a point where it ceases to be punitive and becomes laughable. Even Gor's Soviet backdrop - his father Yuri Gorokhovsky was reportedly an aviation engineer who worked on aircraft designs for the Soviet military, notably the IL-76 - and whispers that he is close to the Kremlin even today, could work as a bridge with

India. Gor has Trump's ear. He is powerful enough to drive a wedge between Trump and Elon Musk (who described him as a "snake") and to go unvetted for six months despite himself heading the White House Presidential Personnel Office. So, Gor's appointment as ambassador does smell of Washington's attempt to reset relations with New Delhi. Former Trump adviser and conservative ideologue Steve Bannon, in an interview, applauded Gor's appointment, hoping his closeness to Trump will serve both countries. believe Sergio is the only person outside of [chief of staff] Susie [Wiles] and a handful of others who actually has walk-in privileges to the president at any time, day or night," Bannon said. "If I'm [Prime Minister Narendra] Modi in India - and I say this as somebody that's so pro that relationship - I couldn't think of a better pick. Does he have a deep knowledge base of Indian policy issues? He doesn't, but this guy's a quick study. He not just has access to the president ... but he has a unique trust. The President trusts this guy, that he's dealing with him straight." In that sense, Gor is the shortest possible route to Trump's regrettably short attention span.

### **Precious Threads**

A kani shawl can take over a year to make. Its intricate design is not mapped on paper but guided by taalim, an oral tradition passed down through generations in the Kashmir Valley. Dozens of slender, eyeless bobbins called kanis build the motif, thread by thread. The result is an object steeped in time, skill, and cultural meaning. In the Mughal court, such shawls signified rank and were bestowed as part of a khilat, a robe of honour to favoured courtiers. They adorned Empress Josephine, the wife of Napoleon Bonaparte, who helped spread the fashion among European elites. An 1805 painting by François Pascal Gérard, now in the Belvedere Palace in Vienna, shows a noblewoman in a white muslin gown draped with an orange kani shawl capturing how the artefact became a marker of European sophistication. In time, the design was imitated in Paisley, Scotland, where factories produced machine-woven versions on Jacquard looms, and the teardrop motif became known as 'Paisley'. And yet, despite their artistry and heritage, most kani weavers are struggling to eke out a living today. The paradox is sharp: exquisite making, invisible makers. This story plays out across India - among the block printers of Rajasthan, the jamdani weavers of Bengal, the zardozi embroiderers of Lucknow - where some of the world's most refined textile traditions survive on the economic margins. India is home to the largest population of craft artisans in the world; yet their labour is rarely transformed into storied brands that allow them to share in the cultural and the commercial value they create. Our nation's aesthetic intelligence remains disconnected from its economic structures. Craft traditions endure in technique, but they falter in innovation, visibility, and reward. Mahatma Gandhi placed artisans at the heart of India's moral economy, elevating khadi as the fabric of freedom. Yet, as with farmers, symbolic celebration rarely translated into commercial empower-

### Why Joint Parliamentary Committees Are An Exercise In Futility

The All India Trinamool Congress (AITC) and the Samajwadi Party (SP), the second largest Opposition parties in Parliament, decided not to nominate any of its members to the Joint Parliamentary Committee (JPC) being proposed to examine the Constitution (One Hundred and Thirtieth Amendment) Bill, calling the committee a 'farce'. Here are three reasons why JPCs are an exercise in futility:

One, the chairperson of the JPC is decided by the Speaker of Lok Sabha and the chairperson of Rajya Sabha, in consultation with each other as may be necessary, and its members are subsequently nominated by each party according to the party's strength. This makes these committees skewed towards the ruling majority because of their numbers in the Houses. The chairperson of the JPC would have been a BJP MP. Second, in almost every JPC there is no consensus on the final report. Whenever important amendments are proposed by an opposition MP, the amendments are defeated in the committee by a show of hands. The ruling party uses its brute majority to do this. This has become a trend. Instead of coming to these meet-



ings with an open mind, Members of Parliament representing the treasury benches come and rubber stamp the views of the ruling party. Those in the opposition, holding an alternate view, are outvoted. The only recourse left is to table a dissenting note - for the record.

Third, let me pluck out a few examples - from 1987, 1992 and 2001. In the Bofors case of 1987, it was alleged that a Congress member had taken bribes while settling the deal of purchasing the Bofors 'shoot and scoot' guns. The JPC report was boycotted by the opposition high-

lighting that the committee was packed with members of the ruling party.

When the Harshad Mehta scam (1992) surfaced, a JPC was set up to inquire into allegations that Mehta diverted funds to Maruti Udyog Limited and provoked a major fall in the Sensex. However, the recommendations were neither accepted nor implemented. During the Share Market Scam (2001), the Ahmedabad-based Madhavpura Mercantile Cooperative Bank had big exposure to the stock market, courtesy former stockbroker Ketan Parekh. The JPC suggested stock market regulations, which were subsequently diluted. There have been other cases where a JPC has been formed for investigations. For example, the Joint Committee

on pesticide residues in and safety standards for soft drinks, fruit juice and other beverages (2003) and the Joint Committee to examine matters relating to allocation and pricing of telecom licences and spectrum (2011). While only some recommendations were implemented from the former, the latter was mired in controversy.

### SC stays trial against Ashoka University professor booked for Op Sindoor posts

Supreme Court on Monday stayed trial court proceedings against Ashoka University political science professor Ali Khan Mahmudabad, who was booked by Haryana Police over his social media posts on Operation Sindoor. A Bench of Justices Surya Kant and Joymalya Bagchi passed an interim order restraining the jurisdictional magistrate from taking cognisance of the Haryana Police's charge sheet involving an offence under Section 152 of the Bharatiya Nyaya Sanhita, which relates to an offence against the sovereignty of the nation. The Justice Kant-led Bench also noted that a closure report had been filed in one of the FIRs against Mahmudabad and accordingly quashed those proceedings. In an earlier hearing, the top court had pulled up the Haryana Special Investigation Team (SIT) for unnecessarily widening the scope of its probe, after being informed



that the SIT had seized Mahmudabad's electronic devices and sought his decade-long travel history. It had also ordered that Mahmudabad should not be summoned again, noting that he had already joined the investigation and submitted his electronic devices. The Justice Kant-led Bench had directed the high-level probe panel to conclude its investigation within four weeks, reiterating that the SIT should restrict its probe to the language and content of the

social media posts on the Pahalgam terror attack and the country's cross-border military response. In an order passed on May 21, the apex court ordered the Haryana DGP to constitute an SIT comprising three directly recruited IPS officers, who do not belong to Haryana or Delhi, to holistically understand the complexity of the phraseology employed and for proper appreciation of some of the expressions used in the two online posts. "The SIT shall be headed by an Officer at least in the rank of Inspector General of Police; the remaining two members will be Officers in the rank of Superintendent of Police and above. One of the members of the SIT will be a woman IPS Officer. The Director General of Police is directed to constitute the SIT within 24 hours. The petitioner shall join and fully cooperate with the investigation," it had ordered. To facilitate the investigation, the Supreme

Court had directed that Mahmudabad be released on interim bail, subject to his furnishing bail bonds to the satisfaction of the Chief Judicial Magistrate, Sonipat. Mahmudabad, 42, arrested on a complaint filed by Yogesh Jatheri, the General Secretary of the BJP Yuva Morcha in Haryana. An FIR was lodged against Mahmudabad under sections of the Bharatiya Nyaya Sanhita (BNS) pertaining to inciting armed rebellion or subversive activities and insulting religious beliefs. Also, sedition-like charges were filed against him. Haryana State Commission for Women Chairperson Renu Bhatia took suo motu cognisance of Mahmudabad's remarks, which were alleged to be disparaging toward women in the Indian Armed Forces and promoting communal disharmony. The women's rights body had summoned the professor, but he failed to appear.

### Madras HC seeks proof of license cancellation in kidney racket case

**Chennai:** The Madras High Court on Monday directed the Tamil Nadu Health and Family Welfare Department to submit a copy of the formal order cancelling the renal transplantation licence Dhanalakshmi Srinivasan Medical College and Hospital, Perambalur, after allegations surfaced about its involvement in an illegal kidney sale racket. Justice N. Anand Venkatesh issued the directive after the medical college challenged only a press release issued by the state government on August 10, which announced the cancellation of its licence. The judge noted that the communique merely stated the government's decision based on an inquiry committee's report, and questioned whether a written cancellation order had been passed thereafter. Responding to the query, Additional Advocate General J. Ravindran informed the court that a cancellation order was indeed passed following the press release and assured that it would be produced before the court by Thursday (August 28). The inquiry committee, constituted by the state Health Department, had recommended the cancellation of licences for both Dhanalakshmi Srinivasan Medical College and Cethar Hospital in Tiruchi. It also sought criminal action



against brokers who facilitated the racket after uncovering fake documents submitted for kidney transplantation. The panel further highlighted lapses on the part of district- and state-level organ transplantation authorisation committees, whose officials had approved forged papers for submission to the Directorate of Medical Education and Research (DME&R). It stressed the need to reconstitute these committees and proposed the framing of a Standard Operating Procedure (SOP) for live donor transplants.

### Haryana Assembly Session Day 2: Cong alleges vote rigging, protests outside house

Chandigarh, Aug 25 (Representative)

The second day of the Haryana Assembly's monsoon session kicked off with the question hour, transitioning to the zero hour, as political tensions flared. Congress legislators held a demonstration outside the Assembly, accusing the Election Commission of India (ECI) of orchestrating vote fraud to derail their electoral prospects in the state polls. Former Chief Minister Bhupinder Singh Hooda spearheaded the protest, leading MLAs to the Assembly's Gate No. 1, where they chanted "End Vote Theft, Surrender Power." Police halted their attempt to enter the premises.

Hooda asserted that the ECI's alleged vote tampering cost Congress its chance to govern. Earlier, a Congress legislative meeting was convened by state president Chaudhary Udaybhan, while Chief Minister Nayab Singh Saini led a parallel BJP meeting. The session is braced for further disruptions over the death of Bhiwani teacher Manisha, which caused chaos on August 22, the session's opening day, with Congress raising law and order issues, leading to several adjournments. Manisha's father later appealed via video to keep the matter apolitical. Parliamentary Affairs Minister Mahipal Dhanda rebuked Congress for breaching legislative norms, defending the ECI's voter list cleanup as a legal step to eliminate "unauthorized voters." Cabinet Minister Rao Narbir Singh promised swift resolution, with Chief Minister Saini highlighting ongoing efforts, including clearing 16,000 tons of waste in Delhi and plans for additional Yamuna sewage treatment facilities. Congress's 37 MLAs attended the session without a Leader of the Opposition for the fourth time, with no decision from the party leadership. BJP's Anil Vij mocked their indecision. The session remains charged with intense debates and political confrontations.

### Iran nuclear talks with European powers to be held in Geneva

Tehran: Iran will resume talks on its nuclear program in Geneva on Tuesday with France, the United Kingdom Germany, three countries that are part of a 2015 agreement with Tehran to regulate its nuclear activities and which have threatened to reimpose sanctions, the state broadcaster reported.

"This new round of negotiations," following a previous session held in July in Istanbul, Turkey, will take place "at the level of deputy foreign ministers in Geneva, the broadcaster said. Iran will be represented by Majid Takht-Ravanchi, according to Tasnim news agency. The location of the talks had not

previously been specified.
France, the United Kingdom and Germany, along with China, Russia and the United States, reached a deal with Iran in 2015 significant restrictions on its nuclear



program in exchange for a gradual lifting of UN sanctions. The agreement became void Washington unilaterally withdrew from the treaty in under President Donald Trump. In response, Tehran has since rolled back some of its commitments, including on uranium enrichment. France, the Kingdom and Germany have threatened to

reinstate UN sanctions against Iran if no negotiated solution is found by the end of August. Iran disputes the Europeans' legitimacy to invoke this clause of the 2015 agreement. When the United States withdrew, Paris, London and Berlin reaffirmed their commitment agreement, saying they wanted to continue trade with Iran. The three capitals

According to the **International Atomic Energy** Agency (IAEA), Iran is the only non-nuclear-weapon state enriching uranium to a high level (60 percent), well above the 3.67 percent limit set by the 2015 agreement.

Western countries, led by the United States, and Israel, Iran's sworn enemy, have long suspected Iran of seeking to develop nuclear weapons. ### New Zealand Post suspends deliveries to US over tariffs

Wellington: New Zealand's postal service said it had suspended most deliveries to the United States, citing uncertainty over the impact of President Donald Trump's looming tariffs. NZ Post said it had temporarily suspended services as of August 21 before the US 15 percent tariff takes effect on August 29. Only limited letters and important documents - such as passports or legal letters would be delivered to the United States, said a statement on the carrier's website. The move follows similar steps taken by postal services and mail carriers in India, Germany, France, Belgium, Austria and Denmark after the Trump administration said that as of August 29 it would abolish a tax exemption on small packages entering the United States. The United States started imposing tariffs



on foreign nations in April, but most are only coming into force this month after months of negotiations and delays. NZ Post said it was "working quickly" to make changes to its service and that it hoped to resume deliveries as "soon as possible." Prime Minister Christopher Luxon told Radio New Zealand on Monday there

was confusion over the impact of the tariffs. "As these organizations worked out, they can't guarantee what the tariff rate will be or cost, or how that will all work in practical terms," Luxon said. "I'm sure NZ Post, along with counterparts in other countries, will work with the US to get clarity.'

#### Japan PM Ishiba bounces back in polls after election debacle



Tokyo: Japanese Prime Minister Shigeru Ishiba's poll ratings have rebounded a month after disastrous election results left his premiership hanging by a thread, a clutch of surveys showed Monday. Ishiba took the helm of the longdominant Liberal Democratic Party (LDP) last year and has since lost his majority in both houses of parliament, most recently in upper chamber elections in July. But the self-confessed defense policy "geek" and maker of model ships has defied calls to resign from within the party, which has governed Japan almost non-stop since the 1950s. According to one poll by the Yomiuri Shimbun daily published Monday, the approval rating for Ishiba's cabinet was 39 percent, a record 17 points higher than after the July 20 vote. More respondents (50 percent) now think Ishiba should remain than resign (42 percent), the questionnaire showed, a reversal from July, when 54 percent said he should go and 35 percent stay. Another poll conducted by Kyodo News put support at 35.4 percent, up 12.5 points from last month after the upper house election, while the disapproval rating stood at 49.8 percent. A third survey by the Mainichi Shimbun put backing for the prime minister at 33 percent, a rise of four points, the first time it has been over 30 percent since February. The Yomiuri put the recovery down to the recent trade deal with the United States and efforts by Ishiba's government to curb the recent meteoric rise in rice prices. US President Donald Trump announced a "massive" trade deal with Japan only two days after the upper house election, cutting threatened US tariffs to 15 percent from 25 percent, while lowering those on cars to the same level. Voter backing of Ishiba's handling of US trade negotiations rose to 42 percent from 29 percent in June. An overwhelming 86 percent said they approved of the government's decision to shift policy toward increasing rice production. Rice prices have skyrocketed due to supply problems linked to a very hot summer in 2023 and panicbuying after a "megaquake" warning last year, among other factors. Ishiba has appointed a new farm minister - the popular Shinjiro Koizumi, 44, a potential challenger - and his government has released emergency stocks in an effort to bring down prices. According to media reports, the LDP plans to conduct a review of last month's election, to be followed by a decision on whether to hold a party leadership election. Ishiba, 68, said after a recent LDP plenary meeting, where some lawmakers reportedly urged him to step down, that he would "consider appropriately" the results of this investigation. "I'd like to deepen my thinking as various things are going on simultaneously," he said. "Even within the LDP, passion for holding a party leadership election... has been diminishing," said Mikitaka Masuyama, politics professor at the National Graduate Institute for Policy Studies. "They may face criticism that instead of doing their jobs and addressing everyday life struggles like inflation, the LDP is holding a party leadership election, Masuyama said.

# SpaceX postpones Starship test flight over ground system issue

New Delhi: Elon Musk's SpaceX on Sunday called off the launch of Starship's tenth mission from Texas over an issue at its launch site, delaying an attempt to achieve several long-sought milestones development missed due to past tests ending in early failures. The 70.7-meter-tall Super Heavy booster and its 52-meter-tall Starship upper half sat stacked on a launch mount at SpaceX's Starbase rocket facilities as it was being filled with propellant ahead of a liftoff time of 7:35 p.m. ET (2335 GMT). But roughly 30 minutes from liftoff, SpaceX said on X it was standing down to allow time to

Zambada pleaded not guilty last year to a range of drug trafficking and related charges, including gun and money laundering offenses. Lawyers for Zambada didn't immediately respond to an email seeking comment Friday. Prosecutors say the Sinaloa cartel evolved from a regional player into the largest drug trafficking organization in the world under the leadership of Zambada and co-founder Joaquín "El Chapo"

#### Vietnam evacuates tens of thousands ahead of Typhoon Kajiki



Vinh: Tens of thousands of residents were being evacuated from coastal Vietnam on Monday, as Typhoon Kajiki barrelled toward landfall expected to lash the country's central belt with gales of around 160 kmh.

The typhoon - the fifth to affect Vietnam this year - is currently at sea, roiling the Gulf of Tonkin with waves of up to 9.5 meters (31 feet). #### BCCI looking for new title sponsor after ending association with Dream11, says Saikia



New Delhi: Devajit Saikia, the Board of Control for Cricket in India (BCCI) secretary, confirmed on Monday that the board's association with fantasy sports company Dream11 has ended, and deliberations over finding a new lead sponsor is on. Dream11 had signed a three-year deal worth Rs 358 crore in July 2023 to replace edtech company Byju's as the lead sponsor of the Indian cricket team. It also had a significant presence in the Indian Premier League (IPL) through multiple franchise tie-ups and being lead sponsor in 2020 after Vivo's pullout. But after the Promotion and Regulation of Online Gaming Bill 2025 was passed in both Parliament houses last week, as well as got the assent of President Droupadi Murmu, Dream11 said it suspended all moneybased online gaming contests on its platform. "Under the new legislation, it will be difficult for BCCI to continue with Dream11 or any other identical gaming companies. So, there is a roadblock and I don't think BCCI will be able to continue with Dream11 now. We are deliberating on an alternative course of action at this stage, said Saikia to IANS. It is understood that Dream11 will not incur any penalties, with the contract having a clause safeguarding the sponsor in case its core business is banned by the government and that they won't be liable to pay anything to the BCCI. Asked if the BCCI will float a new tender soon for the Indian team's sponsorship, especially with just a fortnight left for the Men's T20 Asia Cup to happen in the UAE from September 9-28, Saikia said, "We have not finalised anything, but we'll have to have an alternative now. Because with Dream11 going away, there will be some vacancy in the sponsorship slot. So, we have to have an alternative, not a replacement. What we'll have to do and how we are going to do it, on that, we are deliberating now." "Dream 11 will not be with us anymore, under the new law. So we still have some time, at least 20 days or in fact, just about 15 days. So, if something develops within these 15-20 days, there will be a replacement. Otherwise, we'll see how it will progress over a period of time." Apart from Dream11, another fantasy sports company My11Circle's deal with the BCCI is also under a big cloud of doubt.

Travel, essentially, is a way to break free from the mundane hustle (or burnout, as they say). It is not just limited to a holiday, but much more. Sometimes, it's to process loss, a bad breakup, maybe, but not exactly to escape from it. When you travel as a way to cope with loss, it's called grief travel. Travel has a way of shaking you out of emotional stillness. Remember when Rani from Queen decided to go alone on her honeymoon? It was her way of dealing with the grief after being rejected by the man she loved, almost on the day of the wedding. She didn't just move past her loss but embraced a new version of herself after that trip. Or Eat Pray Love, for that matter, where Julia Roberts' Elizabeth Gilbert travels to Italy, India, and Bali after a divorce to heal and rediscover herself. Experts believe that travel serves as a powerful therapeutic tool when approached with the right intent. Staying put in the same space replays old memories, like being stuck in a loop. That's where travel comes to the rescue. "Travel introduces change - new faces, unfamiliar streets, different smells, and in that shift, something inside starts to soften. You may not forget your grief, but you begin to carry it differently," Shivani Misri Sadhoo, a marriage counsellor and psychologist, tells India Today. The air and aura of a new town, city, or country become a safe space for your emotions because they come without judgment. The strangeness becomes key to leaving behind the familiar and slowly rediscovering who you are without what you lost. Enough of the philosophy bit, let's add a little bit of science. By creating psychological distance from familiar environments and painful memories, travel allows the mind to breathe. "Immersing oneself in nature can trigger the release of mood-enhancing neurotransmitters like serotonin, promoting emotional balance and reducing stress," Dr. Anil Kumar Yadav, psychiatrist, Apollo Hospitals Bilaspur, tells us. Movement and novelty activate the brain's reward systems, lifting mood and reducing emotional overwhelm, Dr. Yadav adds. A change in the environment can disrupt negative thought loops and bring fresh insight. But it's not as easy as it sounds. When you think you are being the happygo-lucky traveller, be mindful of not escaping your thoughts. The line may blur. What you think is coping might in fact be escaping. So, how do you differentiate? Travel should not be used to suppress or replace difficult emotions. Instead, it should facilitate new experiences that support emotional reprocessing. Mindful travel can be like clicking the 'refresh' button just irl this time. According to Dr. Yadav, one should remember a key difference between the two: "Healthy coping allows for reflection, growth, and clarity. Escapism numbs emotions without resolution, often delaying healing." Experts further emphasise that not every kind of travel may help in the process of healing. Choose travel that promotes stillness, not distraction. Overscheduling, excessive planning, or constant stimulation can become mechanisms of emotional escape rather than pathways to healing. Beach or mountains? Pubs or cycle tours? Solo vs group travel? Every choice has a role to play when it comes to grief travel. Experts believe that the destination should be soul-touching and not distracting. While nature, in particular, has a calming effect in lowering stress and promoting mental clarity, other historically or culturally vibrant places can be grounding as well. "Cultural travel, like visiting ancient places or sacred sites, also shifts your perspective. And sometimes, going somewhere connected to your roots or your dreams can realign your identity post-loss," says Sadhoo. Slow travel is ideal for grief travel because it is intentional and allows you to be personal. Here are a few expert-backed tips to do grief travel right: A grief travel checklist can serve as a gentle guide for those seeking healing through journeys. Simple practices such as talking to locals, sitting in silence, or writing postcards to yourself can create moments of connection and reflection. Supporting the mind and body with self-care tools like journaling, online therapy, or meditation may also help provide an anchor during emotional turbulence. Establishing routines while traveling brings stability, while creative outlets such as music or writing allow for emotional release. As grief travel expert Sadhoo notes, this practice can be meaningful, but it should be approached with gentleness.
